Simple rules for attractive neighborhoods

To keep our neighborhoods looking their best, it is important to follow a few simple rules. First, be sure to remember the days your weekly garbage/recycling service and monthly street sweeping are done. Then...

• Don't put your garbage and recycling containers or yard waste on the street more than 24-hours before scheduled pick-up. (This is required by city ordinance.)

• Be sure to bring your garbage and recycling containers in by the end of pick-up day. Remember: City ordinance also requires that these items be stored <u>behind</u> your front gate, out of sight from the street.

• Sweep-up any yard waste debris that is left behind and put it in your yard waste container or garbage. Yard waste left on the street is not only unsightly, it also leads to storm sewer blockage, consequent street flooding during the rainy season, and it seriously contaminates our creeks and the Bay.

• Be sure to move your vehicle(s) off the street on street sweeping day. Doing this allows more complete removal of debris that also eventually finds its way into our streams and the Bay, threatening wildlife and water quality.

Be a good neighbor. Following these simple steps can go a long way toward keeping our VEP area one of the most attractive in Santa Clara County.

Neighborhood Developments

-Greg West, VEP President Continuation School News: Construction of the continuation school on the John Muir campus is nearly complete for a spring opening. According to a recent newsletter from Community Action in Robertsville (CAIR), the color scheme of the school violates the visual impact sections of the Mitigated Negative Declaration (MND).

CAIR reports that the color scheme is somewhere between "mooseturd" and "jailhouse jump-suite orange." The District reported that they picked a color scheme to distinguish the continuation school from John Muir and to give it its own identity.

CAIR also claims that during construction of the school, the District has violated the noise mitigations from the MND.

CAIR reports that settlement negotiations with the District have failed and it is pressing ahead with its lawsuit. The suit should go to trial sometime in June.

Our area school board member, Veronica Lewis, did report, however, that the enrollment at the continuation school has been reduced from 350 students to 200 students.

<u>Oakridge Mall Expansion</u>: Larry Greene and Kim Brewer, representing Westfield Corporation, the owners of Oakridge Mall, attended our March meeting. They presented some details on expansion plans and traffic mitigations, and answered our questions.

An April 4th letter from Larry to VEP recapped the issues and concerns that he and Kim took away from our meeting. In that letter, Larry stated, "Fortunately, Westfield believes in the strength of the community and intends to make the private investment necessary to ensure Oakridge continues to serve the role as the designated regional center, thereby maximizing the public investment in light rail, public transport, infrastructure and regional freeways and roads."

<u>Chynoweth Ponds</u>: The plans to build a bridge to connect Chynoweth across the Guadalupe River have apparently been shelved for the time being. VEP will watch this situation diligently and will act on any changes.

GARAGE SALE SIGN VIOLATIONS

It's that time of year when our neighborhoods sprout colorful signs. Most residents are unaware that using public property for private notices of any kind is illegal.

We all need to be aware of the law: *Title 23 of the City Code*. Paraphrasing, it says that private signs cannot be posted on public right-of-way, with few exceptions.

Public right-of-way is defined by the city as the sidewalks on each side of a street and everything in between them. That includes the sidewalks themselves, the park strip between them and the curb, the center street median and any poles, light standards, traffic signs, trees, foliage, fences or anything else on public property or in intersections.

We all want to be kind and thoughtful neighbors. So, we need to be mindful that, to many neighbors, placing garage sale or other notices around our streets is as unsightly as any other kind of graffiti. Many homeowners object to the mess and complain to the city Code Enforcement Department (277-4528).

There is a \$250 per sign fine for violating the Sign Graffiti law. City property is not to be used for private, commercial, or any other kind of notices.

Sewer tax increase sought-again!

One year ago VEP members voted unanimous opposition to an increase in the storm sewer tax charged by San Jose. Our decision was made after a full presentation by Environmental Services Department (ESD) staff and careful consideration of the facts of their arguments. Mayor Ron Gonzales stood with us and convinced a majority of the city council to join him in voting it down.

It's back again! ESD is asking for more money.

The storm sewer service tax was first imposed by the city in 1991. Rates were increased in 1995. Last year, ESD staff asked for another major increase (23.3%) in its annual appropriation, from \$13.3-million to \$16.4-million. In light of a 2% to 3% inflation rate in recent years, we were shocked at the magnitude of their request.

Our questions went unanswered regarding the possibility of departmental cost reduction through efficiency measures, etc. We suggested more frequent street sweeping or the use of containers for yard waste, instead of dumping it on the street, to save the high ongoing costs of clearing clogged storm sewers. They want more money.

City staff indicated that much of the rapid rise in costs is attributable to increasingly stringent federal and state EPA mandates; we urged the council to go after money from those governments instead of squeezing more from us. The feds and the state have plenty of money and we think they should, at long last, be held financially accountable for the requirements they unfairly pass down to our cities.

As of this writing, the details of proposed rate increases are not known. We urge VEP members to keep their eyes and ears open for any news of a sewer tax increase. We'll apprise you of any late-breaking news at our April meeting (which may be too late, as this topic is scheduled for hearing at the April 18th city council meeting).

Don't hesitate to telephone Mayor Gonzales (277-4237) and Councilwoman Dando (277-5251) to let them know how you feel about this—they are supposed to represent *you*.

As individuals and as an organization, we are supportive of environmental protection. We have not, however, heard a compelling case for paying more money for storm sewer services.

Survive a heart attack-when you're alone

Many people are alone when they suffer a heart attack. Hopefully nobody will need this information, but it may save your life in an emergency.

Let's say it's 6:15 p.m. and you're driving home (alone of course) after an unusually hard day on the job. You're really tired, upset and frustrated. Suddenly you start experiencing severe pain in your chest that starts to radiate out into your arm and up into your jaw. You are only about five miles from the hospital nearest your home; unfortunately, you don't know if you'll be able to make it that far.

What can you do? You've been trained in CPR but the guy that taught the course neglected to tell you how to perform it on yourself. Without help, the person whose heart stops beating properly and who begins to feel faint has only about 10 seconds left before losing consciousness.

However, these victims can help themselves by coughing repeatedly and very vigorously. A deep breath should be taken before each cough, and the cough must be deep and prolonged, as when producing sputum from deep inside the chest. A breath and a cough must be repeated about every two seconds without let up until help arrives, or until the heart is felt to be beating normally again.

Deep breathing gets oxygen into the lungs and coughing movements squeeze the heart and keep the blood circulating. Squeezing pressure on the heart also helps it regain normal rhythm. In this way, heart attack victims can get to a phone and, between breaths, call for help.

Tell as many other people as possible about this. It could save their lives!

Computer Corner

-Bob Aquino In springtime the young (and not so young) computer nerd's fancy lightly turns to thoughts of financial software. As I am writing this article, half of my mind is focused on my IRS returns. Whether you prepare your own taxes (a la Turbo Tax), or have them done by a professional, there is nothing so helpful as maintaining your household accounts on Quicken, MS Money, or some other software package.

I'm a very big fan of this type of software. I've been using it for fifteen years or so, and I recommend it to anyone who has a computer and wants to understand his personal finances.

In the bad old days, when I went to prepare my taxes, I would have a large envelope full of receipts, cancelled checks, and the like. Now, I can run a report of my deductible expenses and I'm done. The only catch is that you need to be very scrupulous and disciplined in entering the data into the program during the year.

Personally, I find that when I receive my monthly statement from the bank is a good time for me to update my records. By the way, you still need to keep those records since, in the event of an audit; Uncle will need to review them.

Personal Finance (PF) software represents an unusual case in the software world. Microsoft attempted to buy Intuit, the publisher of Quicken, because MS Money was not effectively competing with it. The Department of Justice put the kibosh on the deal because of competitive considerations. MS had committed to *give* MS Money to Word-Perfect in order to provide a competitor to the proposed MS Quicken. But DOJ wouldn't buy the deal.

So, Intuit remained independent and is still dominating the market. (We will all pause here to weep bitter salt tears for Microsoft.)

In any case, in addition to the quality of its software, one of the reasons that Quicken remains in this position is that there is a great deal of inertia in the market. Many people who buy PF software are upgrading an existing package. If you have been on one package for years, there are a lot of reasons not to change vendors. Your records might not update with a new vendor's package, you'd have to get used to a new interface, etc.

You'll notice that all PF software has an annual update. About three years after buying a package, a user finds that the latest version has some features that he believes he must have. You will also notice that successive versions are completely incremental in character; they're always evolutionary, never revolutionary.

Gumby-Mumby

-John Marks, VEP's Green Gardener Remember those twistable Gumby toys that you or your children used to play with? Well, now they're quite the rage as attractive twist ties to stake or tie plant stems together. They're more colorful than the little green twisties you normally use to stake plants, and represent different animals.

Along with Twisty Flamingo and Twisty Frog, there's Twisty Duck, which your children or grandchildren will delight in seeing. They're made of soft vinyl similar to the famous Gumby toy, and can be reused many times. They're available in the garden department at Wal-Mart stores for \$1.49 for a set of three. Probably Orchard Supply and Woolworth's Gardening Center will have them too.

Crabgrass Controls: How to beat this annual weed

The best way to control crabgrass—that familiar annual weed with blue-green leaves and spreading stems—is to maintain a dense, healthy lawn that will out-compete it and prevent it from establishing. Mow at a height of 2 1/2 to 3 1/2 inches, and cut the grass frequently so as not to remove more than one-third of the leaf blade at one time. Also, water deeply and infrequently, and fertilize to encourage a vigorous lawn.

Weed killers are another option. The most effective among them are pre-emergent types that kill weed seeds as they sprout. It's essential to apply herbicide before the crabgrass emerges from the soil. This happens in spring when soil temperatures are greater than 55° to 60°F for 7- to 10consecutive days. Check with your local extension service for timing, or monitor the soil temperature yourself using a soil thermometer inserted at an angle just below the surface. But don't apply weed killers prior to seeding or in an area that's just been seeded.

Pull Those Dandelion Blossoms!

As you head out the driveway on your way to work or shopping, you've probably noticed a yellow dandelion blossom or two. Make a note to at least pull the blossom off before it goes to seed, preventing it from spreading all across your lawn. If you have a dandelion stab, dig up the whole plant, or hit it with RoundUp.

More Hints & Tips

You've probably wondered where I get all the material you see in this column. Well, I keep my eyes open and read a

"Get the Lead Out" When Buying a Home -Stuart Lieberman(*)

People usually share the nostalgic view that "they don't build homes like they used to." And, when it comes to the

nation's older housing inventory, there is good reason. Older houses were often better built to last longer than contemporary houses. They had "class," "charm," "character," and matured lots. But don't forget something that is *not* so appealing: old houses often have lead.

Lead has been in American Paints Since the 1900s

While paint manufacturers have not been permitted to add lead to their paint since 1980, before then it was a common additive. Adding lead made paints brighter and increased their durability. Experts believe that in some parts of the country, three out of four homes are likely to have some lead paint. Wall paint and pipe solder are probably the most prevalent sources.

Problems with Lead

While experts generally concur that lead is potentially harmful, unfortunately there is little consensus on how much lead is harmful. Children are particularly vulnerable to the effects of lead contamination. Scientists believe that lead may cause serious health problems in children, especially young children. Studies link lead poisoning, which means that a person has a lot of lead in his/her body, with brain damage, nervous system impairment, and learning disabilities. It may also cause problems in pregnancy.

Experts believe that children under six are at greatest risk from exposure. Children who live or play with other children that have been lead poisoned are at greater risk. As are children living in pre-1960s homes and children that do not ingest sufficient levels of iron or calcium.

For good reason, federal health officials recently reminded owners of older homes to ensure that their children are kept away from home improvement projects involving paint scraping or sanding. A recent New York state study of children living in homes where there had been recent removals of leaded paint revealed that nearly ten percent had dangerously high levels of lead in their blood.

Ingestion and inhalation pose an ongoing threat to children in houses with leaded paint. Parents need not just be concerned during renovation projects, either. Small children haven been known to eat paint chips and to even bite contaminated windowsills. Due to the health risk, prudence therefore suggests that all home purchasers determine whether the home they are buying contains lead.

Legal Requirements

Under recent federal laws, buyers of pre-1978 homes must receive a pamphlet that identifies the risks of lead contamination. This pamphlet states that it is assumed that paint in pre-1978 houses is lead based. Buyers are instructed that they have the right to test for lead in the paint, usually at their own expense.

If lead is found, a buyer has the right to cancel the contract. There are two other options as well: (1) the seller may pay for lead paint removal or (2) the buyer may purchase the house "as is."

In addition, landlords are now required to advise tenants of the presence of lead paint once it is detected. If lead is found, a landlord must properly remove the lead containing paint. Landlords must also provide their tenants with information pamphlets concerning lead exposure.

Lead As a Contingency In the Sales Contract

It is very common practice for homes to be sold with "contingencies." The most common contingencies are an acceptable termite inspection and radon inspection (at least on the east coast). But there are few rules in real estate, only customs. Parties are free to adjust their contracts as they deem fit. In the case of an older home purchase, cautious purchasers, especially those with young children, may wish to consider an acceptable lead inspection as one of the purchase contingencies.

Conclusion

In the last ten years, there has been a tremendous amount of litigation nationwide over injuries allegedly attributed to lead contamination. Older paint manufacturers, distributors, and retailers have been included in these large, multiparty cases, and plaintiffs' attorneys have collected a sizable war chest of shared information. Their clients, often people who came into prolonged contact with lead as children, are alleged to be suffering from irreversible brain damage.

Home purchasers never are interested in buying into these kinds of horrifying lawsuits. They might therefore consider confronting this issue *before* the purchase. If you already own a house with this problem, a professional should be consulted to evaluate your particular situation and define your available options.

As explained above, recently enacted federal laws also cover this issue. Sellers need to ensure that their practices conform to federal law. Some states also have their own laws that must also be considered by buyers, sellers, and tenants.
