## Our May Meeting

Two sense-votes will be taken by VEP members on proposed work at Vista Park. The first of these involves a proposed relocation of the west ball field. Because of its orientation and close proximity to New Compton Drive, neighbors' homes/yards and passing pedestrians/motorists have been threatened by hard-hit, flying balls.

VEP formed a committee of neighbors last autumn to work with sports groups and the city to find a solution. They are now recommending that the field be relocated to have home plate at the north end of the park, and be rotated so that its first-base line is roughly parallel to New Compton (see article elsewhere in this issue).

**Joshua Howard** and **Art Rosales** will present the relocation plan. VEP members will be asked to express their support/opposition. If a majority of us endorse it, work could begin early this August.

The second vote will be on our support for the location of our new Community Room at Vista Park. Final plans for the building will be presented by **Bob Hencken** and **Josh Howard**. After a quick review of options considered, we'll be asked to vote on a VEP committee's recommendation for where to locate it.

Jim Helmer, Director of the City of San Jose's Department of Transportation will share information on transportation projects coming up in our area. We've asked him to include a discussion of plans for the widening of Branham Lane (Snell to Vistapark Drive) and associated sound walls, sidewalks, and landscaping. We also want to get Mr. Helmer's suggestions re how to slow traffic on Chynoweth Avenue (New World/Gaundabert to Pearl).

Jim Helmer has been a very good friend to VEP. He is a remarkable, long-time city employee who responds quickly and responsibly to every request we send to his department. I know you will be impressed and enjoy meeting him.

We always allow time for YOUR issues, so be sure to bring them along and share them with us. We develop our Goals & Objectives during the summer months, so input from you now will be especially timely.

### Vista Park ball field relocation

VEP's Ball Field Relocation Committee met on May 12 and decided to recommend to park neighbors and VEP members that relocation of the west ball field be started the first week in August this year. This project will take an estimated seven weeks, including two weeks to allow new turf to get established before opening for use.

Youth softball sports groups were present at our meeting. They said their schedules would not be affected if the work took place after June 15<sup>th</sup>.

What's being proposed is to move the west ball field from its existing location to the north end of the park, along New Compton Drive, approximately where the practice field used to be years ago.

This change is sought as a remedy to balls now being hit frequently into the street and neighbors yards—primarily by older players. Neighbors cannot use their back yards as a result, and the city is rightfully concerned over potential liability should a pedestrian or motorist be struck as they pass along New Compton. Near-misses have occurred.

We focused on selecting and orienting the proposed new site so that foul balls won't be a problem for a new set of neighbors. Special attention was drawn to the neighbor's house on Hornblower Court which juts farthest into the park near the new site; Parks officials propose adding height to the existing chain-link fence there as added assurance against future problems.

The city will do essentially ALL of the required work. Some volunteer work MAY be necessary if budgeted dollars don't stretch far enough.

VEP will notify all neighbors that could potentially be impacted (no pun intended) by this relocation. Parks & Recreation officials and a representative of Vice Mayor Pat Dando's office will attend our May 25 VEP meeting to present the relocation plan. We will vote that night to indicate whether they have our support.

# Membership Drive

### Water softener rebate program

The Santa Clare Valley Water District (SCVWD) is offering a rebate program that gives Santa Clara County homeowners a \$150 rebate for replacing a currently-owned, existing timer-based water softener that was purchased before October 31, 1999.

Your old water softener must be replaced with a new demand-initiated regeneration (DIR) model that meets the California efficiency rating of 4,000 grains of total hardness removal per pound of salt utilized. The new DIR water softener must be installed by July 31, 2004. The funds available for this rebate are limited and could run out before that date. A pre-inspection may be required.

New DIR water softeners use up to 50% less water than some timer-based models. When you save water, it saves energy because it takes energy to treat the water and deliver it to your home.

A new DIR water softener can also use up to 50% less salt than some timer-based models. Many older water softeners are not salt efficient and cycle more often than needed. The DIR water softeners meter your water usage and regenerate only as required.

# Week-long summer day-camps for kids

Campers will meet every day at 8:30 am (Wednesdays at 8 am) at the Guadalupe Garden Center. On Monday, all activities will be presented on-site by the Friends and will include a discovery hike of the Guadalupe River, water experiments, a wriggly moment with composting worms, archeology digs and more!

On Tuesday morning, campers will board a bus for a day at the Mexican Heritage Plaza to experience Mexican art and culture (children who sign up for the first week of camp will meet the internationally renowned *Mariachi de America* from Mexico City and watch them in action!).

Wednesday's destination will be a visit to a bird banding station on Coyote Creek and a chance to explore wildlife and marshes at Don Edward's Environmental Education Center in Alviso. On Thursday, the bus will take campers to the Museum of Art for an eyes, brains, and hands-on artistic experience. On Friday, campers will visit History San Jose, where they will discover how a child's life in old San Jose might have differed from their own!

Campers will return to the Guadalupe Garden Center each day and will be ready for a ride home at 5 pm.

This new day camp will be held three times this summer for children between the ages of 7 to 10, during the weeks of July 12, July 26, and August 9. Each camp will feature the same activities.

## Capitol Expressway light rail transit plan

The draft Environmental Impact Report (EIR) for the *Downtown East Valley Capitol Expressway Corridor Project* is now complete and being circulated for public comment. While the report discusses three options, it is clear that VTA strives to run light rail down the median of Capitol Expressway from the Alum Rock station all the way to Route 87.

Naturally, VEP executives and members are concerned that this would exacerbate traffic gridlock on Capitol Ex-

pressway from Vistapark to Route 87. We have a number of other concerns as well.

A public hearing will be held on Thursday May 27, 2004 from 6 to 8 pm at the Hank Lopez Community Center, 1694 Adrian Way, San Jose. At least two VEP executives plan to attend that meeting. Please join us.

VTA's deadline for receiving public comments is June 21, 2004. VEP executives are reviewing the EIR and plan to send a formal letter to VTA with our comments.

Here is some history on this plan:

At our February 25, 2003 meeting, VTA presented its plan for a Capitol corridor extension to the light rail transit system, connecting the Eastridge Mall in East San Jose to the Capitol LRT station at Hwy 87 (see related articles in the February, 2003 VEP News). Although plans for construction may be 10- to 20-years out, VTA had already finalized options for this extension and was in the process of preparing the Environmental Impact Report (EIR) for their project.

VEP responded to the plan in an April 17, 2003 letter to the VTA Board, commenting on and questioning several aspects of the plan. Some of these include traffic impacts on Capitol Expressway and its intersections, motorist and pedestrian safety on the reconfigured expressway, impacts on the surrounding neighborhoods and businesses, land-scaping issues, ridership projections used to justify the expense, and alternatives that might fit better with the concept of light rail transit for San Jose and the Santa Clara Valley. # Cable system replacement

Here is a brief description of our construction process:

1. Our construction crews first cut a 4" wide trench in the street near the curb to install fiber-optic cable. After the cable is installed, the trench is filled with cement. The top of the trench is deliberately left low to allow the cement to cure and to prepare the street for restoration.

Once the cement is cured, our crews grind the existing asphalt wider than the actual trench in preparation for new asphalt. The reason for this wide grind is to give a stronger and wider area for the asphalt to bond. This results in a longer lasting and stronger asphalt finish. Weather permitting, this "grinding" and asphalt replacement usually takes place within two- to three-weeks after the initial work.

2. In areas where the cables enter a box on a public utility easement (near the curb), the sidewalk is removed to facilitate the work. After our crews install the cables, they place a temporary black asphalt patch on the sidewalk.

This patch is placed to give pedestrians a smooth walkway immediately. Within two- to three-weeks, our work crews will replace with new concrete the entire section of sidewalk that was removed. The sidewalk will be restored to meet city standards.

City of San Jose inspectors inspect each phase of our construction to ensure that our crews meet all requirements for the construction project and city specifications. Furthermore, we will repair any damage to private property caused by the construction.

## Capitol Expressway name change

In case you missed it, here's an excerpt from a story the San Jose Mercury News ran on 4/21/04 regarding the outcome of a proposal to rename of Capitol Expressway:

Street naming effort refused HONOR SOUGHT FOR REV. KING By Katherine Corcoran, San Jose Mercury News

A group of current and former San Jose residents trying to rename a local street in honor of Dr. Martin Luther King Jr. encountered another roadblock, this time at the county.

Responding to the group's request to rename Capitol Expressway in honor of the slain civil rights leader, the Santa Clara County Board of Supervisors decided in a split vote to ban the renaming of the county's expressways for any reason.

Supervisor Liz Kniss, who voted for the ban, said she was concerned about the cost in tight financial times. A county study showed that changing the street signs on Capitol Expressway would cost between \$500,000 and \$700,000.

The report also noted that the county has a similar ban on renaming parks.

# Street lights

While on my walk around the neighborhood recently, one of our members observed to me that two of the lights in Vista Park were on 24/7.

I went to the poles and recorded their number. Then, went home and called 277-5517, the city street light maintenance number. It's a voice-activated system that is available round the clock. After that, my conscience bothered me because I am aware of a light on my daughter's street that didn't come on. I went over there, got the number and called it in, too.

If you know of a street light that does not come on or go off properly, get the pole number and call it in. It could even save a life sometime.

### President's message

I remember growing up in San Jose and being told not to go into certain areas as they were "a dump". I have seen our city and our community clean up and I am proud of the living conditions in our city.

## Pat Dando's stand on city parks

Vice Mayor Pat Dando strongly believes that parks bring communities together and are a great source of neighborhood pride. Saturdays at the park, watching the kids play forms friendships among families that usually last for years. To that end, the city needs to continually provide for these basic municipal services.

At the May 13 budget study session, Vice Mayor Dando discussed the need for a comprehensive review of how the city maintains its parks. Through a management audit, she is confident that the city will find new ways to deliver these services more efficiently and at a lower cost. She has forwarded a request to the City Manager asking that he begin this review immediately.

In November 2000, San Jose voters supported a parcel tax to fund the development of new parks and rehabilitation of existing parks in their communities. Vice Mayor Dando strongly believes that the city has a responsibility to keep these facilities clean, safe, and open for our neighborhoods.

One of the most interesting things that it is now possible to do over the web is to plan a vacation. There are lots of sites out there that are waiting to help you, but it does require work on your part.

If your preferred mode of planning is to go to a travel agent and let him or her make all the arrangements, it can be done on the web, but you may not get the best prices or do all the things that you might like at a particular place. The Web doesn't take the place of perusing travel books to learn about the sights and accommodations of a place.

Here are a few tips:

Get in touch with the tourist bureau of the cities and countries you will visit. You can find them on your search en-

gine. Especially when planning a foreign trip, pay particular attention to maps and public transportation facilities. Most countries have better public transportation facilities than the US and it might be inadvisable to drive.

Passes on rail transit in Europe are cheaper when bought in this country, but you need to figure out how many days you expect to be traveling to get the right ticket. If you are just looking for all-in-one tours, there are a lot of agencies out there for that. If one size fits all doesn't work for you, and you want to plan your own itinerary, then you might want to go to specialized agencies.

For instance, last year I planned a three-week trip in Italy. I plotted out the path that we would take. I got an Italian 5-day RealPass that had a couple of days of auto rental included (that was a good deal) and made all my hotel reservations over the web. I made some of the reservations directly with the hotel, but made most of them through Hotels.com. There were no glitches. The hotel charges were reasonable, the cars were available, and the trains all ran on time.

For flights, you can try sites like Expedia, Travelocity, and Bestfares. Don't forget to try the airlines sites, especially lines like Southwest and Jet Blue. Sometimes you get the best deal directly from the airlines.

Cruises are another avenue to explore. There are lots of sites specializing in cruises. However, after trying a bunch of them you will find the same cruises and costs. Just ping a few to get a feel for what's available.

If you can react at a moments' notice, you might put yourself on the mail list of sites that specialize in last minute sales. Try Travelzoo, Cheaptickets or Bestfares.

A lot of what you can do depends on your flexibility, sense of adventure and passion for travel. Try looking around. It won't cost you a thing to look.

# Gardening tips

#### **Pruning Citrus Trees**

You may get delicious fruits from your orange, tangerine, and grapefruit trees, but eventually, those trees get out of control and need pruning. To keep them in good health, you should remove dead or weak branches and thin twiggy growth.

It is also possible to rejuvenate older, established citrus trees, which usually respond well to hard pruning. Start with by cutting away dead, injured, diseased, and crossing branches, suckers, and/or branches growing downward. At the next pruning, remove weak branches and overcrowded growth.

Never remove more than one-fourth of the tree at one time. Keep in mind that most citrus trees have a limited supply of carbohydrates in their stem tissues. Excessive pruning at one time may set back growth and fruiting.

After the tree is back in good shape (it may take a couple of years), continue to thin as needed. You can also cut back long branches at their tips to promote shoots nearer the center of the tree. If more than one shoot arises around a cut, choose the one or two best-placed shoots to develop as the main branches.

As far as flavor and sweetness is concerned, many grape-fruit trees prefer warmer climates to develop the sweetness you desire. However, we are very fortunate to have some relatively new grapefruit-pummelo crosses that develop very good flavor and sweetness in Santa Clara Valley. These include the Oro Blanco and Melogold varieties.

You can top an old citrus (or most trees for that matter) by severely cutting back the tree and grafting on the preferred variety.

#### Checking for Termites

If your garden seems to be invaded by many flying insects with four wings (3/8- to 1/2-inch long) with 3/16-inch ant-like bodies, you may have subterranean termites. Hundreds from a colony will develop wings, fly, mate, shed their wings, then seek new sites to build nests.

Subterranean termites usually leave their nests in October. They look for pieces of wood or roots next to or on the soil and dig tunnels into the wood. If needed, they construct tubes made from soil to get to the wood, protecting them from desiccation and predators. Termite inspectors look for these distinctive tubes of dried mud leading from the soil to the foundation and into wood frames of homes where they feed.

You might consider doing your own inspection. Use a strong flashlight and look at each footing of the foundation for those tubes.

#### Stop Invading Roots

Barriers to our neighbor's vine and/or tree roots may seem needed this time of year, particularly now since everything is growing so well with our recent rains.

Plastic root barriers, impregnated with chemicals, are available in the garden department at Orchard Supply.

The usual practice for installing root barriers is to dig a two-foot deep trench alongside your fence. If possible, rent a trenching machine to do the digging. These are available from rental yards, and almost anyone can operate them.

Place the barrier on the fence side of the trench, then backfill. These barriers are supposed to stop all roots from going past them, but some aggressive tree roots will go down and under the barrier in a few years.

You can plant shrubs near the barrier, but be aware that the barrier will also prevent the extension of their roots and thus limit their ability to get the nutrients and moisture needed to grow properly.

Barriers are not always a permanent solution, but you may be lucky and stop those roots from coming into your yard.

### When to call 311 vs 911

A VEP member wrote to me just before our April meeting apologizing that she could not attend. She had a question of general interest that she hoped I could ask of SJPD Chief **Rob Davis** at the meeting.

Here's the question: You see a group of teenagers periodically in a park, and their behavior suggests they may be doing drugs. Do you call 311 or 911?

Here's the answer: If the activity is in progress, call 911. If it's not in progress, call 311 and provide any information that may help the police such as time of day you notice the activity, etc. If you aren't satisfied with the response from 311, you may ask to speak with a supervisor.

If possible, get license plate numbers. If the police don't catch the individuals, they can look for their car. More importantly, they can visit the home of the registered owner. Parents are normally very responsive when they hear their car has been spotted near possible drug dealing.

Finally, you can talk to Lt. Commander **Jack Farmer** at 408-277-5530. He is in charge of our area, and well in tune with our issues. He has been very responsive to our traffic concerns near Gunderson, for example.

By the way, did you know that cell phone calls to 911 are handled by a call center *outside* of San Jose? That can delay a response to a local emergency. The City of San Jose has made the following phone numbers available for <u>cell phone</u> users to access its emergency call center:

- 911 calls (emergency) = (408) 277-8911
- 311 calls (non-emergency) = (408) 277-8900

### West Nile virus

West Nile virus is a mosquito-borne virus, carried in the female mosquito. Although new to the U.S., West Nile virus has been found for several years in parts of Asia, Eastern Europe, Africa and the Middle East. First detected in the United States in 1999 in New York City, West Nile virus was reported in 28 states by the end of 2001 and continued its move westward in 2002. California reported its first human case in September 2002, although it is unclear how or where the patient acquired West Nile virus

since no infected birds or mosquitoes were detected prior to or following the detection of that case.

#### Who is affected?

Humans and animals, including birds, may all be affected by West Nile virus. The majority of people and animals infected with the virus have mild or no symptoms.

Those most at risk are the elderly and those who have compromised or weakened immune systems.

#### What are the symptoms?

Most people who are infected with the West Nile virus will not experience any type of illness. Mild symptoms include fever, headache and body aches, occasionally with a skin rash on the trunk of the body and swollen lymph glands. Symptoms of mild illness will generally last a few days. Severe symptoms of West Nile encephalitis or meningitis include headache, high fever, neck stiffness, stupor, disorientation, coma, tremors, convulsions, muscle weakness, and paralysis. Symptoms of severe illness may last several weeks, although neurological effects may be permanent. It is estimated that 1 in 150 persons infected with the West Nile virus will develop a more severe form of the illness.

#### How does it spread?

West Nile virus is normally spread to humans, animals, and birds through the bite of an infected mosquito. A mosquito first acquires the infection by feeding on a bird already infected with the virus. The virus lives in the mosquito and is then transmitted through the mosquito's saliva when it bites a person or an animal.

Birds are "reservoir hosts," meaning the virus can survive in the bird's blood system and, through the bite of a mosquito, be spread to humans and animals, including other birds. Humans and other mammals are considered "incidental" or "dead-end" hosts, meaning that mosquitoes biting infected humans cannot spread the infection to other humans or animals.

Although rare, West Nile virus has been transmitted through blood transfusions, organ donations and breast milk.

What can I do to protect myself and my family from being bitten by mosquitoes?

- When possible, wear long-sleeved shirts and long pants whenever you are outdoors.
- Place mosquito netting over infant carriers when you are outdoors with babies.
- Consider staying indoors at dawn, dusk and in the early evening, which are peak mosquito-biting times.
- Install or repair tight-fitting window and door screens so that mosquitoes cannot get indoors.
- Apply insect repellent in moderation to exposed skin. Choose a repellent that contains DEET (N. Ndiethyl-m-toluamide or N, N-diethyl-3-methylbenzamide) in a concentration that provides protection for the amount of time that you will be outdoors. Whenever you use an insecticide or insect repellent, be sure to read and follow the manufacturer's DIRECTIONS FOR USE, as printed on the product. Avoid applying repellent to the hands of children.
- Spray clothing with repellents containing permethrin since mosquitoes may bite through thin clothing. Do not

apply repellents containing permethrin directly to exposed skin.

NOTE: Vitamin B-1 and "ultrasonic" devices are NOT effective in preventing mosquito bites.

What can I do to fight West Nile virus?

- Routinely check and eliminate any standing water in your yard. Remember, water an inch deep can produce hundreds of mosquitoes. Use the list and picture in this brochure to check your yard.
- Report neglected or abandoned swimming pools, hot tubs or fish ponds to the Santa Clara County Vector Control District.
- If you find a bird that has recently died, particularly a crow or other corvid (i.e., jay, magpie, raven) please call 408-792-5010. SCCVCD will arrange for pickup and testing when appropriate.
- Contact the SCCVCD if you are experiencing problems with mosquitoes.
- Contact the SCCVCD for a speaker on West Nile virus for your homeowners or neighborhood association, or civic group.

What is our County doing to prevent West Nile virus? West Nile virus cannot be prevented from entering Santa Clara County. Controlling the mosquito population in our county will reduce the chance of people being bit by mosquitoes that could be carrying West Nile virus. The Santa Clara County Vector Control District (SCCVCD) routinely surveys for mosquito-borne diseases such as West Nile virus. Santa Clara County has maintained a mosquito abatement program since 1918. This includes routinely checking the hundreds of miles of creeks and waterways and more than 30,000 storm drains for developing mosquitoes, treating when necessary.

In addition to efforts to keep down mosquito populations, SCCVCD also has surveillance for the presence of viruses which cause human disease. Adult female mosquitoes are trapped and tested for these viruses. Also, since the primary carrier of West Nile virus and other strains of encephalitis virus is a mosquito which prefers to feed on birds, sentinel chicken flocks are placed throughout the county and tested for infection every two weeks during times of high mosquito activity, usually spring through early fall. The SCCVCD also collects and submits dead birds to the California Department of Health Services to be tested for West Nile virus.

SCCVCD also provides free home and yard inspections for mosquito sources as well as free mosquito-eating fish to interested residents.

The Santa Clara County Public Health Department has educated the physician community in the county about the signs and symptoms of West Nile virus. This educational campaign provides physicians with information they need to identify early cases of West Nile virus infection, if needed.

As a steward of many of the creeks, reservoirs, wetlands and ponds in the county, the Santa Clara Valley Water District works collaboratively with SCCVCD and the public health department to identify and report mosquito problems and educate the public about the virus.

It is unnerving when a car accident affects those beautiful palms. Fortunately, they have probably prevented some cross-over head-on collisions. Unfortunately, most accidents are caused by excessive speeding. VEP is working with the city police and transportation departments to help slow down Chynoweth traffic.

If you see a tree getting hit, please note the license plate number and a description of the responsible vehicle(s), along with the time and date. Call 911 to let them know that an accident has occurred. Then call or email me. I will call the police department to get a police report number, then make sure Vice Mayor **Pat Dando**'s office hears about it.

We've taken an aggressive stance on getting damaged trees replaced. When the palms were smaller, we used to reach into our own pocket to pay (\$50 to \$60) for replacements. VEP now insists that the person responsible for the accident gets a bill for installation of a replacement tree that's closer to full-size. Dando has always assisted us in making this happen.

It takes a while to get a replacement tree, but is worth the wait. You may have noticed that our volunteers are out there several times each week, watering them until they're established. Reckless speeders may pay for replacement damages, but our volunteers have to pay too—with time and effort—to keep this gateway into our community looking well-groomed.

# Our April meeting

Thank you to everyone that attended our April Meeting! We had a nice turnout and a lot of great information.

The meeting began with **Joshua Howard** from Vice Mayor **Pat Dando's** office giving us an update on the Vistapark ball field relocation issue. To help solve the problem of balls being hit over fences and into backyards, Joshua gave us two solutions. First, signs will be posted that state that the ball field is limited to <u>youth</u> softball only. If this ordinance is not followed we have been instructed to report the violators.

Second, funds have been found to have the ball field closest to New Compton relocated to the north end of the park (where the practice field used to be years ago). The parks department will do a presentation at VEP's May 25<sup>th</sup> meeting to show all of our members the new layout. We will ask for a vote that night to measure neighbors' acceptance.

Parkview Park #2 is slated to open next weekend. The new Cilker Park (on Winfield at Chynoweth) will have a grand opening and ribbon-cutting ceremony in late June. (The date will be announced to VEP members via email.)

San Jose contracts with several service providers to collect garbage, recycling, and yard trimmings and to sweep streets in City neighborhoods. Norcal, GreenTeam, and GreenWaste Recovery each have their own customer service representatives to handle your service needs.

Read the information below to find out which companies serve your neighborhood. Call the numbers listed next to their logos for service-related issues, like cart replacements and missed pick-ups.

Who is my garbage and recycling hauler? Check the first two letters of the serial number on your recycling cart.

Who does my yard trimmings & street sweeping service? If GreenTeam collects your garbage and recycling, then GreenWaste Recovery sweeps your street and collects your yard trimmings. If Norcal collects your garbage and recycling, then check the hauler map on our website at www.sjrecycles.org to see whether GreenWaste Recovery or Norcal collects your yard trimmings and sweeps your street.

Call the city's *Recycle Plus* Customer Service at (408) 277-2700 for billing and account-related inquiries. Please note our new hours: 8 am to 1 pm and 2 pm – 5 pm, Monday through Friday.

### Recycle Your House

We all know that much of the waste we generate in our homes is recyclable, but did you know that much of your home is recyclable too?

San Jose's award-winning construction and demolition (C&D) recycling program makes it easier for homeowners and contractors to recycle the debris from their remodeling and construction projects. By adding C&D recycling to its programs, San Jose has reduced the amount of materials disposed of in local landfills and maintains the highest recycling rate of any large city in the country.

If you plan to work on your home, visit our website at www.sjrecyles.org/business/cddd.htm. It explains how to get rid of materials like clean wood, tree stumps, concrete, asphalt, and dirt, and how to get your construction permit deposit returned.

#### Spotlight on Yard Trimmings

What happens to yard trimmings after they leave the curb? Every week Norcal Waste Systems and GreenWaste Recovery collect about 500 tons of yard trimmings from approximately 200,000 San Jose homes. The yard trimmings are then taken to composting facilities for processing. After being ground into smaller pieces, the material is formed into long outdoor rows, called windrows, for composting. Each windrow is equivalent to the height of a basketball hoop and the length of three football fields.

The windrows are continuously turned and watered for over twelve weeks to complete the decomposition process. Temperatures are monitored closely as the windrows reach target temperatures of approximately 131° F for 15 straight days. The high temperature helps kill all bacteria and accelerates the decomposition process.

The finished compost is used in the city's parks and community gardens and sold to the local soil amendment markets. To buy bulk compost at competitive prices, please call BFI at (408) 945-2844, or Zanker RRM at (408) 263-2385.

#### Reduce & Reuse

Help endangered animals and dispose of your old cell phone at the same time. With every cell phone donated, Happy Hollow Park and Zoo will receive funds from the Wireless Foundation to help preserve one of the most endangered species on earth, the Orangutan, and its habitat.

The phones are sent to ReCellular where they are refurbished and sold at low rates as an alternative to buying new phones. The money that is made from selling the phones is distributed by the Wireless Foundation to the Balikpapan Orangutan Society and to help several domestic safety, school and community watch programs.

#### Can old CDs and videos be recycled?

No, there is no market for them at this time. But they can be reused. If your old CDs, videos and tape cassettes are in good condition, consider donating them to your favorite charity before discarding them in your garbage cart. If you live in an apartment or multi family complex with a community room, your association may want them to use in an exchange library.

Gardening tip: Like wind chimes, old CDs may be hung from fruit trees or vines. They will catch the light as they sway in the breeze and discourage birds and squirrels from enjoying your harvest before you do.

Can I put my old garden hose in my recycling cart?

No, unfortunately. Hoses will jam processing equipment at the recycling center, so they must go in the garbage.

Gardening tip: Cut your old hose into pieces and use them to protect tree branches from wire plant hangers. Simply thread the wire hanger through the hose when suspending a hanging plant from a branch. Your trees will thank you!

#### **Bulletin Board advertising rules:**

- 1. Bulletin Board ads are limited to four (4) lines of text. One line contains 50 characters, including spaces.
- 2. VEP will print **free** Bulletin Board ads <u>for its members</u> for onetime transactions involving less than \$400, for lost and found, and for services offered by kids under 18 or retirees over 60 years of age. Free ads may be published in a maximum of three successive issues of the VEP News per submission. After three issues, non-renewed ads will be dropped without notice.
- 3. VEP will print commercial Bulletin Board ads <u>for its members</u> for \$6 per issue of the VEP News. (A commercial ad is one that offers goods and/or services for a fee. The VEP President and/or Editor has final say in determining whether an ad is commercial.) Ads must be prepaid before publication and be of four (4) lines or less in length (see 1, above). Commercial bulletin board ads may be published indefinitely so long as payment is received in advance of publication. Non-renewed ads will be dropped without notice. No graphics allowed.

### VEP history in a nutshell: 1983 – 1986

The following is another in a series of summaries of VEP history taken from our newsletter archives. This summary covers 1983 to 1986. VEP is scanning archived newsletters and posting them on-line at the VEP web site (www.vepca.org).

1983 VEP News is *mailed* to members for the first call for approval of annual goals and objectives and to allow the executive committee to take action in alignment with the goals and objectives on behalf of the organization between meetings. CalTrans begins 32-month "Alternative Analysis" study of West Valley Corridor (now Hwy 85) at a cost of \$975,000. Branham Lane opens to Monterey Road.

VEP Treasurer **Jim Hicks** is appointed to City's *Horizon* 2000 Task Force by Councilmember **Iola Williams** to draft a General Plan for 1984-2000. 84 of 110 property owners adjacent to the Lick Spur respond to an Southern-Pacific survey that they would be interested in purchasing Lick Spur parcels; city requirements for drainage of the land is an issue. SPRR offers sale of land to adjacent property owners.

Dave Fadness serves another term as VEP President. Aiko Fadness elected President of Gunderson PTSA. Federal Urban Mass Transportation Administration head, Arthur Teele, questions the capital efficiency of the \$215M Guadalupe Corridor light rail over bus and car pool solutions in a letter to State Assemblymen Ernie Konnyu. The Building Industry Association asks San Jose City Council to allow development in advance of planned transportation improvements for the Guadalupe Corridor.

Jerry Estruth visits VEP to discuss closing of Belden School. City proposes postponing \$125,000 development of 2-acre Vista Park to '84-'85 pending SJUSD's decision on the Belden property. VEP successfully lobbies city for a controlled crosswalk across Branham for Belden students going to Carson School.

1984 Congressman Norm Mineta discusses foreign policy, including US policies in Lebanon and El Salvador, at townhall meeting held at Gunderson. San Jose rolls out 5-year capital improvement plan including \$67.5M for roads and highways in and near VEP (including building of Hwy 85 and 87 and completion of Vista Park Drive from Blossom Hill to Branham through the Lester Property), \$500K for parks improvements including Meadows Park and acquisition of the Belden School site, and \$115K for Santa Teresa Library.

VEP members ratify by-laws changes to protect members from misuse of VEP membership lists and to institute the VEP *Community Service Awards*. May meeting features City Council District 2 candidates' night with **Gene Amato**, **Kieth Lowry**, **Judy Stabile**, and **Richard Vincent**, at a trash-strewn Gunderson High School--in the middle of Project MAYNARD (May All Your Nasty Awful Rubbish Disappear).

350 VEP members lead by **Ray Call** and **Brian Bonnifield** attend city budget hearing to lobby for purchase of 9+ acre Belden site from SJUSD under the Naylor Act. City buys 4-acres for \$560K, with first right of refusal on remaining acreage. City also buys 1.66-acres of the Lick Spur adjacent to Meadows Park from SPRR for \$125K.

**Robin Pugh** (Gunderson) and **Christine Herran** (Hill) won inaugural \$250 VEP Community Service Awards (CSA).

Horizon 2000 General Plan released, planning for city population growth to 836,000 (an increase of 145,000) and to 315,000 housing units (an increase of 75,000) by the year 2000. Plan also establishes Coyote Valley and South Almaden Urban Reserves with building triggers tied to job, housing, and transportation growth. County launches *Transportation 2000* effort.

1985 City Council approves purchase of remaining Belden School site land. VEP dissolution agendized at April meeting for lack of a voluteer for president. **Dian Burdine** steps up to volunteer for president and is elected at our May meeting. (Vitality + Energy + Persistence = VEP.)

VEP surveys Arcadia homeowners about cracked walls and foundation settling. VEP retains an attorney to persue a cracked wall class action suite against Arcadia.

720 Gunderson students recognized at 2<sup>nd</sup> Academic Honors Night. **Kimberly Basehore** and **Michele Kato**, both of Gunderson, win VEP's 2<sup>nd</sup> CSA. No nominees were submitted by Hill.

City Planning Department proposes rezoning 4.8-acres of Belden School site to medium density residential (8 units/acre). CalTrans completes "Alternative Analysis" study of the West Valley Corridor and presents nine alternatives for public input. City proposes relaxing traffic level of service requirements for new development.

1986 VEP successfully lobbies against a General Plan change to make Narvaez a through street across the Lick Spur. Arch Walters from the Santa Clara County Transportation Agency and Jim Leitner from the city attend our March meeting to present the 85/87 Corridor plans to VEP members.

Christopher Henriques (Hill) and Kenin Nichols (Gunderson) win CSA. Lick Spur property ownership still not transferred. VEP keeps up pressure on SPRR and the City to resolve issue surrounding the land sales. **Dave Fadness** re-appointed to County Transportation Commission.

City plants shrubs and trees to improve the Branham Lane median between Narvaez and Vista Park Drive. VEP begins expressing concern over 85/87 interchange and 87 crossings at Capitol, Branham, and Chynoweth. VEP members approve neighborhood-proposed changes to the 85/87 interchange and requests action on our proposal by the City. The City Council unanimously supports VEP's recommendations and VEP gains the support of the Joint Powers Board.

Council member **Judy Stabile** suggests that the new park at the Belden School site be named Josiah Belden Park after the first mayor of San Jose. VEP successfully lobbies for the name **Vista Park**.

#### FLASHBACK

VEP member **Al Snyder** happened across a copy of Arcadia's 1971 Vistapark sales brochure the other day. We neighbors got a few belly-laughs from the following passage printed on its cover. Read and enjoy (hindsight <u>is</u> 20:20!)...
