★ <u>Branham Lane Widening</u>: San Jose Department of Transportation's **Rene Cordero** will update us on plans to widen Branham Lane, Snell Avenue to Vistapark Drive. VEP has asked the city to include consideration of improved sound walls, landscaping, and provisions for safer turning movements in this plan. We also requested that they consider safety improvements between Vistapark and Narvaez.

★ <u>Update on Martial-Cottle Park</u>: County Parks Director Lisa Killough and County Supervisor Don Gage's Aide Rachael Gibson will report on the status of plans for a park on the Lester Property. (See article by Don Gage in this newsletter.)

★ <u>VEP Business</u>: We want your input on and need member approval for two proposed expenditures:

weekends, donating time planting trees and bushes, weeding, painting over graffiti, watering, picking up trash, etc., people often mistake us for "weekend warriors." Most citizens assume that anyone who does work in public places is either a government employee or a convict.

# Martial Cottle Park update

- County Supervisor Don Gage At VEP's November 23<sup>rd</sup> meeting, County Parks Director **Lisa Killough** and my Policy Aide **Rachael Gibson** will provide a status report on current activity at the Walter Lester property, or *Martial Cottle Park* as it is now officially known.

As most of you are aware, in October 2003 Mr. Lester donated 153 acres of land to the County and, in a separate transaction, sold State Parks 136 acres at a significant discount. The State and County then entered into an agreement whereby the County will develop and manage the entire property as the Martial Cottle Park.

The first step in that process will be development and eventual adoption of a master plan to guide operation

and maintenance of the entire acreage. The master plan process will be inclusive of many stakeholders, perhaps most importantly the local community, and is expected to take approximately two years.



In the meantime, Parks has begun preliminary studies of how to open a small portion of the park to public access in the near future; **Lisa Killough** will elaborate on those plans at the VEP meeting.

As a condition of the property's transfer, Mr. Lester built into the transaction certain deed restrictions that seek to ensure that his vision for a historic agricultural park is maintained as the site is planned, developed, and operated. Here is the text of the recorded deed restriction:

"No part of the property shall be used for high intensity, organized recreational uses such as athletic fields, playgrounds, tot lots, swimming pools, play courts, amusement rides or similar uses, nor as a repository for historic structures that are relocated from other sites. The property shall be used exclusively as a public historical park that informs and educates the public about the agricultural heritage of the Santa Clara Valley, as exemplified by the Martial Cottle family, dating from the 1850s into the 20<sup>th</sup> century. The property may be used for passive recreational activities such as picnic facilities, trails, and other low intensity uses that may be incidental to the primary historic and educational purposes of the park, and for interpretative, passive recreational, agricultural education and research and commercial uses that area reasonably related to the history of farming in the Santa Clara Valley. In addition, commercial uses such as agricultural leases, produce stands, community gardens, farmer's markets, interpretative programs or similar uses may be allowed if reasonably related to the primary historical purpose of the park."

That's certainly specific! As the master plan for Martial Cottle Park progresses, this deed restriction likely will be the guiding force behind the park's ultimate development. I look forward with great anticipation to partnering with the community on this historic master planning effort.

#### **Branham and Snell Road Widening Project**

During and after the property's transfer to the County, the City of San Jose informed the County of pending



plans to widen both Snell Avenue and Branham Lane. As is the case with most capital improvement projects, the City had plans to widen these arterials long before Mr. Lester considered donating his property. However, those plans never reached

fruition, and now the City is working with the County on completing widening plans.

Because it is now officially designated park land, the County cannot simply donate the acreage necessary to accomplish street widening; to do so would violate laws protecting park lands. However, recognizing that all local jurisdictions are feeling the budget pinch, County staff is working on an arrangement with the City whereby the City would contribute in-kind resources (such as traffic signals) in lieu of cash compensation, and the County would then convey the acreage necessary to widen the streets.

These negotiations take time, and have not concluded yet. However, I am confident that County and City staffs will continue to work cooperatively toward ultimate widening of both Branham and Snell. \* \* \* \*

#### **VTA Transportation Forum**

On November 23, 2004 there will be a forum to discuss the Valley Transportation Authority's (VTA) transportation plan 2030, also known as VTP 2030. The purpose is to raise awareness on transportation priorities in the county and to receive public feedback on the projects. VTP 2030 consists of transit, highway, and local road improvement projects in Santa Clara County.

This meeting will take place at 6:30 pm in the Board Chambers located at 70 West Hedding Street in San Jose. I hope to see you there and encourage your participation.

#### School consolidation update

-Irene Shoberg (\*) An Ad-Hoc Committee has recommended to the SJUSD staff that Steinbeck Middle School be closed after this school year. There is a public forum on November 15<sup>th</sup> and the first reading by San Jose Unified's School Board will be held on November 18, 2004.

A second reading and final Board Action will take place at the regularly scheduled School Board meeting on

December 9, 2004 at 855 Lenzen Avenue. Citizens will have an opportunity to speak SNP (be sure to fill out and submit a stand (be sure to fill out and submit a speaker card before the meeting starts at 6:30 pm). Call the school district at 535-6000 for further details.

January 6 and 13, 2005, 6:30 to 8:30 pm Public Forums: Staff recommendation on Elementary School Consolidation in District Office. Room 129.

January 20<sup>(\*)</sup>, 6:30 pm Board meeting/Public Hearing: Elementary School Consolidation Recommendation, first reading; District Office, Room 129.

February 10<sup>(\*)</sup>, 6:30 pm pm Board meeting/Public Hearing: Elementary School Consolidation Recommendation, second reading and final Board Action; District Office, Room 129

<sup>(\*)</sup>Note: 1/20 and 2/10 dates are tentative, pending approval by the Board of Education on December 9. 2004.



The wonderful thing about daffodils is that they come back every year, so you should see daffodils popping up all over from our 4 years of planting. Once our daffodils emerge from the ground, please keep your

eye out for folks spraying weeds and ask them not to spray the daffodils.

Finally, I'd like to thank our parks manager **Art Rosales**. He arranged a meeting with VEP leaders and parks maintenance staff prior to planting day to help select planting locations and communicate where to avoid applying weed spray. They also gave us park maps that showed where utility lines were so we could be careful not to disturb them with the trencher.

Our volunteers at Cilker Park expressed interest in working with VEP to officially adopt that park through the City of San Jose Adopt-A-Park program. Watch for updates in upcoming issues of the VEP News.

# San Jose pets given amnesty

*-Debra Suydam* In celebration of the opening of the new City of San Jose Animal Care Center, they will license your pet with no citations, no late fees, and no penalties for 45 days starting October 15<sup>th</sup>.

Every person who owns a dog or cat over the age of four months is required by law to license their animal (Ordinance 20128.7.08.610). Dog and cat owners who fail to comply with licensing requirements are subject to costly penalties! A license tag should be securely fastened to your pet's collar or harness and worn at all times.

In order for the Animal Care & Services to license your pet, you must have proof of current rabies vaccinations. The first rabies vaccination is good for one year, the second vaccination given one year later and subsequent (or booster) vaccinations are valid for three years. You can get the rabies vaccine from your local veterinarian or a vaccine clinic.

Just give them a call at (408)578-PAWS (7297) and help protect your dog or cat now! After the amnesty period, all citations, late fees, and increases in fees will apply, so please hurry. Amnesty ends November 30, 2004.

Amnesty information: All dogs and cats are required to have current rabies vaccinations before being licensed. Animal Care & Services will offer the rabies vaccine for only \$5.00 on the dates listed on their web site

To take advantage of this opportunity, just bring your pet to the new facility at 2750 S. Monterey Road (south of Umbarger Road, near the Santa Clara County Fair-grounds). You can also purchase a license there.

# Oak Grove School District

Our top priority for the Oak Grove School District is always the safety of students and employees. We are continually examining policies and practices around safety issues as we strive for the safest environment possible. Each school has developed two types of safety plans.

**Emergency School Plans** address safety concerns centering around such potential disasters as fire and earthquake. For example, students and staff regularly practice "duck and cover" (earthquake) and fire drills. Each school maintains emergency supplies consistent with a District-wide standard. School building codes are at the highest standard of all facilities throughout California.

Schools also are prepared for such possibilities as unwanted intruders to the school campus. Schools collaborate with City staff through *Code Red* training in response to intruders.

**Safe School Plans** address school climate safety issues to ensure a harassment-free environment for our students; e.g., not allowing bullying, sexual, or racial harassment.

Currently we are particularly concerned about traffic safety around our schools. Each school has developed safety routes for dropping off and picking up students. We are working in collaboration with the City of San Jose Police Department to ensure that traffic laws are obeyed around schools.

We ask all of the VEP community to be especially careful when driving around schools during the peak starting and ending times in the morning and afternoon.

# Gunderson High School happenings

-Cary Catching, Interim Principal I am pleased to share with our community some of the exciting events that are happening at Gunderson High School this year.

Gunderson was recently awarded a Federal Magnet Grant along with several other schools in our district. The purpose of this grant is to refine and increase innovative technologies in the arts and sciences. The ultimate objective is to increase and stabilize the school's enrollment, thus creating an exciting, active, and engaging learning community. To this end, we will be increasing our recruitment efforts beginning in January by inviting 8<sup>th</sup> graders from across our district to attend informational meetings and tours on site.

Gunderson's leadership class has been actively engaged in beautifying our campus. Most of the work has been to the internal open areas, including cleaning out trash and dead brush, prepping the ground for planting, and creating student-centered areas for posting informational flyers and bulletins. They've also applied for two grants through the City of San Jose in an effort to increase these beautification opportunities.

# Local business complaints

There are very few state or local laws governing a business' operating practices or policies. For instance, no businesses are required to issue rain checks or to accept returned merchandise, unless defective. Businesses are free to set their own return policies, but should have these policies posted if the business doesn't offer a full cash refund.

It's smart shopping to ask about the store's return policy before making any purchase. If a clerk or manager offers you an exception from the posted rules, be sure to get it <u>in writing</u> before leaving the store.

To file a complaint about a local business in Santa Clara County, including false advertising problems, write to the Consumer Protection Unit of the Santa Clara County District Attorney, 70 W. Hedding Street, San Jose, CA 95110. As may be appropriate, you can also check with Consumer Mediation Services, (408) 792-2880, or Small Claims Court Advisory, (408) 792-2881.

Complaints may also be registered with the local Better Business Bureau. In Santa Clara Valley, the BBB is at 2100 Forest Avenue, San Jose, CA 95128. (408) 278-7400. A wise shopper will contact the BBB before patronizing a local business to see if there's a pattern of complaints.

# Salts in potting soil steal nutrients

-John marks, VEP's Green Gardener If you have planted strawberries or other crops in a barrel, you may notice the berries getting small, or the leaves turning brown. This may happen even though you water frequently and feed with *Miracle-Gro* and sulfate of ammonia.



The problem is that many potting soils are high in salts. This causes burning of leaf edges. It will also lock up nutrients, and

plants slowly starve, as indicated by small berries. Try mixing two to three tablespoons of vinegar in two gallons of water and pouring the solution into the planter. This will counteract salt buildup in the soil.

A couple of days later, pour a solution of Miracle-Gro

and water into the planter. You will have to live with the burned edges for a while, but if you do this a couple of times a year, whatever you are growing will do better.

#### Veggies that lose moisture

Although your harvest of cucumbers and other fleshy veggies yield large, healthy, and impressive results, they may lose their firmness, becoming limp after six to ten hours. Cleaning and storing at refrigerated temperature will not help.

The problem is that all fleshy vegetables lose moisture within a few hours after picking, some faster than others. Commercial growers cover their crops in wax right after picking to retain moisture before sending them to market. You are doing nothing wrong, it's just the nature of the veggies; just don't pick them unless you intend to eat them soon after.

#### **Trimming Rhododendrons**

Rhododendrons that are planted in the yard may become overgrown need to be pruned in the winter or early spring. But severe pruning without preparation can destroy blooms next year.

To rejuvenate an old, leggy Rhododendron, first feed and water the plant in the summer so that it is strong and healthy, and able to withstand severe pruning. In the winter cut one-third of the old limbs to 8-12 inches from the ground.

The following year, cut off an additional one-third of the old stems; a year later cut down the last third. This may take about four years, but you'll retain some flowers every year.

Try to find old growth rings and make your cuts above one of these. New shoots will emerge from these growth rings. If the Rhododendron is too old and growth rings are not visible because of the bark, make the cuts 12 inches from the ground and hope that new growth will emerge from the hidden growth rings. Or, you can severely prune the entire shrub now, but it may be a few years before any flowers are seen.

#### Bulbs go in NOW

There is still time to plant spring-flowering bulbs. Most nurseries and garden centers remain well-stocked with dozens of colorful selections. To help you plan your garden, check out www.bulb.com for a wealth of information and tips about how to choose, plant, and otherwise care for your bulbs. That site is maintained by the Netherlands Flower Bulb Info Center (where else?).



Once you get those bulbs in the ground, give yourself a little instant gratification by planting winter-color annuals on top. Good choices for sunny spots include pansies, violas, primrose

and Iceland Poppies. For shady or dappled spots, try cineraria and cyclamen.

# Help wanted: pruning Chynoweth palms

We prune the 161 palm trees on Chynoweth Avenue in January and July each year. This job typically takes approximately 24 manhours. My side-kick Frank won't be able to help me this coming January, so I'm asking for volunteers.



This job can be scheduled around whatever days/times are convenient for those involved. My preference is for the weekends of January 8-9, or 15-16. Needless to say, if there are more than two of us, we'll be able to finish in one weekend. Volunteer for as much time as you can give. Any amount of help you can offer will be appreciated; it's okay if you have to leave before the job is done.

It's nice and cool in January, so mornings or afternoons qualify. We can work as a team or individually. A twoperson team is best, as one person can cut fronds while the other stacks them in piles.

Traffic is a potential hazard, so we don't want youngsters working in the street median without parental supervision.

What's needed? If done by hand, a sharp, aggressive, saber-type pruning saw works best. If we can get a motor-generator and reciprocating electric saw donated, that's even better. Now that some of the trees are getting taller, we also use a ladder, which I can supply. Gardening gloves (VEP can supply these) and a longsleeved shirt are a MUST, as the saw-toothed edges on fronds can otherwise result in nasty scratches and puncture wounds.

I will do a quick training demonstration the first day. We cut fronds close so they won't impede future pruning and the tree trunks look uniformly like pineapples.

# Traffic congestion standards under fire

-Dave Fadness In 1975, the citizens insisted on imposing a traffic level of service (LOS) standard in San Jose's original General Plan as a way to assure that urban development did not diminish our quality of life. That requirement is also reflected in adopted city council policy.

Simply stated, the impact of any project that reduces the traffic level of service below LOS "D" must be mitigated. LOS ranges from "A" (no congestion or delays) to "F" (gridlock). LOS D exists when an intersection is operating at 90% of its theoretical capacity, or when average stopped delay times range from 28 to 37 seconds.

This LOS standard typically shifts the cost of transportation improvements onto new growth. In effect, it provides the city with a revenue source for the infrastructure



needed to support growth, protecting urban services for existing (and new) residents. It also gives the city the ability to deny or reduce their size of projects that would violate this measurable congestion standard.

Politicians typically do NOT like measurable standards. Maintaining LOS D has been a contentious issue from day one.

Under constant pressure from developers, exceptions have frequently been allowed. Downtown and the Golden Triangle industrial areas, for example, have been designated as special development zones, wherein LOS D is either waived or based on overall averages. This means that development can go on unimpeded despite traffic gridlock.

And the council is NOT prohibited from a finding of "overriding need" for a given project, thereby side-

stepping LOS D policy. This, in part, may answer your question why traffic seems to keep getting worse, despite having a LOS D requirement on the books for 29 years. It's policy, <u>not</u> law.

Now being proposed is a sweeping change in traffic LOS policy. It's an outgrowth of what is now being heralded as "Smart Growth", and is based upon the newly-

launched theory that maintaining LOS D is itself a negative impact. In order to swallow this, you have to accept several assumptions: (1) that development (especially high-density development) absolutely MUST occur, (2) that the council can't say "no", (3) that the only way to mitigate traffic is to build wider streets and roads, (4) that arterial street traffic will somehow dissipate without impact via adjacent neighborhood streets, or (5) that many of us will eventually just give up our cars and start using public transit.

Specifically, under the proposed new policy, thirteen major intersections in San Jose will be "protected" from the LOS D requirement. Others may be added at council's discretion after an environmental impact report (EIR). Exceptions may also be applied to other impacted intersections if traffic mitigation means limiting right-of-way for public transit, reducing pedestrian walks or bicycle lanes, or imposing 'undesirable aesthetic' changes.

A draft EIR has been prepared to evaluate the effects of this proposed policy change. It is available for public review; call Environmental Project Manager Janis Moore at (408)277-4576 or email janis. moore@sanjoseca.gov and ask for a copy or information on "Modifications to the City of San Jose's Transportation Impact Policy."

To allow time for public input, the city has extended its EIR comments deadline and hearing schedule, as follows:

• December 2 = Community meeting in the evening (time to be announced) in the council chambers at city hall;



- December 6 = Deadline for written comments on the EIR (close of business day);
- January 26, 2005 = Planning Commission meeting (time to be announced) in the council chambers at city hall; recommendation to city council;
- February 15, 2005 = City Council meeting (time to be announced); final decision on policy.

Watch for time/date announcements in the Mercury-News. We will attempt to get update VEP members via email. We plan to write a formal response and will post it on our website, www.vepca.org.

# Capitol Expressway median trees

Trees in the Capitol Expressway median, Snell to Narvaez were trimmed recently by our volunteer *phantom pruner* (not by the County).

The presence of overgrowth, heavy masses of olive-like fruit, and strong winds during an October storm combined to break limbs on many of these sadly neglected trees. Two newly-planted trees east of Vistapark Drive had also been struck by an automobile.



Pinn Brothers Construction (*Bella Villagio*) is in the final process of obtaining permits from County Roads to complete their work, planting trees and applying wood-chip mulch to the median, from the Snell end to Copper-field Drive. They will also take on maintenance. This is being done at the request of VEP.

# VEP history in a nut shell: 1996 – 1999

The following is another in a series of summaries of VEP history taken from our newsletter archives. This summary covers 1996 to 1999. VEP is scanning archived newsletters and making them available on-line at the VEP web site www.vepca.org.

**1996** New City Councilmember **Pat Dando** proposes using the competitive process as a tool to provide better city service at lower cost. City proposes 4-phase development of Vista Park. \$250K Phase I ground breaking occurs in May.

Pac Bell rolls out plan to wire the neighborhood with fiber optic cable at January meeting. VEP plants an additional 120 palm trees in the Chynoweth median in March. City imposes fines of \$50 to \$75 for putting yard waste out more than 24 hours before pick-up. VEP opposes \$4.45M city subsidy for Eden affordable housing project at Ohlone-Chynoweth light rail station after finding out that this project is planned in addition to the Bridge housing project (not opposed by VEP) at the corner of Chynoweth and Winfield. Costco opens in Almaden Plaza. Dando calls for better community outreach for housing projects.

Parkview Valley and Echo Valley developer, **Ed Rosenbaum**, dies. VEP election forum features pro and con speakers for nine ballot measures, three each from the city, county, and state.

**1997** Councilmember Dando speaks at January meeting. VEP co-hosts county supervisorial election forum with AVCA, Pinehurst, and Thousand Oaks. City recognizes VEP as an Outstanding Volunteer Group. VEP begins 1997 with about \$3800 in its treasury.

City passes less restrictive "group home" ordinance to conform with State law. Earthquake insurance increases 3x over previous year. VEP celebrates Vista Park Grand Opening (completion of Phase I development) in May. VEP has first Dumpster Day in conjunction with city, ridding the area of 810 cubic yards of junk. VEP Vice President, **Mark Schoenberg** put VEP on the World Wide Web.

City Planning Commission and City Council approve (7:3) Eden Housing Project despite VEP protest. Newly elected County Supervisor, **Don Gage**, speaks at May meeting. **Jake DeHaeseleer** and **Josie Supencheck** named District 10 Outstanding Volunteers of the Year. **Andrew Hitchcock** (Gunderson) and **Saul Verduzco** (Hill) win \$750 VEP Community Service Awards. Past VEP president, **Sally Hess** graduates Summa Cum Laude from San Jose State. VEP begins lobbying for completion of Parkview 3 Park. 2nd term VEP President **Jane Elkins** moves from VEP; VEP secretary, **Jasmine Ocegueda** steps in to fill her spot.

Assisted Senior Living facility plan for Vista Park Drive and Branham presented at September meeting. VEP endorses plan. Lester property park plan shared with VEP at October meeting; wins overwhelming VEP endorsement.

**1998** California deregulates electricity. Parkview 3 Park gets new playground equipment. Mercury News writer, **Gary "Mr. Roadshow" Richards** speaks at February meeting. City considers changes in parkland dedication fees. San Jose Airport Traffic Relief Initiative placed on ballot, to force traffic and transit improvements before airport improvements are completed; sponsors negotiate traffic relief measures with city and actively campaign against the initiative.

VEP, Pinehurst, and Thousand Oaks co-sponsor Mayoral Candidates forum with candidates **Ron Gonzales**, **Kathy Napoli**, **Bill Chew**, and **Pat Dando**. VEP opposes building of a bridge over the Chynoweth percolation ponds to mitigate traffic for a proposed high density housing and retail Arcadia development at Almaden and Chynoweth; Planning Commission (5:0) approves project EIR. **Jill Carter** and **Jay West**, both of Gunderson win \$750 CSAs; Hill submitted no nominees. Nine Gunderson seniors selected for the Santa Clara County Youth Hall of Fame. VEP negotiates deal with property owner to leave a perimeter of walnut trees at Vistapark and Branham. VEP member **Gay Brasher** named SJUSD Teacher of the Year. City approves 67 single family homes on 7.4 acres at Branham and Pearl (old Lucky supermarket site).

**1999** City enacts storm sewer and garbage collection tax increases. PG&E presents at January meeting. The SP Lick Spur crossing of Narvaez rezoned to allow building of two single-family homes. City broadens Chynoweth Ponds Bridge traffic study at VEP's request. Members approve dues increased from \$12 to \$15.

State Assemblymen **Mike Honda** and **Jim Cuneen** speak at March meeting. Gunderson receives \$400K BASRC Digital High School grant. Police Chief **Bill Lansdowne** speaks at April meeting. Arcadia withdraws application for high density housing/retail development at Chynoweth and Almaden, eliminating need for Chynoweth Ponds bridge.

**Edith Lester** dies in April. Eden Housing receives full funding. SJUSD considers moving Broadway Continuation School to Gunderson Campus; settles on relocation to Muir Middle School campus after opposition from VEP and Gunderson's PTSA. One Hill and 13 Gunderson seniors honored at Santa Clara County Youth Hall of Fame. City enacts \$250 fine for violating yard sale sign ordinance.

Andrew Pew (Gunderson) and Mariah Rayes (Hill) win \$1000 VEP CSAs. Muir Middle School designated California Distinguished School. VEP holds first Community Garage Sale. A General Motors EV1 electric car shows up in the neighborhood. VEP endorses General Plan changes to Single Family Residential for 10 acres at Vistapark and Branham; removal of Chynoweth and Vistapark rights-of-way through Lester property.

VEP has second Dumpster Day with *Neighborhoods First!* removing 800 cubic yards of stuff. City approves \$1.6B budget. VEP takes no stance on the Calpine Power Plant after presentations by Calpine and Santa Teresa Community group. City enacts ordinance on front yard paving. City approves low income senior housing project at Capital and Vista Park Drive.

It was an invitation to attend a community meeting concerning development plans for Vista Park. # VEP's October general meeting summary -Ginger Cardona, VEP Secretary

Superintendent **Manny Barbara** shared Oak Grove School District's (OGSD) priorities and concerns with our members. (See their website www.ogsd.k12.ca.us.)



OGSD has 11,600 students in 19 elementary and middle schools. OGSD students graduate into the Eastside Union High School District.

Safety is the number one priority. All schools have emergency and safe school

plans. These deal with intruders and code-red training.

Oak Grove has the highest number of eighth graders in algebra for the entire state. The API target score is 800. The district started with one school meeting this criterion, and now has eight. There are 14 California Distinguished schools.

Like other school districts, budget cuts have affected OGSD. Owing to budget cuts and no growth in student population, two schools had to be closed two years ago. The school district expects to loose 600 students over the next three years.

The Humane Society has opened a new shelter. **Christine Benninger**, president of the Humane Society was there to explain the benefits and functions of this facility.

Six years ago, the Humane Society worked with the cities to discontinue providing animal control. The cities would then provide their own animal control and the Humane Society would provide strays, lost and found, animals, which must be confined, or be held due to legal issues.

The Humane Society will now focus on placing animals. Still in transition, they still perform some functions which will be turned over to the new shelter. The Humane Society is looking to build a new facility in Milpitas, close to the Great Mall. That shelter should be complete in 2 years and will include an educational center, boarding, grooming, vet center, and an adoption community center.

**Cary Catching** is the interim principal at Gunderson High School. Her updates revealed that student enrollment is currently at 1072, an increase from 2% over last year. This year, Gunderson has 12 new teachers in a variety of subject areas. All teachers are accredited in their subject.

Congratulations are in order for Gunderson as it has just been through an accreditation process by Western Association of Schools and Colleges. They were given the second highest level possible, a six-year accreditation with a three-year review.

San Jose Unified District was awarded a federal magnet grant for seven schools working to become art and science magnets. Gunderson is one the schools to receive the benefits. Some of the money will be used on recruitment of students.

Using Measure C and F funds, San Jose Unified (SJUSD) school facilities upgrades continue. **Ty Wil-liams** and **Susan Davenport** attended to give us an update on their program.

<u>Gunderson</u> - The stadium is scheduled to be completed by the end of November. The old portables are scheduled to be replaced. Specialized instruction changes for measure F will begin soon. These changes include computers, wireless networks, and a new building. White boards will be installed. Stage curtains will be replaced. There is a second phase of field upgrades to handle the baseball and softball fields. In addition, shower and locker rooms were just completed and restrooms are currently being renovated.

<u>Carson</u> – Kitchen renovation is complete. A central kitchen will now provide lunches for all District schools, so Carson's kitchen was modified to install warming equipment. White boards have been added to all class-rooms for elementary schools.

<u>John Muir</u> – Underground utilities are being upgraded. Restrooms are scheduled for renovation. Shower and lockers rooms will also be renovated. White boards will be added to all classrooms.

<u>Steinbeck</u> - Steinbeck is currently scheduled to have its showers and locker rooms renovated. White boards were installed in classrooms. Measure F provides specialized instruction needs for its being a technology magnet.

<u>Pioneer</u> – Renovations, including the fire rebuild, are currently being designed. The football field has been completed and is now wider to accommodate field hockey and soccer. Specialized instruction program includes upgrades to the science lab. In addition to HVAC and underground utilities upgrades, all classrooms will also have white boards.

#### \* \* \* \*

**Veronica Lewis**, SJUSD Board Trustee for our area, discussed the difficult subject of schools closures. Closures are inevitable due to declining enrollment and budget shortfalls. SJUSD has a \$9M shortfall.

Over the last five years, enrollment declined 1500 students. When declining enrollment reaches a 75% mark, a committee is automatically formed to review school closures. Three schools will be closed next year; two elementary and one middle school.

There are a number of factors being reviewed with each school. These include the number of students being displaced, transportation of students to schools, available facilities, and possible leasing of schools property, among many others. A final decision is scheduled for December 9<sup>th</sup>. Please reference the web site www.sjusd.k12.ca.us for a current listing of meetings.

E = Encore (and Echo Valley); and


P = Parkview Valley.


