Kim Gaddis, Program Manager for the San Jose Police Department's *Neighborhood Watch* program will be our first speaker. The goal of *Neighborhood Watch* is to take crime prevention tools and techniques down to each neighborhood by individual block. Those interested in developing a block program will be encouraged to do so.

This program is being presented in response to concern regarding recent break-ins in cars, garages, and homes within the VEP community.

- ▶ Ben Angeleris, Board Member for San Jose *Crimestoppers* will provide an brief overview of how successful this crime reporting program has been. He will give us local contact information, and a description of how their anonymous cash reward system works.
- ▶ VEP presentation to honor Captain **Jack Farmer**: 'Captain Jack' will be retiring from the San Jose Police Department at the end of this year. VEP is pleased to thank him publicly for his excellent service to the members of the VEP community as well as the greater community of San Jose.
- ▶ Presentations and updates by San Jose Councilmember Nancy Pyle and Santa Clara County Supervisor Don Gage: Our elected officials will provide us with an update on issues pertinent to the residents of the VEP community.

Neighborhood Alert

There have been several break-ins in the VEP neighborhood
(particularly around Holycon/Branham and Bluefield/
Rosenbaum areas) consisting of car break-ins, garage breakins, and at least one home break-in. In addition, other
neighboring communities are also reporting similar break-ins.

One example was a group that used a contactic to enter the home of an elderly woman and then robbed her. She lives near Foxworthy and Almaden.

Should someone knock on your door long and loud, and then ask for someone you don't know, call 911. This could mean they

are checking the house to see if it is clear to rob. By calling 911, you may help the police solve open robbery cases by getting a name to match fingerprints collected at unsolved thefts.

Please be alert to any suspicious activity in our neighborhood, and report it!

Fraud alert

San Jose Police Department's Burglary Unit is investigating several reports of burglars impersonating Water District employees when contacting senior citizens at their homes. These impersonators say they are with the water district, doing work in the area due to problems with water lines.



Perpetrators say they need to do water tests. Typically, they will ask the victim to perform some task in one part of the house or yard while going to other parts of the house and burglarizing it. The thief then flees after taking money, jewelry, passports, guns, and/or other small items.

Do <u>not</u> allow any unscheduled visitor, repairman, or "company employee" of any type into your home. Call 9-1-1 immediately to report any suspicious person, vehicle, or activity in your neighborhood.

My opinion: Development at Capitol-Narvaez

40,000 riders per day. That's what overly-optimistic transportation planners forecast in 1981 for first-year Guadalupe light rail patronage. It was to be a stunning success, the basis for a new urban way of life in Silicon Valley, an economic and fiscal boon, a beginning to the end of traffic congestion and urban sprawl.

Transit planners designed accordingly, building the Guada-

lupe system and buying light rail vehicles to support that expected glut of users. Expensive park-n-ride lots were designed to accommodate hundreds who would leave their cars behind as they whisked, free of congestion to work and shopping destinations each day.



More miles have been built and cities have boosted zoning densities wherever possible to "support" our light rail investment. But after eighteen years since the grand opening of service, we're still waiting for anything like the predicted ridership to materialize. Traffic congestion is unabated. Large, mostly empty parking lots sprout weeds and invite leased use for storage by auto dealerships and construction companies.

Reality has re-established itself: Californians *do* love their cars, and are perfectly willing to pay for public transit services they hope other people will use. Despite billions invested, as a percentage, growth in transit ridership hasn't even kept pace with increases in our valley's population.

VTA appears to be admitting this sad turn of events.

VEP members will recall that 535 housing units were built at the Chynoweth-Ohlone Light Rail Station a few years ago. 195 of them replaced much of the park-n-ride lot there. Now, perennially cash-strapped VTA is proposing urban development on the south park-n-ride lot at the Capitol Light Rail Station.

Before Pat Dando left the city council, she approached us with a proposal to build senior housing on the Capitol park-nride lot. In exchange for community support, the city would require that a small park be built on the north side of Bridget Drive, between Narvaez and Canoas Creek. Neighbors objected. The idea went silent—or so we thought.

It's now being reconsidered. VTA requested and now has two detailed proposals from developers. Both will use the entire park-n-ride lot south of Capitol Expressway and the adjacent 2-acre county-owned parcel immediately south of it. This is what is being proposed for the combined 8.9-acre site:

Bridge Housing: 23,000 square-feet of retail plus 380 residential units. Their proposal includes the small park on Bridget Drive.

Avalon Bay: 10,000 square-feet of retail plus 628 residential units. No park is included in their proposal.

Residential units would be a mix of rental apartments and owner-occupied condominiums. Buildings will be four stories

tall. (As proposed, both projects would exceed the scope and density of the 355-unit, 14.9-acre *Bella Villagio* complex on Capitol Expressway at Vistapark Drive.)

All that will remain for those who drive to this transit station is the small lot on the north side of Capitol.

VEP has long-standing, major concerns about the impacts on traffic congestion and safety of *any* development at or near that site. Here's why...

The ramp meter on the northbound Route 87 approach causes a traffic nightmare at Capitol/Narvaez <u>every</u> workday morning. Westbound traffic backs up on Capitol past Home



Depot. Eastbound traffic often backs up across Capitol itself as commuters attempt to turn left onto Narvaez, which is grid-locked in both directions from the freeway approach. More than just inconvenient, the situation there is dangerous.

No one is proposing a solution; the city just keeps adding cars by approving more high-density ("smart-growth") development. In fact, by way of twisted logic, the city's official stance is that the level of service at the ramp meter is "B" (much better than the minimum acceptable "D"). That assertion clears the way for more growth--without any requirement for traffic mitigation. VTA takes the city's word for it. We suffer the consequences.

VEP is not opposed to growth. We are opposed to growth that makes conditions worse in our neighborhoods and city. To reflect that spirit, for several years VEP's member-approved *Goals & Objectives* have included these specific directives:

Monitor opportunities for improvements in traffic level of service at Capitol/Narvaez/northbound 87 onramp.

Work with the City to ensure that impacts of any proposed high-density development along the Guadalupe Corridor are fully mitigated.

Our G&O have been distributed to elected city and county officials, so these concerns should be well-known to key decision-makers. We've also drawn from these points repeatedly in letters and public testimony regarding development proposals in our area. So far, our pleas have gone unanswered.

If VTA removes all but the north parking lot, virtually all options may be foreclosed for traffic relief at the ramp meter—unless they're willing to give-up the north lot, as well. All that could be done otherwise is to move the freeway approach farther north along Narvaez. However, doing that could run afoul of Caltrans' requirement for one-mile separation between freeway approaches; Curtner is only 1.2-miles from the existing onramp.

What we're saying is this: Go ahead with whatever you want to do at the Capitol Light Rail Station, VTA, BUT first show us a plan and secure funding for a solution to the northbound Route 87 freeway approach problem.

After all, improving transportation is what we pay VTA to do.

mission at its November 1st meeting.

- County and State Parks & Recreation staffs met on September 12 to discuss environmental reports and documents required by the California Environmental Quality Act (CEQA), project coordination and management, and their respective general plans for Martial Cottle Park development.
- A request for proposal soliciting master planning consultants closed on October 20. A total of seven consultants bid on the project. The RFP process included a tour of the property by prospective consultants in mid-September. Interviews of consultants that submitted RFPs are scheduled for mid-November. County Parks plans to forward a contract for a planning consultant to the Board of Supervisors for approval in early 2007. Master Planning is slated to start in early spring 2007 and be completed by March, 2009.
- The County and San Jose's Department of Public Works are still negotiating the right-of-way needed for Branham Lane widening. County Parks very recently received a draft agreement from the city.
- The County is working with San Jose Parks, Recreation, & Neighborhood Services staff on the planning of a community gardens (and access to the property for that purpose). Consultant selection for the production of design and development documents for the gardens should be done by the end of November, with a project start in early spring 2007. The community gardens development will happen well in advance of master plan completion.
- Martial Cottle Park planning is budgeted (through the Park Charter Fund and a grant from the Santa Clara County Open Space Authority) and is moving ahead, despite the County's projected \$200-million general budget shortfall.

Beautification planned for Branham-Narvaez

VEP applied for a San Jose Beautiful grant to round-out the funding we need to install irrigation, plant 33 trees, and apply mulch on the empty, barren lot at the corner of Branham Lane and Narvaez Avenue.

This will be a volunteer project, so your help will be needed.

We've had great success so far. The city prepared the landscape plan, selected the tree species, and agreed to install

water service for us. *Our City Forest* is donating the trees. Browning-Ferris Industries is donating and delivering 165 cubic yards of wood-chip mulch. With a grant from San Jose Beautiful, all the pieces will be in place...



The rest is up to us.

Proposed dates for this project are two Saturdays and Sundays, January 20 & 21 and/or January 27 & 28. If we get plenty of volunteers, this big job will be quick and easy for all of us. You don't have to be there both days or both weekends, and we'll be happy to have you join us even if it's for only a few hours. Please set aside some time for one or both of those weekends—and let me know which will work best for you.

-San Jose Councilmember Ken Yeager ~ Remove blight, recycle automobiles ~

As part their towing service contract, tow company operators have agreed to assist the City and the public with the voluntary surrender of unwanted vehicles. The contracted tow

companies have agreed to remove and dispose of relinquished vehicles at no cost to the registered owner or the City. This is an opportunity for homeowners who have an unwanted vehicle in their front yards or on the street to have that vehicle removed.

For more information, call Code Enforcement Division at (408) 277-4528 and ask for the "Voluntary Tow Program". The vehicle must be free of all liens and loans and you must have the pink slip.



VEP endorses fundraising for Pearl Library

At our October meeting, VEP members unanimously adopted fundraising efforts for Pearl Avenue Library enhancements.

Groundbreaking occurred September 30 on our new 14,000 square foot facility, expected to be completed in May, 2008. Although its construction is paid for by a general obligation

bond voters passed in 2000, that source of funding cannot legally be used to buy interior fixtures, furniture, or equipment. City revenue for those purposes is being used, but there isn't enough to supply the full needs of an ambitious program that will build twenty branch libraries city-wide.



A non-profit citizen group, the *San Jose Public Library Foundation* is asking the community served by each new branch library to help raise funds to fill the unmet needs for its own library. To get the job done right, to make your own branch library the best it can be, they're appealing for tax-deductible donations from citizens like us.

Did you get your flu shot?

If you haven't already gotten your flu shot for this year, it isn't too late! This is the single most important action you can take to protect yourself and your family from the flu.

Each year several thousand people die from the flu, so help protect yourself and decrease the spread of the flu to others by getting a flu shot.



If you are in a high risk group, it is even more important for you to get a flu shot. High risk groups include: people over the age of 60, healthcare providers, those of you caring for an elderly or chronically ill individual, and those of who have a chronic illness.

As concern about the potential for a pandemic flu increases, Centers for Disease Control, and other healthcare agencies are highly recommending that all adults and teenagers have yearly flu shots. The usual yearly flu shot will not protect you from a pandemic type flu, but does decrease the likelihood of a flu virus's ability to continue to adapt (particularly the severe type--like Bird flu--and then be able to spread from human being to human being). Of course, as with all healthcare interventions, it is always best to check with your own healthcare provider/physician in determining any special considerations that may apply to you.

This year, ample supplies of the flu vaccine are available. It usually takes 2- to 3-weeks following immunization for your body to develop adequate protection. The recommended timeframe for having a flu shot starts during the first part of October and extends through the first of January--the sooner the better.

Additional recommendations for avoiding flu and colds this season include: get plenty of rest, eat lots of fruits and vegetables, wash your hands often, use tissues for coughs and sneezes (and offer tissues to others), and stay home when you are ill.

Here's to a happy and healthy (flu-free) holiday season!

Update on Chynoweth traffic calming efforts

Following presentations and discussion on traffic calming at our September VEP meeting, the San Jose Department of Transportation (DOT) agreed to develop conceptual drawings for VEP to see and evaluate. These drawings will focus on possible additional options to decrease speed and increase safety along Chynoweth Avenue, between New World/ Gaundabert and Pearl.

These drawings will allow us to visualize one or more configurations of a single lane on that stretch of Chynoweth. Bike lanes will also be included along Chynoweth for both single and double lane options.



Following VEP's October Executive Board meeting, we requested that DOT also complete another traffic monitoring study. Our intent was to measure possible effects of an increased number of drivers (as the original study was done just as school was ending for the Summer at Gunderson), and to de-

termine how effective the newly implemented traffic calming measures have been. DOT agreed to do so.

To date, it appears that overall speed of drivers along this route <u>has</u> decreased. However, many drivers are becoming used to the electronic speed monitoring signs, and are ignoring them. Please continue to be good role models and <u>slow down</u> along this dangerous stretch of road!

After the New Year, information and proposals being developed by DOT will be presented at a VEP meeting for our consideration and approval.

Street Smarts traffic safety

Over half of the children who died last year in Santa Clara County died as a result of traffic-related crashes. Motorist actions such as red-light running, stop sign violations, and speeding are the leading behaviors contributing to this somber statistic.

It also allows her to enjoy the beauty of the big fields, the wildlife, and the view of the mountains—taking her back to her farm life roots in North Dakota.

Potholes have you in a rut?

A recent survey disclosed the fact that San Jose streets and roads are in the worst condition of all U.S. cities studied. That came as no surprise to VEP members. Our streets have crumbled noticeably in recent years and it seems like nothing is being done to correct it.



If anything, the schedule for periodic maintenance is being stretched on the city's 2,260 miles of streets, adding more years between cost-effective surface repairs that prolong pavement life. The result will be disastrous; deferred maintenance will mean

that many streets and roads will fail prematurely, then need to be torn up and reconstructed. Reconstruction is very expensive and money seems always to be in short supply.

The costs of delaying maintenance are borne by taxpayers in more ways than one. Beyond street repair and reconstruction, we also pay on an ongoing basis to repair our cars. Shock absorbers, tires and wheels, front-end alignments, and other auto suspension repairs caused by bad pavement conditions can be very expensive. We also pay in time spent getting those repairs done.

What can we do? First, promptly report any problems you encounter. If those in charge don't know about a problem, you can bet it won't get fixed. Don't assume they already know about it or that someone else will call. The squeaky wheel principle applies: drawing more attention to a given problem increases the likelihood that action will be taken to correct it.

If there's a pothole or failing street surface in your neighborhood let the city know by calling Central Dispatch at (408) 277-4373 during regular work hours. You can also call the city's customer center anytime day or night at (408) 535-3500. Be ready to identify the address or location of the problem.

According to their website, San Jose has two city-wide pothole patch crews that respond to priority complaints within the next day after they are received. These crews are radio dispatched and carry cell phones.

If the problem is on a county road or expressway, call County Roads at (408) 494-2750. For freeways or state highways, call Caltrans at (408) 436-0930.

Second, after you've called in the problem, let VEP know

about it by calling or emailing me or anyone listed on the mailing page of this newsletter. We'll compile a list and submit it to the department and elected representative(s) of the appropriate jurisdiction.

Finally, if your car is damaged as a result of hitting a pothole, file a damage claim against the agency (city, county, etc.) that's responsible for the street or road. Please note, however, as reported in Dennis Rockstroh's November 5 Mercury-News Action Line column, "Jurisdictions are not responsible for damage caused by lack of road repair unless the pothole or other damage had been reported to the [responsible agency]."

Obviously, calling to report a street repair need is important, both to get the problem fixed and to get help fixing your car if it's not.

<u>Branham Lane widening project</u>: The City Attorney's Office has finally transmitted a draft right-of-way land transfer agreement to the county. Staffs of both agencies are still working through some of the details—evidently a very complicated task.

After the city and county approve this agreement, environmental and preliminary design processes can begin. City staff assures us that VEP's input will be sought.

If you are interested in joining VEP's Branham Widening Committee, call me at 578-6428. Meetings with city staff will resume soon after the land transfer deal is formally approved.

<u>Snell Avenue widening project</u>: County staff has been speaking to Walter Lester on several issues, including setting a meeting with him and city staff to discuss getting right-of-way now for his Lifetime Estate frontage on Snell.



Median island landscaping on Vistapark Drive: VEP has been working for more than a year to have the landscaping completed on Vistapark Drive, just north of Capitol Expressway. Trees were planted there, but the cobblestone treatment used on other median islands to the north was never completed on this short segment.

San Jose Public Works (PW) is now saying that developers Pinn Brothers Fine Homes and KB Homes have no obligations for any additional work on this median island—andwe're told that the city doesn't have the funding to finish this job. PW is working with the Department of Transportation (DOT) to see what is required to give this median a "finished" look. If a solution is available, they promise to let us know.

<u>Chynoweth Avenue traffic calming</u>: Per our request, San Jose's Department of Transportation is now preparing a drawing that will show us what changes might be made if Chynoweth Avenue is reduced to one lane in both directions between Gaundabert/New World and Pearl Avenue. Bike lanes will also be included.

This drawing will be discussed at a scheduled VEP meeting on Chynoweth traffic calming solutions (to be announced).

Neighborhood break-ins: Reports of home break-ins and vandalism continue in our southern San Jose neighborhoods. VEP is having a police department presentation on this subject at our November 28 meeting.

Meanwhile, please keep your doors locked and *always* be on the look-out for and report suspicious activities in your neighborhood. The best 24/7 defense against criminals is an alert and watchful community of caring neighbors who know each other.

clubs or groups, custodians, parents, and PTAs and PTOs of San Jose K-12 schools, public or private, are eligible to apply.

Mini-grants, ranging from \$500 to \$2000, are intended to foster school-wide and in-classroom recycling and other environmental actions and environmental education in San Jose's public and private K-12 schools.

It is intended that these grants help establish, maintain or expand on-campus recycling or composting programs or other sustainable environmental programs. Grants are intended for projects that work directly with and benefit K-12 students.

Although creative approaches are welcomed, these are examples of eligible projects:

- Purchase of supplies and equipment to promote recycling and other environmental programs on campus;
- Purchase of supplies and equipment that stress reuse and waste reduction, such as refillable water bottles and reusable lunch containers:
- Purchase of reusable promotional items made of recycled materials including posters, caps, tee-shirts, water bottles, mugs, school supplies, magnets, reusable lunch equipment.
- Purchase of student, teacher, custodian, school administrator and parent award items and award event supplies to recognize individuals or groups who were part of the program's success;
- Payment for environmental field trips, school assemblies, presentations, entertainment;
- Purchase of environmental education books, videos, DVDs, posters and supplies;
- Payment for teacher training;
- Purchase of materials to allow construction, planting and/or maintenance of school gardens including composting, worm bins, tree plantings, and native, drought tolerant, or non-invasive bulbs and plants:
- Purchase of litter pick-up gloves, tools, carts that enhance litter removal campaigns; and
- Other creative ideas, which would promote school recycling and go-green actions.

Mini-grants are funded jointly by San Jose Beautiful and the City of San Jose Go-Green Schools Program of Environmental Services.

This has been a good budget year for education. Our financial fortunes are very much connected to the economic health of our state. If the state economy is positive, education tends to benefit as well. As a result, we will be able to maintain critical District programs through the 2007-2008 school year.

Our Oak Grove School District budget priorities have focused on the following:

Maintaining our Class Size Reduction Program at 20-to-1 at arades K-3.

Maintaining our Extended Day Kindergarten Program at all our schools, one of only two districts in this county to do so. Maintaining our Visual and Performing Arts Program for all

Maintaining our Intermediate School Counseling Program, thanks to additional state funds.

Maintaining our Intermediate School- After School Sports Program.

This year's state budget follows years where school funding had been cut severely, leading to over \$4-million in budget reductions in Oak Grove District alone. We are extremely fortunate that our community has supported us with renewal of our Parcel Tax. Without the additional funds from the Parcel Tax, we could not continue to offer the high quality programs such as the ones just listed. Thank you!

Stadium lights at Gunderson?

Veronica Grijalva Lewis, SJUSD Board Trustee San Jose Unified School District will be working with our communities in a process to determine if stadium lights will be installed at our high school athletic fields. The opportunity for

evening activities can build strong community and school spirit, but we also realize there might be concerns the community wishes to bring forward.

San Jose Unified has a public engagement policy that encourages our stakeholders to have an active voice as the Board of Education attentively listens to your concerns while information is gath-

ered and addressed. We will keep you informed as we move forward with this process.

In compliance with California Environmental Quality Act (CEQA), during November the District will contract to have an environmental impact study conducted on the surrounding communities. Information will be gathered and a formal analysis and report generated.

The District will hold an administrative Kick-Off Meeting in early December to inform site administrators and athletic directors of the process, so they too can help keep the community informed.

Throughout December and into February, each site will hold two meetings with their communities to enlist their support and seek to understand and mitigate any concerns surrounding the installation of stadium lights.

There will be a Public Hearing at a regularly scheduled Board of Education meeting where once again community concerns can be gathered. If the school board approves stadium lights, installation would be completed by August 2007.

My hope is you will join me and others in our community as we begin the process of looking at stadium lighting for Gunderson. As your trustee, I will work with you, the district, and Gunderson's Principal Cary Catching to hear all concerns and ideas during this process. District 9 news

-San Jose City Councilmember Judy Chirco A groundbreaking for San Jose's newest dog park at Roy M. Butcher Park was held on Saturday, November 4. Roy M.

Butcher Park is located on Camden Avenue between Lancaster Drive and Oakwood Avenue.

Construction of the new Butcher Dog Park will complement the growing list of off-leash dog park facilities in other San Jose neighborhoods including: Jeffrey Fontana Park, Miyuki Park, Ryland Park and Los

Gatos Creek Park in Campbell. This dog-friendly park will be in the northwest corner of the 10-acre Roy M. Butcher Park.

Upon completion, canines and their owners will be able to utilize pet-friendly amenities including a double-gated entry, separate large and small dog areas, decomposed granite and artificial turf, benches, a community bulletin board, and a small shed for staff and volunteers to store supplies. The facility is designed to accommodate between 30-50 dogs at one time.

The \$566,333 project was funded by State Proposition 40 grant, Council District 9 Construction and Conveyance Tax Funds, and Park Trust Funds. Construction is scheduled to start in December, with the grand opening scheduled for June 2007.

City of San Jose street tree rules

At our February 28th general meeting, members enjoyed excellent presentations by San Jose city aborist **Ralph Mize** and *Our City Forest's* Director of Operations **Christian Bonner**.

Here's a quick reference to the rules regarding street trees:

PERMITS:

You need a permit to plant or trim a street tree

The permit is free

A permit is not required if you use a pre-approved tree service (see website below)

VERTICAL CLEARANCES:

8 feet from sidewalk to canopy

13 feet from street to canopy

PLANTING CLEARANCES:

See City Code #13.28.190, reprinted in the May 2006 VEP News (also available at www.vepca.org).

Do NOT top trees: The most universally important advice from our February meeting was the fact that topping trees is very harmful to proper tree growth and appearance. When a tree is topped, it is shocked into producing fast growth to the sides of the topped branches. Salts in potting soil steal nutrients

If you have planted strawberries or other crops in a barrel, you may notice the berries getting small, or the leaves turning brown. This may happen even though you water frequently and feed with Miracle-Gro and sulfate of ammonia.



The problem is that many potting soils are high in salts. This causes burning of leaf edges. It will also lock up nutrients, and plants slowly starve, as indicated by small

Try mixing two- to three-tablespoons of vinegar in two gallons of water and pouring the solution into the planter. This will counteract salt buildup in the soil. A couple of days later, pour a solution of Miracle-Gro and water into the planter. You will have to live the burned edges for a while, but if you do this a couple of times a year, whatever you are growing will do bet-

~ Veggies that lose moisture ~

Although your harvest of cucumbers and other fleshy veggies yield large, healthy, and impressive results, they may lose their firmness, becoming limp after six- to-ten hours. Cleaning and storing at refrigerated temperature will not help.

The problem is that all fleshy vegetables lose moisture within a few hours after picking, some faster than others. Commercial growers cover their crops in wax right after picking to retain moisture before sending them to market. You are doing nothing wrong, it's just the nature of the veggies; don't pick them unless you intend to eat them soon after.

~ Trimming rhododendrons ~

Rhododendrons planted in your yard may become overgrown and need to be pruned in the winter or early spring. Use care, as severe pruning without preparation can destroy blooms next year.

To rejuvenate an old, leggy Rhododendron, first feed and water the plant in the summer so that it is strong and healthy, and able to withstand severe pruning. In the winter cut onethird of the old limbs to 8- to 12-inches above the ground. The following year cut off an additional one-third of the old stems, and a year later cut down the last third. This may take about four years, but you'll retain some flowers every year.

Try to identify old growth rings and make your cuts above one of them. New shoots will emerge from these growth rings.

If the Rhododendron is too old and growth rings are not visible because of the bark, make the cuts 12-inches from the ground and hope that new growth will emerge from the hidden growth rings. Or, you can severely prune the entire shrub now, but it may be a few years before any flowers are seen.

~ Bulbs go in NOW ~

There is still time to plant spring-flowering bulbs. Most nurseries and garden centers remain well-stocked with dozens of colorful selections.

To help you plan your garden, check out www.bulb.com for a wealth of information and tips about how to choose, plant, and otherwise care for your bulbs. This site is maintained by the Netherlands Flower Bulb Info Center (where else?).

Once you get those bulbs in the ground, give yourself a little instant gratification by planting winter-color annuals on top.

Good choices for sunny spots include pansies, violas, primrose, and Iceland Poppies. For shady or dappled spots, try cineraria and cyclamen.

Taxpayers vs Open Space Authority

We still have a couple of weeks to file claims for possible refunds of Santa Clara County Open Space Authority's (OSA) property assessment taxes. Those taxes are shown as "990 Open Space Districts" on your County of Santa Clara Secured Property Tax Bill.

A lawsuit now before the California Supreme Court may find that assessment tax unconstitutional. If so, Silicon Valley Taxpayers' Association (the plaintiff) has asked that refunds be given to property owners and taxpayers, who may then elect

to keep them. However, OSA will likely argue it is entitled to keep and spend the taxes-unless individual taxpayers make separate claims for their own refunds.

Taxpayers need to be aware they may lose their rights to refunds if they do not file their own personal refund claims, even if the Su-

preme Court declares the assessment tax unconstitutional. Taxpayers will have a right to obtain refunds of assessment taxes paid within only four years prior to the date of a refund claim.

This means that, if a taxpayer paid the assessment beginning with OSA's first levy in 2002, his or her refund claim would have to be filed within four years of the date the taxpayer actually made his or her first payment of 2002 taxes, which were due on December 14, 2002 and April 10, 2003.

Refund claims would thus be due in early December 2006 for most taxpayers. Any taxpayer filing a refund claim later than that date would lose all or part of his or her refund.

Taxpayers need to file their signed original claims with the OSA at 6830 Via Del Oro, Suite 200, San Jose, CA 95119, making sure they ask OSA to stamp a copy of the claim form "filed" or "received" on a specific date. Taxpayers should keep a copy for the own records.

As a service to taxpayers, SVTA will supply claim forms prepared by its attorney that can be filled out, signed, and filed. Upon request, SVTA will also file the claims on taxpayers' behalf and keep copies.

SVTA's lawsuit is not about whether open space funding for parks and trails is a good or a bad thing. This lawsuit is about how open space and other government spending must be paid for under the California Constitution as enacted by the voters of our state, whether through general or special taxes approved by voters or through assessments on real estate for special benefits to particular parcels.

San Jose Police Detective, **Adam Tovar** of the Internet Crime Unit gave a very informative presentation of how crimes are perpe-

trated against children by online predators. He cited many examples of how these predators get the children to reveal personal information and how that information is used to seduce them into becoming victims of sexual crimes.

With the sophistication of information available on the Internet, and with a small amount of personal information, a predator can easily obtain the child's address, telephone numbers, and other information. The take-away message was, to make sure your children do <u>not</u> get give any personal information to <u>anyone</u> on the Internet.

For household batteries, fluorescent light bulbs and tubes, mercury thermostats and thermometers...

▶ Call the County's Household Hazardous Waste Collection Program at (408) 299-7300 to find free locations to drop these items off. OSH will accept fluorescent bulbs and Radio Shack will take household rechargeable batteries.

For computer monitors and TVs with cathode ray tubes, flat screen TVs (LCD and plasma)...

▶ Call Recycle Plus Customer service at (408) 535-3515 for a large item collection appointment. The current cost is \$23 for a full computer system or TV. Other recyclers may take these items without charge.


