With summer almost behind us and the fall and winter months ahead, it's a great time for new beginnings. We have an informative meeting planned for you this month...

▶ I'm sure you know of a family member, a friend, or a coworker who may need assistance. At our September 25th general meeting, Staff Attorney **Beatriz Lopez** from SALA (Senior Adult Legal Assistance) will speak on the basics of legal planning (e.g., wills and trusts), health care decisions, and directives for your future. SALA specializes in the following areas related to our elder population:

• PUBLIC BENEFITS: Social Security and SSI (except disability cases); Medicare and Medi-Cal; and In Home Support Services.

• LONG TERM CARE: Nursing Home and Residential Care issues; Alternatives to Institutionalization.

• ELDER ABUSE: Restraining or Protective Orders (for elder abuse or domestic violence); Lodger Statute Evictions; Revocation of Powers of Attorney (for fiduciary abuse).

• HOUSING: Landlord-Tenant; Subsidized/Senior Housing; Mobile Home Residency problems.

• CONSUMER: Medicare HMO or Supplemental Insurance disputes; Long-Term Care Insurance problems.

• INCAPACITY PLANNING: Advance Health Care Directives; DireHealth Care Powers of Attorney .

• PROBATE ALTERNATIVES: Death of Joint Tenant Affidavits; Small Estate Affidavits (valued at \$100,000 or less).

• SIMPLE WILLS: For elders with modest assets (available through SALA's No Fee Wills Panel).

▶ In addition, we will welcome back SJPD Captain David Cavallaro to give us the latest scoop and statistics regarding our area, to remind us how to protect our personal and real properties, and to address any concerns you may have. Please come and thank him. He attends our meetings on his off duty time because he's passionate about his work.

We will ask your input and vote on the following proposed G&O at our September 25th meeting. If any changes are adopted at that meeting, they will be published in our October newsletter.

VEP Board-Recommended ★ 2007-08 Goals & Objectives ★

- 1. Continue to improve our community and our association.
- A. Values: Place first priority on volunteer efforts that reflect member-endorsed improvements in our community.
- B. Leadership: Encourage regular turn-over of VEP Officers to impart broad, area-wide membership representation.
- C. Membership: Monitor changes in paid VEP membership.
- D. Meetings: Encourage attendance at VEP meetings and events.
- E. Fiscal Health: Continue to maintain VEP's positive fiscal condition.
- F. Communication:
- a) Continue publishing the VEP NEWS nine times per year.
- b) Continue development and encourage usage of VEP Website.
- c) Utilize e-mail to communicate important VEP business with members.

Pearl Library donation recommended

Our Executive Board is recommending that $\tilde{\mathsf{V}}\mathsf{EP}$ donate \$1000 to help furnish and equip the newly-constructed Pearl



Avenue Branch Library. This recommendation will be discussed and voted upon at our September 25th general membership meeting. <u>Please be sure to attend</u>.

The small but perennially busy Pearl Branch has been <u>our</u> community library since it was first opened in 1971. The

population here was much smaller then and our neighborhoods and demographics have changed dramatically. Our families grew up using "Pearl".

Fortunately, city voters approved bond money to enlarge it to about twice its original size on the same lot, next to the fire station on Pearl Avenue. You've probably noticed that it's nearing completion. A grand-opening is now scheduled for late-May 2008.

Unfortunately, general obligation bond money can't be used for furnishings, equipment (computers, etc.), and extended collections (reference books, DVDs, etc.), the things that successfully transform an empty building into a functioning library. Yes, there are city dollars and they'll be used, but they're limited. So, the non-profit *San Jose Public Library Foundation* is asking for the help of businesses, residents, and community associations like ours.

This approach has been working very well at other recently opened branch libraries like Almaden, Cambrian, and Vineland. People in the service areas for those libraries have given generously. The results are impressive—please make it a point to see for yourself. Similarly, to make sure it's a facility we



can be proud of, many folks in our area have already donated to Pearl.

Donations over \$100 are publicly and permanently acknowledged in the library. Our \$1000 donation would not only greatly help the library, it will place our organization's name on the library's *Legacy Donor Wall*, a fitting and lasting tribute to VEP and its community-minded and always-generous members.

VEP has the money to do this and it's a good thing for our community. Please consider a vote in support of this proposal on September 25th.




Oakridge Mall events for this autumn

Paid 10-month internships available

Here's a great opportunity for anyone who has thought of joining the Peace Corps or VISTA but would rather stay close to home. Persons of all ages are welcome and encouraged to apply.

Our City Forest, a non-profit urban forestry and environmental action organization serving the greater San Jose area, is accepting applications for 22 paid community service positions. These full-time positions offer an \$8.50/hr living allowance plus health insurance and education scholarship.

This program starts October 1st, 2007. Applicants must be 18 years of age but there is no upper age limit. Apply now.



Successful applicants will receive specialized job training while serving their community. Activities include coaching neighborhood and school tree plantings, teaching tree care techniques to residents, recruiting

community volunteers, mentoring youth, conducting tree care projects, teaching in classrooms, and developing/publishing educational materials. Interns will receive technical training in all aspects of urban forestry, community service and applicable computer software.

Successful applicants must commit to completing 1,750 hours over ten months, typically working five days per week, Tuesday through Saturday. Program begins 10/1/07 and ends 8/9/08.

All interns receive:

- \$15,000 stipend for ten months of service (living allowance valued at \$8.50/hr).
- \$4,725 AmeriCorps education scholarship after completion of the program.
- Health insurance.

YMCA Adventure Guides for fathers and kids

Dads, are you looking for a special way to bond with your son or daughter in kindergarten through 3rd grade? Then consider joining us this year! We have father/son and father/daughter groups with immediate openings!

The YMCA Adventure Guides program (formerly known as "Indian Guides") is all about father/child bonding. The Y emphasizes community, nature, family, and friendship (particularly friendship between dads and their kids). As such, there isn't the same rigor as with some scout programs. Instead, they just want the kids to have a good time with their dads, including a great deal of one-on-one time that you won't

find in other activities!

This program is comprised of small groups who meet on a monthly basis, typically held in the evenings after work. Normally, each father/child pair volunteers to take one month, so we pass the responsibility around.

Meetings give the kids an opportunity to talk about something "good" they did since the last meeting, listen to a

story, plan for upcoming events, and participate in arts and crafts (with dad's help). Many groups also do an informal outing up to once a month, to do something fun as a group.

Additionally, the YMCA has a number of activities planned this year, in which all the groups can participate, including:

Chynoweth clean-up day



Crime in VEP neighborhoods—Part One -Tanya Summers

In our neighborhood this summer, a couple with two young children that go to Parkview were on vaca-

tion for three weeks when someone pried open a locked window and broke into their house. The thieves stole EVERYTHING of value then trashed their home. They had and still have access to the family's computer, palm pilot, email, credit cards, passwords, social security numbers, birth dates, birth certificates, etc.



The crooks probably found a travel itinerary on their computer, so knew the family would be gone for a few weeks. They used those three weeks to order things on-line and have them delivered to the family's home, used their credit cards locally, changed their email address and passwords, and requested many new credit card applications to be mailed to them.

I saw pictures of the family's home after the crime. Every single drawer was opened and dumped, every vent was pulled open, they even went through their freezer, either looking for money or eating the food. Chances are the thieves may even have stayed in the house during this time.

Upon return from vacation, the family reported this crime. Although their home was finger-printed and evidence has been gathered, no one has yet been apprehended. It's easy to understand the family's impatience with the ongoing police investigation; no one seems to take this crime as seriously as they do, yet it's difficult for cops who are barraged with cases like this every day.

The family and neighbors have supplied evidence to the police. A neighbor saw an old white truck in their driveway, but didn't call the police because he thought it may have been a relative. Other neighbors saw this truck driving around during that time and earlier. Messages were left for them on the family's answering machine and emails were sent. The investigating detective said a similar case also occurred just across Capitol Expressway this summer.

This family is understandably very concerned because the thieves know so much about them and have their birth certificates, social security numbers, etc. They don't want this to happen to anyone else in our community.

Burglaries and other crimes are on the rise in our community. Solving crime is difficult, time consuming, and often far less than satisfying to victims, as lost and/or damaged property often cannot be recovered. The time to deal with crime is <u>before</u> it occurs—prevention is crucial, but easy and very effective.

~ Home invasion lessons learned ~ Our home was burglarized in May, between 11am and 12:45pm. Entry was gained through the locked window of the



gained through the locked window of the side garage door. The thieves went through every drawer. They hit our master bedroom the worst. I now wish I had paid more attention to Oprah who warns against storing your jewelry there. The thieves got away on our two bicycles and used our backpack to carry the items they stole.

I was pleasantly surprised in June when I received a call from a very nice SJPD detective saying that they had caught the individuals. He invited us down to identify our property. I must commend the police department on this process, as a majority of the other victims were there as well—a part of the healing process.

While talking with the other victims we found out that the suspects were Santa Teresa High School seniors. They'd hit us all at the same time of day over a period of about six weeks. Because we recovered some of our belongings, we were among the "luckier" victims.

The funniest part of this process was another victim recovered his digital camera and when he turned it on guess what was on there? Yes, the suspects had taken pictures of themselves and left them in the camera. We all had a great laugh at that.

The police detective helped clear up some issues that had been lingering in our minds. Was our home being watched? No, was his answer. He said these thieves would randomly knock on doors and if someone answered they would ask for a certain person then apologize saying they had the wrong house.

When the detective told me that, I went cold; I remembered that happening three weeks earlier. I didn't know that I should have called 911. He also told us that thieves would watch the neighborhood by posing as utility workers. Again this freaked me out because a week before our break-in someone "with the water district" was measuring our street. I had questioned that individual but didn't get their information. I wish I had.

One of our other questions was how did they catch the thieves? They had received a tip. The thieves had made a big mistake in burgling the homes of VEP and Santa Teresa people who sent out alerts via email and flyers to neighbors.



Here are a couple of tips that we have learned ⁵ through this ordeal:

• Take photographs of your valuables and keep them in a safe place (off-site would be best). Having photos also helps

in case of a fire or other loss.

• Check your insurance. If you have jewelry, make sure it is well documented and that you have separate riders covering the pieces you will want/need to have replaced. Most insurance companies only cover up to \$500 if not separated out. The same goes with a coin collection.

• If you submit a claim of more than \$2001, your insurance rates will be increased. (For that reason, we didn't file an insurance claim.)

We are now in the healing process and working with the District Attorney's office to ensure that these young men serve their time.

District 10 news

- City Councilmember Nancy Pyle The newspapers have been full of editorials and articles about the serious condition of the city budget. There are simply not enough dollars coming into the city to maintain parks and provide essential services at an acceptable level. As your city council member my job is to balance the city budget and provide services that you need in your neighborhood.



The key question at this time: How do we increase the city revenue without raising taxes? As chair of the Community and Economic Development Committee, I know that there are

simple steps we can take as a community to increase our city budget. As a city, we need to keep more of our own retail tax dollars and stop sales tax leakage. San Jose collects only \$82 per person in sales tax while Palo Alto collects \$222. We can all help close this gap by spending our money in San Jose. Increased sales tax dollars collected can be used to extend library hours,



pave streets, maintain parks and provide services and programs for our youth and seniors.

I invite you to let me know what type of shopping you prefer by participating in a retail survey that will focus on the Almaden and Blossom Valley and south San Jose neighborhoods. The results of this survey will help me and the Community and Economic Development Committee to better understand the retail needs of our residents.

Survey results will be presented at my "Retail Coming Attractions" forum on Wednesday, September 26th in the theater at Pioneer High School. In addition to survey results, there will be a presentation on the importance of retail sales to our city budget and updates on the Via Valiente Shopping Center Pilot Improvement Project, Whole Foods, and new retail at Westfield Oakridge.



Please take a few minutes to complete the survey at www.sanjoseca.gov/district10. There are only eleven questions, but the information gathered will be very useful to San Jose as we look forward to solving our city budget deficit through an increase of revenues. This survey will close on September 25th, 2007.

San Jose Unified School District news

-Veronica Lewis, Board Trustee San Jose Unified School District entered into an innovative partnership with Chevron Energy Solutions and Bank of America to establish the largest solar power and energy efficiency program in K-12 education in the United States.

This program will include installation of five megawatts of solar power, expected to reduce the district's demand for utility power by 25%, provide more than \$25-million in energy cost savings over the life of the solar power system, and reduce carbon dioxide emissions by 37,000 tons, equivalent to planting 400 trees. There will be no upfront

Solutions will design, build, operate, and maintain the system. Bank of America will finance and operate the service contract.



"This program is a result of years of research and commitment on the part of the San Jose Unified Board and is the living proof that schools can improve their facilities and help the environment without tapping their capitol budgets", said Board of Education President **Jorge Gonzalez**. "It's also an educational opportunity--it can help teach our school communities about energy efficiency and renewable power."

The first phase of the program will include installation of two megawatts of solar arrays, on the rooftops of Gunderson and San Jose High, and parking lot shade canopies at Gunderson, Pioneer, Leland, and San Jose High school parking lots.

~ Stadium lights are coming ~ After months of community meetings, an environmental (CEQA) study, and a Mitigated Report issued to the Board of



Education, installing stadium lights at all of our high schools was unanimously approved. The Board of Education created a Board Policy and Administrative Regulations that set the guidelines for the use of stadium lights and speakers. As part of this policy, the schools must submit a plan for how they will implement the mitigation measures of the CEQA report. We are cur-

rently awaiting approval of plans from the Department of State Architecture.

Oak Grove School District news

-Manny Barbara, Superintendent Welcome to the 2007-08 school year!

Even though the 2006-07 school term ended in June, school district work continues throughout the summer. Two types of

summer school were held this past summer. One provided additional assistance in reading and mathematics for approximately 1200 students, including programs for special education and English Learner students. We also held our first Summer Language Camp for high achieving students. This was a hugely successful program wherein students enrolled



for classes in Spanish, Vietnamese, and Mandarin Chinese. Another accelerated program included an advanced math curriculum.

At its August 23rd meeting, our Board of Trustees heard initial staff recommendations on our Five-Year Plan, an annually revised document that reflects District priorities for the coming

year.

Two other significant issues were considered at that meeting. The first involves a possible bond election. In 1994, our community supported a \$75-million bond election, enabling the upgrading and modernization of our school facilities. All schools have benefited significantly from the passage of this measure through new playgrounds, roofs, painting, earthquake retrofitting, and upgrading of classrooms and libraries, among other things.

That \$75-million will be expended by the end of the 2007-2008 school year. However, those funds have not been sufficient to complete all of the needs at the sites, while new facility concerns due to normal wear and tear are already evident. On August 23rd, our Board of Trustees considered a proposal for a "no tax increase" bond election, to be held in February in conjunction with the State primary election. They are expected to consider taking action at their September 27 regularly scheduled meeting.

Another significant proposal involves a potential sale of property. Due to a fortunate set of circumstances, special legislation was passed on behalf of the Oak Grove School District allowing us to sell surplus property and to use the proceeds in support of District



programs. This is a once in a lifetime opportunity to add additional resources, as the bill sunsets in 2010.

Our goal is to provide the best educational experience for all of our students. We are proud of current District programs that are particularly valued by both our staff and community, such as extended-day kindergarten; the low teacher-student ratio at grades K-3 of 20-1; and the grades 4-6 Visual and Performing Arts Program. We also want to continue with accelerated enrichment programs, such as this summer's language camps. The possible sale of one of our surplus properties can establish a funding source that will support existing and new programs for years to come.

Our Trustees heard preliminary information on both the possible bond election and the sale of surplus property on August 23. Please note that all Board meeting agendas and minutes are posted on our District web site at: www.ogsd.k12.ca.us. Autumn gardening

~ Fall checkup ~ I trust you've been pulling the heads off those dandelions all summer. If not, you should have. Every time you walk to the car to go somewhere and you see a yellow dandelion blossom, don't think, "I'll have to dig that up when I get home." It'll



never happen. Prevent that plant from multiplying by going over and plucking the blossom; if it's already progressed to the fuzzy ball, all the more important to trot over and close it into your hand and throw away, before the wind spreads the spores.

The best way to control crabgrass, that familiar annual weed with blue-green leaves and spreading stems, is to maintain a dense, healthy lawn that will out-compete it and prevent it from establishing. Mow at a height of 2-1/2 to 3-1/2 inches, and cut the grass frequently so as not to remove more than one-third of the leaf blade at one time. Also, water deeply and infrequently, and fertilize to encourage a vigorous lawn.

Weed killers are another option. The most effective among them are pre-emergent types that kill weed seeds as they sprout. It's essential to apply the herbicide before the crabgrass emerges from the soil. This happens in spring when soil temperatures are greater than 55° to 60°F for seven to ten consecutive days. Check with your local extension service for timing, or monitor the soil temperature yourself using a soil thermometer inserted at an angle just below the surface. But don't apply weed killers prior to seeding or in an area that's just been seeded.

~ Fall Plantings ~

September is a good month for planting cool season veggies including beets, carrots, lettuce, parsnips, certain types of peas, and Swiss chard. Broccoli, cauliflower, kohlrabi, rutabaga and turnips also do well. Leaves, stems, flower heads and roots are the edible portions of these versatile vegetables, depending on the species.

Anything grown from seed (most of the above) can usually be started in August or September. Those bought as nurserygrown seedlings are usually better transplanted in September, since the same warm weather that stimulates fast seen germination can cause tender, thirsty seedlings to wilt or burn.

Such root crops as carrots and parsnips require full sun, sandy or loamy soil, and regular irrigation. When sowing carrot seeds keep the soil moist and never let a crust form on top, or the seeds have difficulty sprouting (start indoors?). Unfortunately, parsnips never get as much good P.R. as their orange cousins. Parsnips' creamy white to yellow roots have a unique, mild flavor and can be baked, fried,

mashed, or cooked in soups or stews. Cold weather makes them sweeter.

Another favorite is the humble beet. For absolute cut beauty and flavor, go for the Chioggia, also called Bull's Eye, an unusual Italian heir-



loom beet with concentric white and red rings inside. Albina Verduna is a sweet white beet that grows well here, and Sangria is a classic deep red, like the wine. Because it develops its shape early, Sangria also makes a good "baby beet" when pulled early.

Swiss chard, a leafy vegetable, is actually a type of beet without the tasty bulbous root, and is beautiful on the dinner table served raw, steamed, or stir-fried. It's also an attention getting ornamental in the garden, when you're touring with friends. The Bright Lights variety is especially attractive, showing up with crimson, yellow and white stems.

The obvious leafy vegetable choice is lettuce, which comes in four varieties: crisphead, like iceberg and butterhead, Bibb loose leaf, Oak Leaf, and Romaine, which grows in vertical stocks.

I trust you've been pulling the heads off those dandelions all summer. If not, you should have. Upcoming gardening tasks...

~ SEPTEMBER ~

SNAPSHOT: Call this the swing shift, when you will be harvesting some of the last-of-summer veggies and planting fallwinter crops. Nurseries are stocking up for the big fall planting season. Smart buys: spring-flowering bulbs.

FLOWERS: Freshen up containers with late-summer annuals such as salvia and chrysanthemum. Perk up the planting mix while you're at it. Trim bearded iris foliage. Plant day lilies. Trim roses, feed and water. Check to see that watering basins are intact.

VEGETABLES: Plant broccoli, cauliflower, radishes, beets, spinach, lettuce, peas, and chard. Sow herb seeds or buy herb transplants.

TO-DO LIST: Clean up fallen fruit. Plant new trees, shrubs, ground covers, lawns, perennials and vines. Fertilize lawn about mid month, or roll out new sod. Divide and replant crowded perennials.

~ OCTOBER ~

SNAPSHOT: Warm early in the month, turning to brisk days

and cool nights. If you're planning a landscaping project, get it going now so tree and shrub roots can get off to a good start before winter. Install hardscape and irrigation systems.



FLOWERS: Cool-season annuals do great. Try coneflowers, pansies, primroses and Iceland poppies. Scatter wildflower seeds. Add some low-water-using California natives. Plant spring-blooming bulbs in containers. Work in compost.

VEGETABLES: Sow or transplant cool-season crops, along with artichokes, established herbs, garlic, parsley, spinach and onions. Don't forget to plant a little extra in your Good Neighbor Garden.

TO-DO LIST: Get ready to say ta-ta to the summer garden; pull up spent plants and clean up. Compost only pest-free plant debris. Plant lawns from seed or sod by mid-month. Plant shrubs, trees, and ground covers. Feed over-wintering plants with low-nitrogen fertilizer to help them become coldhardy. Spread compost or composted manure over all planted areas.

DO <u>NOT</u> **TOP TREES**: Topping trees is very harmful to proper tree growth and appearance. When a tree is topped, it is shocked into producing fast growth to the sides of the topped branches. The new growth will look very unnatural as it matures over time, and will also be weaker than normal growth. For full details, see your April 2006 VEP News (available at www.vepca.net).

Buyers beware—contractor scams

-Dave Fadness We've heard reports about scam "contractors" in our neighborhoods this summer and folks who lost their money by paying up-front to have work done by them. VEP has cautioned against this many times, so if you missed reading about it...

Never succumb to anyone who knocks on your door, uninvited, offering any kind of service. Whatever their story, and no matter how low-priced they are, don't <u>ever</u> let them convince you that you need the work done now, before they withdraw their offer. Spending any substantial amount of your money deserves looking around, checking the yellow pages, and consulting with neighbors and your community association, for starters.

Better yet, <u>before</u> you hire any type of contractor, do these two things:

1. Check on them in the Superior Court Records of Santa Clara County at www.sccaseinfo.org.

2. Be sure to check with the *Contractor's State Licensing Board* to see whether the contractor you want to hire has a li-




cense, is insured, and/or has any claims or complaints filed against them.

The Contractors State Licensing Board has an office at 100 Paseo De San Antonio (in downtown San Jose), 277-1244. They have excellent free information on your consumer rights and how to protect yourself against unscrupulous contractors. Get and read this information <u>before</u> you hire a contractor. Or, if you've already been burned, call them to report it and see what remedy you may have.

Do these easy checks BEFORE you sign a contract. You will be happy you did—you could be VERY <u>un</u>happy if you don't.

- Check contractor's license number at www.cslb.ca.gov or (800) 321-2752.
- Get three references and review past work.
- · Get at least three bids.
- Get a written contract and don't sign anything until you completely understand the terms.
- Pay 10 percent down, or \$1,000, whichever is less.
- Don't let payments get ahead of work. Keep records of all payments.
- Don't make final payment until you're satisfied with the job.
- Don't pay cash.
- Keep a job file of all papers relating to your project.

Be especially careful if sub-contractors are involved in doing labor or supplying materials. Even if you pay your contractor in full, if your contractor doesn't pay their subs, YOU are liable. You can end up paying twice, end up with a lien against your property, or spend precious time and money in court. A little due-diligence up front will save you money, headaches, and many sleepless nights.

Home maintenance

[Ed. Note: This is the sixth in a series of monthly reprints taken from "Home Maintenance Calendar 2007" which appeared in the December 30, 2006 San Jose Mercury-News.]

~ September ~

TOP JOB: Inspect water heater for leaks and flush tank. Test temperature and pressure relief (TPR) valve according to the manufacturer's instructions.

ALSO: Paint the inside of your house if needed. Remove and clean "pop-up" drain plugs.

Inspect grout around sinks, tubs and showers. Repair or replace damaged areas.

Clean patio furniture and prepare for winter storage. Protect metal.

~ October ~

TOP JOB: Replace batteries of smoke, heat and gas detectors.



ALSO: Insulate outdoor pipes to avoid freeze damage.

Clean gutters. Leaves and other debris will hamper drainage and may promote rusting. Compost the leaves.

Inspect and clean the fireplace and flue before lighting your first fire. Hire a professional if needed. Stack firewood away from the house.

Check furnace filter. Clean or replace if necessary.

~ Each month ~

- Test and inspect smoke, heat, and gas detectors.
- Check fire extinguishers. Replace or service as needed.
- Check to be certain nothing flammable is near a source of flame, such as a water heater pilot light, gas range, furnace, etc.
- Practice your family fire-escape plan and review earthquake preparedness. Inspect electrical cords for damage. Repair or replace if needed.
- Check the operation of all electrical circuit breakers by turning each off and on. Do the same with ground fault circuit interrupters, usually found in bathroom, kitchen, garage, and outdoor outlets. Replace those not working properly.
- Always be alert for other safety hazards, such as cracked walkways, hazardous materials that aren't properly stored, or unsecured heavy bookcases or other furniture that could topple during an earthquake.
- Check water softener. Add salt if needed.
- Clean garbage disposal by grinding up two trays of ice cubes made from a mixture of 1 cup white vinegar in 1 gallon of water. (Be certain to use the disposer cap when

grinding.) For a pleasant smell, follow the cleaning by grinding a lemon.

Trash & recycle collection reminders

There will now be two different trucks collecting garbage and recycling. Green and white *Garden City* trucks only pick up garbage. Gray *California Waste Solutions* trucks collect your recyclables. These trucks may come by anytime between 6 a.m. and 6 p.m. Please wait until 6 p.m. before calling in to report a missed pickup on either of your carts.

Setout reminders...

• Set out all carts no later than 6 a.m. on your collection day to avoid a missed pick-up. Collection may be anytime from 6 a.m. to 6 p.m. Please leave your carts out until they are emptied.

• Set out yard trimmings or carts no earlier than the day before collection to minimize unsafe driving and biking conditions.

• Completely close the lids of all carts when you set them out for collection to avoid spills or, in some cases, non-collection.

• Park the back wheels of carts against the curb and keep the carts 2-feet away from cars or other carts to give automated truck arms space to maneuver.

• Flatten and cut cardboard to fit loosely in your recycling cart so they will not jam when being emptied.

 Keep yard trimmings piles at least 5feet away from parked cars, carts, or other piles.



• Only use FREE City-issued oil jugs and oil filter bags at curbside to avoid spills. Driv-

ers will leave empty replacements after collection. Call the Recycle Plus Customer Contact Center for oil jugs and filter bags.

What's Garbage?

Use your garbage cart for food waste, disposable diapers, pizza boxes, broken glass, toys, shoes, garden hoses, empty toothpaste containers, etc. If your cart is full, place extra garbage in a 32-gallon plastic garbage bag on the curb near the garbage cart. Attach an Extra Garbage sticker that can be purchased at all San Jose libraries plus Safeway and Albertsons stores in San Jose.

What's Recyclable?

Please don't contaminate recycling carts with non-recyclable or hazardous materials. Not certain if something is recyclable? Check first by visiting our website at www.sjrecycles.org. Place extra recyclables in paper bags on the curb next to your recycling cart.

What are Yard Trimmings?

Lumber and fruit are not yard trimmings. For a list of what can and cannot be collected as yard trimmings, visit www.sjrecycles.org or return the attached postcard to request a free Recycling Guide.

What's Hazardous?

Some common items are too hazardous for garbage and recycling carts and must be taken to a household hazardous waste facility. Otherwise, they could endanger your neighborhood, the drivers, or the sorters at the recycling facility. These include household chemicals (pool, photo and gardening) and cleaners, batteries, syringes, propane tanks, paint, fluorescent bulbs etc. Call the Santa Clara County Household Hazardous Waste Program at (408) 299-7300 for a FREE drop-off appointment or for more information.

Street Sweeping...

Your street will be swept on your sheduled day each month. For cleaner streets, remember to move your car off the street by 7 a.m. on your sweep day. If you need a schedule magnet, call the Customer Contact Center.

Large Item Pick-up...

Mattresses, sofas, refrigerators, tires and other large items can be scheduled for curbside pick-up for an extra fee. To schedule a pick-up appointment, call the Customer

Contact Center. What's the best way to place my carts out for service?

Place them in the street with the rear wheels touching the curb. Carts should be at least a cou-

ple of feet apart and should not be near a parked car or other obstacle so that automated truck arms have space to maneuver. Also, make sure cart lids completely close.

Will you collect extra garbage?

We will if it is bagged and bears an official "extra garbage" sticker. Stickers can be purchased at all San Jose libraries, and Albertsons and Safeway stores, as well as at certain 7-Eleven stores. If you have large items that won't fit in your cart or in an extra bag, consider requesting an oversized item collection. Call (408) 535-3500 for more information.

What happens to any recyclables placed in my garbage? Once GCS collects them, they go straight to the landfill. So please be sure to put all your recyclables inside your recycling cart and <u>not</u> in the garbage.

VEP's May 22 meeting

-*Jim Hicks, VEP Secretary* VEP President Marilyn Rodgers opened our meeting with a warm welcome.

Jane Mark, Senior Planner with County Parks & Recreation Department started the meeting with a brief presentation about the Martial Cottle Park Master Plan.

Her summary addressed the large property located along Snell between Branham Lane and Chynoweth. A contract has

been signed with consultants *Wallace Roberts & Todd* to conduct the Master Plan. Public input will be part of a 2-1/2 to 3 year planning process. Public workshops will also be held by the County Parks Commission and the Board of Supervisors. The resulting joint plan with Regional Parks will span a ten to fifteen year period.



Walter Lester gave a total of 288 acres as a gift to Santa Clara County and the State of California. A regional Historic Agricultural Park will be developed on 136 acres at the southwest end, near Chynoweth. There are deed restrictions. No high-activity uses are allowed. Part of the park will be dedicated to community gardens consisting of 30 to 40 plots.

An advisory community task force of 12 to 14 members will be appointed. For more information, see the Santa Clara Park's Website www.parkhere.org. Click on the "Martial Cottle Park Master Plan" link.

Santa Clara County Open Space Authority is the funding source for the Master Plan, Phase One trail access, and community gardens.

Next on our agenda was a panel discussion on 87/Capital/ Narvaez. Assisted by **Carolyn Gonot**, VTA's Chief Development Officer, **Carey Ameto** presented a PowerPoint presentation entitled, "Summary of Operational Analysis of SR 87/ Narvaez Avenue Area." It focused on the current traffic problems in that area and recommendations in a consultant's analysis. Some preliminary solutions were discussed.

Bottom line: the various agencies must work out a solution to



traffic congestion before the proposed residential/commercial project on the VTA parking lot at Narvaez and Capital can go forward.

Standing-in for Councilwoman Nancy Pyle, her Chief of Staff Lee Wilcox said that

traffic solutions would require an Environmental Impact Study. He also mentioned that VEP's request for a small park (east side of Narvaez at Capitol) is still under consideration, but not yet included in a development proposal.

Hans Larson, Deputy Director of San Jose's Department of Transportation admitted that the Route 87 interchange is a problem. Solutions are competing for funds with some twenty other interchange issues within the city. Mr. Larson offered some possible fixes:

• This project must be made a regional priority. It needs to be listed in VTA's 30-year plan, which today it is not. State funding is needed. Private developers must contribute to a plan devised by VTA and the city to effect traffic solutions.

• San Jose will submit to VTA a draft recommendation for this project in July 2007. If adopted, 87/Capital/Narvaez improvements would become part of VTA's long-range plan.

County Supervisor-VTA Board Member **Don Gage** was successful in stopping the the Narvaez/Capital project. Two contractor bids were canceled last December and VTA has adopted a new process for bidding. He agreed that we need a regional solution.

Jim Hicks presented the annual Treasurer's Report for **Ginger Cardona**, who was unable to attend. The account was \$377 over last year's budget. The biggest expense items were the newsletter, our Memorial Day Parade & Festival, and our Community Service Awards. The Treasurer's Report was approved by those present.




