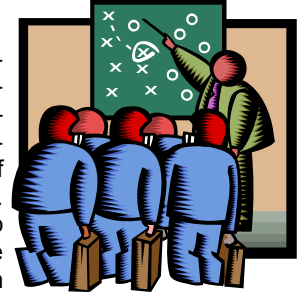

## October Meeting

To a "standing room only" attendance in the Vista Park community room, the October membership meeting started with brief introductions and an overview of the evening's meeting agenda. Attendees were encouraged to participate in the raffle for a free sampler box of chocolates from Champagne Wishes and Chocolate Dreams provided by Susan Iverson.



**Jaime Ruiz**, newly assigned San Jose City Parks and Recreation Manager for Vista Park provided an overview of the planned work to be completed in Phase 3 of the Vista Park Community Room Master Plan. Included work will be applying wood chips around the area where trees were planted in April, installing a mowstrip type curbing around the basketball court, and replacing shrubs and ground cover plants in front of the community room. The shrub planting will take place after a determination that the irrigation system is working. Mr. Ruiz provided hard copy pictures of five plants for possible selection. One attendee voiced concern about using one of the options – that of Jasmine, as it is a fragrant flowering plant which might attract bees.

The city will have a contract in place for the work to be completed in January/February, 2011 timeframe. One member voiced support for having all of the work completed by contractors rather than depending on volunteers.

**Thuy Nguyen**, Sr. Civil Engineer and **John Aquino**, Project Manager, of the San Jose City Public Works Department presented a very enlightening overview of the "Branham Lane Sewer System Project" (official name Downer-Canoas Interceptor Rehabilitation Project). Ms. Nguyen and Mr. Aquino informed the attendees that the project was ahead of schedule and equipment and crews would be completing the Branham Lane portion of the project by the first week in November. (See article included elsewhere in this edition of the newsletter for detailed information of the project.) Several members of the audience asked questions. The dialog became quite energized when one member asked about traffic flow and control. The contractor had hired SJ Police Officers to provide for traffic control and safety. One member asked about the adequacy of the signage in regards to the area being a "construction zone", as his family member had been given a traffic citation. Construction zone citations for speeding are significantly more costly. Another attendee voiced confusion about where the "construction zone" started and ended. Several members of the

audience voiced strong support for SJPD issuing traffic/speeding citations, as there has been a long history of vehicles speeding along this section of Branham Lane.

Laura Cowen of Councilmember Nancy Pyle's office announced several upcoming events.

Members in attendance approved the 2010-2011 VEP budget.

Other announcements included the November Santa in the Park event, and a brief update on the status of the Martial Cottle Park EIR Report.

## Arco Station Redevelopment

On October 26<sup>th</sup>, the San Jose City Council upheld the August 25<sup>th</sup> Planning Commission decision allowing the Arco franchisee at Branham and Pearl to build an AM/PM mini market with 24 hour operation, but without alcohol sales.



The Arco franchisee appealed the Planning Commission's denial of alcohol sales to the City Council, but withdrew that appeal at the City Council hearing.

In addition, the neighboring 7-11 franchisee appealed the Planning commission's approval of the mini market. The City Council heard his concerns but decided to allow the project as approved by the Planning Commission.



With the appeals behind them, it is our understanding the Arco franchisee will now proceed with the project.

## Sewer Rehabilitation Project

The saying “Out of Sight, Out of Mind” can be applied to the sewers running beneath our streets...until...something goes wrong such as sewer spills or back-up into homes and businesses, or roadway cave-ins due to collapsing sewers. Most of these menaces are caused by aging sewer systems combining with limited maintenance activities. Sewer rehabilitation (or renewal) projects such as the recently completed Downer-Canoas Interceptor Rehabilitation Project (the project) is intended to keep the sewers working effectively while staying “out of sight” for residents and business owners of the south San José communities, including the VEP neighborhoods. Running parallel to Canoas Creek, east of Route 87, from Blossom Hill Road to Curtner Avenue, the Downer-Canoas Sanitary Trunk Sewer is a large sewer (42-inches and 48-inches in diameter). This trunk sewer serves the neighborhoods of South San José and conveys over 7 million gallons of wastewater per day north toward the sewage treatment plant in Alviso. The sewer had an accumulation of sediment and had never been cleaned since its construction in the 1980s.

In 2006, the City contracted with AES Enterprises, Inc. to clean more than a mile of pipeline and inspect 3 additional miles of the Downer Canoas sewer system. The inspection revealed the need to renew a portion of this sewer system. Video images inside the pipe showed signs of aging pipe and joint separations which allowed ground water to infiltrate into the pipe. In August 2010, the City contracted Pipenology, Inc. from Rocklin, California to renew the aging sewer along Branham Lane from New Compton Drive to Narvaez Avenue and along Narvaez to Hillsdale Avenue.



The project utilized a “trenchless” method to renew the existing 42-inch and 48-inch diameter concrete pipes. To implement this renewal process, the existing (host) pipe had to be cleaned. Sewage was diverted through a sewer bypass system which consisted of series of black (high density polyethylene or HDPE) pipes stationed along the east side of Canoas Creek and along the south side of Hillsdale Avenue.

The installation of the sewer bypass system took five weeks

to complete, including four diesel pumps placed near the intersection of Branham Lane and New Compton Drive (picture below.)



With the sewer by-pass in operation, the pipe cleaning phase began and took seven weeks to complete. Pipenology utilized large vacuum trucks and high pressure cleaning equipment to remove 12 truck loads of debris from the sewer.

Multiple layers of a woven polyester felt-like material are used to line the sewer in the cured-in-place pipe (CIPP) liner process. The polyester liner is first saturated with a thermo-resin at the construction site. After saturation, the liner is inserted into the sewer through a manhole and pulled through the pipe. The liner is kept cool until it is ready to be inflated like a balloon inside the pipe. The contractor pumps cold water into the liner, which causes it to expand inside the pipe. After the liner is fully expanded, a large boiler is used to heat and recirculate the water inside the liner to “cure” the resin. The liner and resin materials harden and form a brand new pipe within the old pipe.

By the last week of October, Pipenology, Inc. has successfully renewed 8,650 feet of the Downer-Canoas Trunk sewer utilizing 720,000 lbs of resin and nearly 2 million gallons of water for curing the liner. The project also rehabilitated 24 sanitary sewer manholes.

The cured-in-place rehabilitation method used for this project is quicker and less costly than the traditional remove and replace (open-cut) construction method. This trenchless rehabilitation method decreases the noise and traffic impacts normally associated with traditional sewer repair methods and minimizes the impacts to other underground utilities such as water, storm sewers, electrical, telecommunications and gas lines.

Residents can help keep the sewer system functioning effectively by not pouring kitchen grease or hazardous waste into sewers. Trees or large shrubs should not be planted near a sewer line to prevent root intrusion into the sewer. Homes with basements plumbing fixtures that are lower than street level should be equipped with a back-water flap valve on the sewer lateral to prevent sewage back-up into the dwelling. 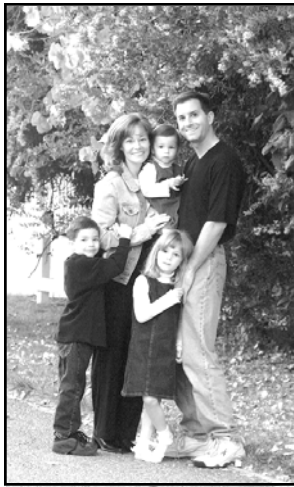
### Street Light Repair

With Fall arriving and the change of time from daylight savings to standard, dusk and darkness seems to arrive early. You may have noticed a street light in the neighborhood that is not working. The City of San Jose appreciates and depends on citizens reporting non-functioning street lights. To report a non-functioning street light, call Street Light Repair at **408-277-5517**. You will hear a recorded message that asks for several pieces of information including: a) your name, b) the number listed on the street light (note: there is a 6 digit number on the pole of the street light at "eye level"), c) address of street light (provide either the residence number if lightpole is in front of a home, or provide a description in terms of street location, ie. southwest corner of x street).

City staff attempts to repair street lights within 7 to 14 days of notification. Help keep our neighborhood and the City of San Jose safer by reporting non-functioning street lights!

**Remember ... When it is raining, be sure to turn on your car headlights at the same time as turning on your windshield wipers! It is the law, and makes for safer driving for everyone on the road!**

### 365 Cookies

Miscommunication resulted in the printing of last month's article in which I mistakenly believed I was writing for the January publication. Being the new leaf on the tree, I thought it possible there would be no more printings until after the holidays (the busiest time of the year). Anyway, the cookie baking is still on track; my list is full for the rest of the year and I'm still finding new recipes. Now comes the predicament of which ones will be sent to the island of untried cookies.



We are nearing Thanksgiving, one of the best holidays for delicious food, with Christmas inching its candy cane fingers around the corner. The following recipe has become one I will make again, especially this time of the year. Make a batch of these to enjoy Thanksgiving morning with a cup of coffee or for a late night snack after the kitchen has been put back into order (somewhat), and the relatives have been sent on their way. They are a cake-like cookie with a mildly spicy pumpkin flavor. The chocolate chips and walnuts randomly sprinkled throughout make every bite satisfying.

Chocolate Chip Pumpkin Cookies: 1 cup butter, softened (recipe calls for shortening), 2 cups granulated sugar, 2 eggs, 2 teaspoons vanilla extract, 1 (15 ounce) can pumpkin puree, 4 cups all-purpose flour, 1 ½ teaspoons baking soda, 1 ½ teaspoons baking powder, 1 teaspoon salt, 1 teaspoon ground cinnamon, 1 pinch ground nutmeg, 1 cup semisweet chocolate chips, 1 cup chopped walnuts (optional).

Preheat the oven to 375 degrees. Grease baking sheets or line with parchment paper. In a large bowl, cream together the butter and granulated sugar until smooth. Beat in the eggs one at a time. Stir in the vanilla and pumpkin until well blended. Combine the flour, baking soda, baking powder, salt, cinnamon and nutmeg; stir into the pumpkin mixture. Mix in the chocolate chips and walnuts, if desired. Drop by teaspoonfuls onto the prepared baking sheets.

Bake for 12-15 minutes in the preheated oven, until edges begin to brown. Allow to cool for a few minutes on the baking sheets before removing

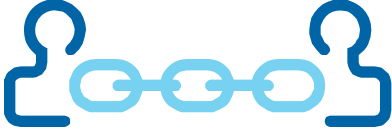

## November Garden Reminders

Sprinkle some color into your winter garden, if you're not growing vegetables this year. Sow wildflower seeds, and the winter rains will water them for you. You could also plant winter flowers, such as pansies, stock, snapdragons, and primrose. I've got some cosmos that keep re-seeding themselves in a neglected former tree hole in the driveway; they grow tall and beautiful, a thing of beauty to behold every day when I leave and return.

For veggies, plant those snow peas, broccoli, chard, etc. Garlic planted now can be harvested in May; set cloves (pointed end up) in soil that has good drainage. Plant about one inch deep, three to six inches apart.

Also, get ready to spray fruit trees; after leaves have fallen, spray peach trees and nectarine trees with lime sulfur to control peach leaf curl. Spray apricot trees with a fixed-copper spray, coating the stems and trunk thoroughly.

Continue to clip spent roses off the plants. You can expect more roses through December, even if the weather is frosty. But hold off on serious rose pruning until January.

### Bulbs go in NOW

There is still time to plant spring-flowering bulbs. Most nurseries and garden centers remain well-stocked with dozens of colorful selections. To help you plan your garden, check out [www.bulb.com](http://www.bulb.com) for a wealth of information and tips about how to choose, plant and otherwise care for your bulbs. The site is maintained by the Netherlands Flower Bulb Info Center (where else?). Once you get those bulbs in the ground, give yourself a little instant gratification by planting winter-color annuals on top. Good choices for sunny spots include pansies, violas, primrose and Iceland Poppies. For shady or dappled spots, try cineraria and cyclamen.

### Using Oak Barrels

Half an oak barrel makes a great container for small trees, particularly citrus trees. But what about drainage? You should drill four, half-inch (or so) holes around the perimeter of the bottom. Coat the interior with a roofing compound, such as Black Jack, to prevent rotting.

### Bees in the Backyard?

Unless there is a bee's nest in your back yard, you need not worry about killing them. Bees will fly miles to reach a site where food is obtainable. To eliminate the possibility of bees buzzing around, say during your yard party, you would have to spray a circular area miles across, and then only on the day of the party.

The music department will put on its yearly winter concert on December 2.

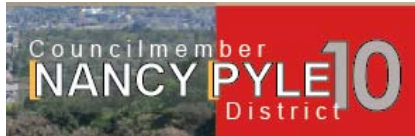

## Proposed Citywide Social Host Ordinance

As many of you know, on September 21st our community suffered a fatal motor vehicle crash involving two 2010 Leland High School graduates. Alcohol was involved in that accident and so on Tuesday, October 19th Leland High School hosted a community forum to discuss issues related to teen drinking and driving. The event was a collaboration effort between Leland and the Santa Clara County Public Health Department's Traffic Safe Communities Network (TSCN). TSCN is a community collaborative which includes representatives from law enforcement, transportation, education, healthcare, and elected officials. I went to the forum and was happy to see many students, parents and other community members also in attendance.



Motor vehicle crashes are the leading cause of injuries and deaths for teens and alcohol is one of the primary causes of these collisions. In 2008, the California Office of Traffic Safety (OTS) reported 118 collisions in Santa Clara County involving drivers under age 21 who had been drinking. The crashes resulted in 111 injuries and three deaths. The same year, alcohol-related crashes made up 11 percent of all motor vehicle collisions in Santa Clara County and caused 38 percent of all motor vehicle fatalities.

These statistics are both shocking and unacceptable. I have submitted a [memo](#) to the Rules and Open Government Committee asking staff to look into a Citywide Social Host Ordinance which is a proactive step that holds adults responsible for underage drinking when they knowingly or unknowingly host parties on property they own, lease or otherwise control

I look forward to continuing to work together to keep our community safe

## San Jose Voters Approve Fiscal Reforms

San Jose voters overwhelmingly passed two important ballot measures this November that will allow the city to take the first step toward restoring fiscal responsibility.



**Measure V**, which received more than 66% of the vote, places some common-sense limits on outside arbitrators that prevent them from spending money the city doesn't have. In addition, **Measure W** received more than 70% of the vote, allowing the City Council to establish lower retirement benefits (a.k.a. a 2<sup>nd</sup> tier) for new employees.

On November 18, the Council will hold a special meeting on the 2011-2012 budget, where they will also receive input from a **Stakeholder Group** that has been looking at potential elements of retirement reform. Negotiations with employee bargaining groups are scheduled to begin in January 2011.

In the November election, San Jose voters also authorized the City Council to impose a business tax of up to 10% on marijuana establishments (Measure U). All local election results can be found at the **Santa Clara County Registrar of Voters** website.

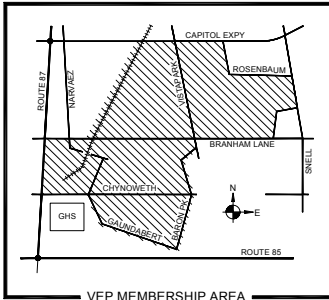
