March Meeting Synopsis

President Rodgers welcomed everyone to the meeting. She informed those in attendance that a nice way to start the meeting is to give everyone an opportunity to meet someone they did not know. She asked them to turn to someone close by and introduce themselves. Introductions were to also include what street they lived on. She gave everyone approximately 3 minutes of time for this activity. Everyone seems to enjoy this activity and it is difficult to get them to stop and return to a meeting format. Ms. Rodgers said she wanted to introduce the Board members in attendance – first she introduced Josie Supencheck who is not a Board Member but had agreed to assist with the meeting in Katherine Decker's absence. She then introduced Ginger Cardona, Debra Suydam, and Adina Pierce, as well as Past Presidents Jeri Arstingstall, Bob Aquino, and Greg West. Others introduced were Councilmember Johnny Khamis and one of his new staff members Jose Salcido.

Ms. Rodgers informed everyone, who might not be already aware of the **tragedy affecting Vice President Katherine Decker** and her family. Katherine is the mother of SJPD Officer Michael Johnson who had been killed in the line of duty on March 24th. President Rodgers indicated that she had been with Katherine since that evening at about 8pm. Ms. Rodgers had quickly contacted Councilmember Khamis who came to the Decker's home to provide any assistance needed. Mayor Sam Liccardo and the Acting City Manager, Norberto Duenas came to the Decker's home to personally relay their condolences and offer any support or assistance needed. Ms. Rodgers also told the audience that Katherine's family appreciates everyone's concern and support, as well as their consideration for the family's need for privacy at this time. SJPD and POA had also been very helpful and supportive in providing both assistance as well as security for the family. Finally, President Rodgers asked everyone to sign a poster for

Katherine and her family.

Ms. Rodgers then invited Councilmember Khamis to address the audience. He also expressed his sadness at the loss of Officer Michael Johnson, and the personal loss he felt on behalf of Katherine, who is not only a constituent but a friend. He also wanted to thank all of the SJPD police officers for their service and the sacrifice they make on a daily basis to the City that we all care about. The Councilmember apologized for not being able to attend all of our meetings, as Tuesday evenings have become almost impossible for him – with the City Council meetings often running late into Tuesday evenings. Councilmember Khamis briefly discussed the Safety Meeting held in Almaden Valley at the Bret Harte School, which had a very large turnout of concerned citizens. This meeting was in response to a large upturn in home burglaries in that area of his district. He was happy to report that several arrests had since been made with the hard work of SJPD and the new Southern Division Commander, Captain Schroder, as well as the involvement and partnership of many of the residents. They have been actively watching out for themselves and their neighbors. A planned follow-up to the above meeting will be a meeting focusing on the impact of Proposition 47 – which mandated releasing non-violent felons from California State Prisons back to the custody and control of the Counties and Cities throughout California. (Note: this was in lieu of increased taxes to build additional new state prisons). He reminded people to take advantage of his community office hours – the newest one now being held on a Saturday morning – the 2nd Saturday of the month, on Blossom Hill Road at City Expresso from 10am – 11:30am. Ms. Rodgers thanked the Councilmember.

President Rodgers then stated she was very appreciative of the willingness of the next speaker, who had made himself available with late notice, to come do a presentation for VEP. There had been some scheduling challenges in confirming speakers, as March 31st is a holiday for both the City of San Jose and the County of Santa Clara (it is Cesar Chavez's birthday). She then introduced **Ron Berube** a volunteer from the AARP's Smart Driver Course. Mr. Berube emphasized the fact that he and his colleagues are all volunteers, not paid staff. They provide these courses because they believe in the value and importance of the course. 400 volunteers teach the class – they teach the courses at Community Centers, Senior Centers, and Hospitals. (Note: They could teach a class at the Vista Park Community Room if there is enough interest.) 15 million seniors have participated in this program since 1979.

Anyone can take the course, but you do have to be 50 years old to obtain an insurance discount. Many insurance companies provide a discount for successful graduates of the program. You will, however need to check with your insurance company to determine if they provide a discount, and how much of a discount. Most insurance companies provide anywhere from 3% to 15% discount on their policies.

The cost of the course is \$15.00 for AARP members, and \$20.00 for non-members. The format of the class can be taken in either two sessions of 4 hours each and/or one session of 8 hours. The course covers a review of issues regarding vehicles, traffic laws, roads, and issues affecting us. As we age, things do start to change, and we have to make accommodations for those things. The first rule is to "take your time," and the second is the "3 second rule." Another is to make a car "fit you and your needs – looking at things like placement of the rearview mirrors, height and depth of car seat, visibility of side and rear windows, and many other issues are reviewed.

This course has saved participants over 128 million dollars. The website www.safecar.gov is sponsored by the National Safety

Association. By utilizing the website and putting in your car's VIN number – you will have access to any and all recalls for a given car, as well as safety reports.

To take the class – you have two options: 1) Sign-up sheet (sign) tonight; and 2) Online – go to AARP.org/findaclass – put in your zip code—including how many miles would you be willing to drive to attend the class. For first time attendees – you will need to take the 8hour course. If you are returning for a review, there is a 4hour course that you can take. Note: at age 70 you are required to go into the DMV and take the written exam. A meeting attendee stated that that this course was a good prep review. Mr. Berube also said he provides lots of resources for class participants, and will provide website that will give you 100s of prep questions, should you be someone who fears taking tests. He also provides lots of other resources including a brochure on "When should a mature driver stop driving." Once a driver successfully completes the course, the DMV will provide a Senior ID card that is good for 10years.

Other organizations or groups also provide similar courses, such as the California Highway Patrol. The CHP's course is free, however, these courses are not certified for the insurance discount – only AARP's course is certified for the insurance discount. Ms. Rodgers thanked Mr. Berube for the excellent information.

The next guest to be introduced was **Jose Salcido**, who has recently been hired as a member of Councilmember Khamis' staff. Prior to that he worked for the Mayor's office. He has a law enforcement background (Santa Clara County Sheriff's Department), and then helped to start the Mayor's Gang Prevention Task Force – which is now a model for the rest of the country. Jose thanked Ms. Rodgers, and expanded on his background. He also acknowledged that he is the "pint person" in Councilmember's office for issues regarding "the homeless," as well as issues involving Public Safety.

President Rodger's continued by introducing the next speaker **Karen Wernerbyce**, who is the Coordinator for the 4-H programs in Santa Clara County. Many of us have some knowledge of 4-H, particularly if we lived in a rural area at some point in our lives. The reporting structure of 4-H is somewhat complex. The oversight for the organization's clubs comes through the University of California Agriculture and Natural Resources. The Extension Officers affiliation comes through the University, and dates back to land grants. 4-H Clubs are located throughout Santa Clara County. The hope and goal is to establish a new club for the Martial Cottle area.

The mission for 4-H is "engaging youth to reach their fullest potential while advancing the field of youth development." While 4-H has a rich 101-year old history in agriculture, there are also additional opportunities for youth to develop skills in several areas. 4-H is a non-formal education program for everyone. All young people ages 5 to 19 are welcome to join a 4-H club or program. Santa Clara County projects cover every interest from baking to bee-keeping, fishing to photography, raising rabbits to racing robots. Groups meet on weekends and evenings to build community and to work on projects.

4-H emphasizes youth leadership and youth-adult partnerships. Youth members take on key leadership roles from club president to project leader, and develop strong positive relationships with caring adult volunteers from all walks of life. Youth members and adult volunteers can join any time. Membership costs approximately \$35.00 per year.

Currently there are 4 Community Ranches – Martial Cottle Ranch will be #5. Currently 4-H for Martial Cottle is in a "holding

pattern" until the Memorandum of Understanding (MOU) is signed. Currently the MOU is at the State level going through this process. Once it is signed, the goal is to establish a "livestock advisory" – with a focus on "pastured sheep." As soon as the MOU is signed, the plan is move sheep on to the park property to eat the spring grass. The next County Fair is held in August.

The final speaker that Ms. Rodgers introduced was **Francisco De La Torre** of TAPS Security and Alarm, to provide us with information on Residential Mobile Security Patrols. She thanked Francisco for his patience and willingness to be the last speaker for the evening. Francisco quickly went through what the TAPS residential security patrols have to offer to our neighborhoods. They provide random 24-hour/7-days per week patrol services (these random patrols depend on priority hours of day and night – and on the number of subscribers on a given street). They also respond to alarms (police are unable to do this, unless alarms are "verified" – TAPS is authorized to verify Alarms), **direct phone or text access to the agent on duty**, vacation checks of your residence, marked patrol cars, prevention/deterrent to criminal activity, immediate response to calls for non-emergency services (such as "suspicious activity" and disturbances – i.e. Loud parties, dogs barking, etc.), and newsletter via e-mail. The current cost is \$17.50 per month – which is paid in 3 month increments. Service can be cancelled at any time.

Several members in attendance are subscribers of this service, and spoke in support of it – strongly encouraging others to consider becoming subscribers. Note: this service is by individual household and voluntary. It is one more level of security for our individual homes and for our neighborhoods.

President Rodgers reminded everyone of the announcements listed in the March edition of the VEP newsletter, particularly the April 25th All American Litter Pickup and the May 2nd VEP Neighborhood-wide Garage Sale – plan now to participate in both! Next meeting is April 28th and Happy Easter!

VEP Community Service Awards 2015

Once again, VEP Community Association will provide an opportunity for up to three high school seniors to be awarded a Community Service Award (scholarship) for recognition of volunteerism in their community. This is the 31st consecutive year that VEP has proudly awarded scholarships to local graduating high school seniors in recognition of their outstanding volunteer service to their community. A panel of judges, who are also volunteers in our community, will determine the winner(s), based on predetermined criteria, after reviewing submitted applications. As in previous years, applications will be solicited from Gunderson High School, from Andrew Hill High School, and through the VEP newsletter and website for the "At-Large category." The "At-Large category" is available for students who attend any other high school in San Jose, but must live in the geographical boundaries of the VEP Community.

Both the criteria and the budgeted amount for the scholarships will continue as has been approved for the last several years. \$1,000.00 has been automatically included in this year's budget. The program criteria which has been approved for the last several years, is as follows:

"Up to 3 awards to be granted at the judges' discretion, evenly distributed among selected winners. Nominations to be solicited from AHHS, GHS, and in the VEP newsletter (for Member-at-Large). School administrators will be asked to nominate at least 2 students per school with no upper limit. No more than 1 award per category (AHHS, GHS, At-Large). Ok to grant an award in a category with only 1 nominee. Ok not to grant an award in any category, if judges feel the candidate(s) don't merit an award."

Applications will be available by April 1st at each high school, and on the VEP website and/or by request for the At-Large applications. At Gunderson High School, the administrator to contact for an application is Ms. Stephanie Heuer, and at Andrew Hill High School, the administrator to contact for an application is Ms. Marquez. For the At-Large Application, contact one of the VEP Coordinators – Helen Castillo or Marilyn Rodgers. Please note: the At-Large student applicants will need to provide contact information to VEP for an administrator at their high school (for verification purposes).

If you know a deserving high school senior, who is a **very active volunteer**, please let them know about our Community Service Awards.

Opening of Martial Cottle Park: Personal Reflections

(Note: The following is the keynote address provided by Congressman Mike Honda at the Opening Ceremony for the Martial Cottle Park, held on Saturday, December 13, 2014. We thank Congressman Honda for graciously providing his comments for publication in the VEP Newsletter. Marilyn Rodgers, President, VEP.)

It has been almost 25 years since I stood on this property with Walter Lester as he shared his vision for creating a living memorial to Santa Clara County's agricultural past. This 288-acre parcel, a tribute to 4 generations of a farming family dating back to the 1850s, is a jewel of the Santa Clara County Parks department.

Today, both Walter Lester, and his sister Edith Ethel Lester have fulfilled the dream of their mother, Ethel, to honor her father, Martial Cottle by transforming the farm into a public historical agricultural park to "promote, educate, and sustain farming traditions in the Santa Clara Valley."

Over the decades, Walter never strayed from his mother's vision. I remember meeting Walter in the early 1990s in the little white outbuilding on his property. We discussed how to insure that his property would never be sold, or come under control of the City of San Jose. We strategized about how to preserve the estate and protect it from taxes. And later, as a state and federal legislator, I made sure that state park funding supported acquisition and federal estate taxes would not eat away at his donation.

Walter was a patient man. He outlasted four county parks directors during the negotiations. In 1999, upon the death of his sister, the issue of inheritance taxes became a seemingly insurmountable obstacle to his pending donation. By then, as a member of the state assembly, I was able to reconnect with Walter and lend my support to resolving remaining obstacles.

Being from a family who sharecropped nearby, I know how this valley has changed and how children from urban areas have little or no opportunity to experience agriculture. Walter knew that a park comprised of a working farm would not only give children an appreciation for the history of the Valley of the Hearts Delight, but would connect them to the food they consume.

Walter Lester has done for our children what we would have been unable to accomplish on our own. He has given them a permanent connection to the history of this valley and our agricultural roots. He has left behind a precious vehicle for teaching environmental stewardship. And it is our duty to honor his memory and cherish the gift that he has left us."

San Jose Police Officer - Michael Johnson Son of Katherine Decker, VEP Vice President

On the evening of March 24, 2015, the VEP Community heard the heart breaking news along with the rest of the City of San Jose: a San Jose Police Officer had been killed in the line of duty. This news was especially difficult and became even more personal for the VEP Community when the officer's name was released: Officer Michael Johnson.

Officer Johnson's mother is Katherine Decker – a long time VEP resident and active volunteer who currently serves on the Board of Directors as VEP Vice President.

The VEP Board of Directors sent out the following e-mail notice to members:

It is with great sadness that the VEP Board of Directors sends this message to notify members that "one of our own".....VEP Vice President Katherine Decker and her family, have suffered a great loss. Michael Johnson, the SJPD police officer who was shot and killed in the line of duty, on Tuesday evening, was Katherine's son. We wish to send our most profound condolences to Katherine, Dann, Michael's wife Nicole, and the rest of the family.

The family wishes to convey their appreciation of everyone's kind thoughts and prayers. However, at this time, they are requesting your understanding in allowing them privacy, while they deal with the shock and grief."

Over the next several days, the VEP community responded with both personal and neighborhood memorials. (p. 7, top) Individuals put up blue lights to honor Michael, others came together by street or area to provide more elaborate memorials. The City of San Jose came together to honor Michael and his family: informally at a large memorial at the San Jose Police Department, and formally at the SAP Center on April 2nd (p. 7, bottom).

The following obituary was written by the family. Permission has been given by the family to re-print it, in its entirety in the VEP newsletter:

Michael Jeremiah Johnson ("Mike") was born on December 4, 1976. At the time he was born, Mike's dad, Daniel Johnson, was a military police officer in the Army stationed at Herlong, California. After his dad was discharged from the Army, he joined the Calaveras County Sheriff's department, and Mike and his family moved to Wilseyville. He then lived in Vallicito and Angeles Camp, and after his parents' divorce, Michael moved to San Jose with his mom, Katherine Decker, and sister, Jamie Radack, in 1988.

Shortly after they moved to San Jose, Mike got his first job delivering newspapers on his bicycle for the San Jose Mercury News. In 1995, Mike graduated from Gunderson High School and then took classes at West Valley College while working as an audio/visual specialist at Radio Shack, and later The Good Guys.

In 2001, Mike joined the San Jose Police Academy and graduated on June 15, 2001. During his time with the San Jose Police

Department, Mike worked as a Patrolman, Court Liaison, and Prescription Drug Fraud Specialist. At the time of his death, Mike had recently been promoted to Field Training Officer and assigned to Covert Response Unit.

Mike was a member of the Specialist Rifle program and was an expert marksman. Mike proved his expert marksmanship skills each year when he and his father would compete together at the US Police and Fire Games.

Mike and his wife, Nicole ("Nikki"), were married in a civil ceremony on August 3, 2013. They were planning a formal wedding ceremony and reception for August 29, 2015 in Santa Cruz.

Mike is survived by his wife Nikki, his parents Daniel Johnson and Katherine Decker, his step-parents Dann Decker and Penny Johnson, his grandmother Frances Guillemain, his sister Jamie Radack, his brother-in-law Steve Radack, his mother and father-in-law Susan and Antonio Chavez, his sister and brother-in-law Gina and Jameson Stiehr, and brother-in-law Danny Chavez.

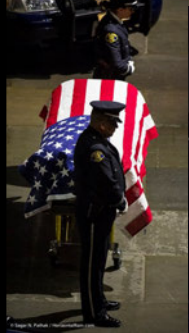

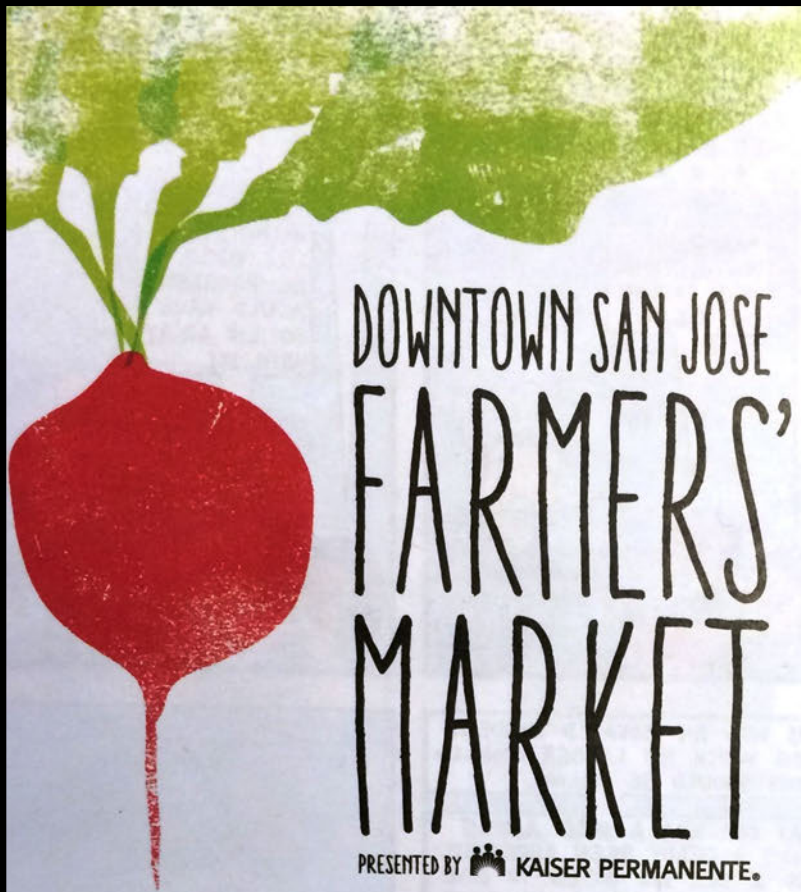

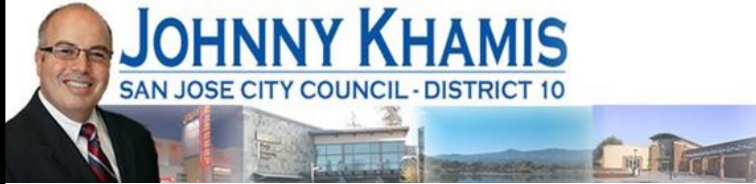

SUPERVISOR MIKE WASSERMAN

Tragedy hit home recently as San Jose Police Officer Michael Johnson was killed while serving and protecting our community on the evening of March 24, 2015. My thoughts and prayers are with Officer Johnson's family, friends, and the law enforcement community, all of whom feel the enormity of this loss.

In light of this news, the Blue and Gold Service Award Ceremony hosted by the Exchange Club of San Jose was especially somber. This annual event recognizes members of the local law enforcement community who were injured in the line of duty. In addition to this recognition, there was a moment of silence to honor Officer Johnson for making the ultimate sacrifice in service to his community. Each of us must remember the risks those in law enforcement take each day by voluntarily serving on the front lines of public safety.

Last month, I had the opportunity to speak to the Almaden Valley Community Association regarding County services. While most residents are familiar with services provided by cities, very few are aware of the Real. Life. Help. that Santa Clara County provides to our 1.9 million residents every day. County services range from emergency, health, hospital, safety, to roads, airports, recreation, parks, inspecting gas pumps and restaurants, and so much more. If your community group or neighborhood association would like to hear a County update too, please let me know.

The County's Re-Entry Center is a good example of the Real. Life. Help. that the County provides. For over 3 years, the Center has been helping formerly incarcerated individuals integrate back into society. One ex-offender named Henry who received services through the Center spoke to me about his experience: He had been incarcerated for 10 years and was released with \$200, a sweat suit to wear, a little card that said —You are Free." Henry has been out for five months and for the first three months, you could find him every weekday at the Reentry Resource Center. Henry talked of how he used his time in prison taking courses, trying to better himself so he could turn his life around and be a better example for his kids. Today, he is working, paying his own way, living on his own and talks with his children daily. The Re-Entry Center reduces recidivism and has already helped 5,500 criminal justice clients successfully integrate back into society. Supporting people who are committed to changing their lives creates safer communities.

What To Do for Family Pets!

It may seem strange or unnecessary to include pets in your emergency plans, but it really makes sense! Your family's furry friends also need to be properly prepared-for in case of disaster. Planning ahead in regards to your particular pets' needs will ensure that all members of your family can survive an emergency.

Stocking Your Disaster Kit for Animals' Needs:

FOOD - Store enough nonperishable animal food in your family's Disaster Kit to feed each animal for at least three days.

WATER - Store additional water for each animal, for at least three days. How much to store depends on the size of the pet(s).



COMFORT - Store an extra blanket for each animal in the family. Also be sure to store a toy or two, to help relieve stress.

SECURITY - Store an extra collar (or, harness) and leash (or, tether and stake) for each of your animals. For smaller animals, consider keeping an extra crate as part of your Disaster Kit.

CLEANLINESS - For dogs: Store doggy-do bags, rubber gloves, and any other related items in the kit. For cats: Store one of those —ready made— litter-in-the-tray types. For small animals in cages: Store extra bedding or shavings, to keep cage(s) fresh.

SPECIAL NEEDS - If your pet is on medication, or requires any specific remedies, treatments, supplements, etc., be sure to stock a supply (and any needed — Pockets—) in the Disaster Kit. Include enough for at least three days.

—Preparing— Your Pets for Possible Disasters:

You should include pets during your family practice drills whenever it is possible and reasonable. For example, have the family dog practice going out through a window during a calm drill, so that in the case of a real emergency they won't balk at using an irregular method of exit from your home. Routinely walk your dog to the Family Meeting Spot, so they are also familiar with, and comfortable in, that area. Such activities will help your pet feel calm and safe if a real emergency occurs.

Gardening, with John Marks

Black Mold on Oranges

When you go to pick your oranges, you may notice a black ~~—it~~ on the oranges as well as the leaves. You may also notice a lot of scale all over the trees. The ~~—it~~ is called sooty mold. The scale comes from aphids, mealy bugs and other sap-sucking insects that eat more sap than they can digest and exude the excess. It all falls to the fruit and leaves below, and a fungus grows on this exudate. Sooty mold grows only on the surface and can be washed off. The exudate is sweet and serves as a food source for ants. To control the scale, prevent ants from climbing the tree and natural predators will usually take care of the scale. To stop ants, wrap a three-inch-wide band of masking tape around the trunk and spread sticky goo (tanglefoot) on the tape. Although the ants can't cross the tape, they will look for other ways to get at the food that they scent. You will have to remove any branches, twigs or leaves touching any structure or another plant, as they will climb to follow the scent.

Degenerate Tomatoes

Tomatoes in our area can be infected by two soil-inhabiting fungi, verticillium wilt and fusarium wilt. Both can cause the fruit to become deformed, stay small, and the leaves turn brown - but the most likely culprit is fusarium wilt. These two fungal disease persist in the soil for up to 20 years and affect many other plants, as well. Do not replant tomatoes in the same place. If possible, plant only those that are labeled VFN (verticillium-, fusarium- and nematode-resistant). These will help prevent the spread of the diseases. Rotating the area where tomatoes are to be planted is an old but effective practice.



Squirrels, Part II

As you know from previous newsletters, there are no repellents or magic wands to make squirrels go away, but you can discourage them with this free tip! Put walnut-sized rocks on the surface of the soil in your pots and planters. Use colored rocks if possible - red, white, lava or smooth black stones. Don't ask me why it works, but the size is important, and those bushy-tailed rats will leave your containers alone.



Crab grass Bothering You?

One way to handle crab grass is weed killers. Many types exist. The most effective among them are pre-emergent types that kill weed seeds as they sprout. It's essential to apply the herbicide before the crabgrass emerges from the soil. This happens in spring when soil temperatures are greater than 55° to 60°F for 7 to 10 consecutive days, so you may still have time. Check with your local extension service for timing, or monitor the soil temperature yourself using a soil thermometer inserted at an angle just below the surface. But don't apply weed killers prior to seeding or in an area that's just been seeded.

Random Tidbits, with Kathy Wood

My husband and I recently returned to the land of sunshine and warmer temperatures after a mostly fun-filled visit with our extended families in Michigan (Pure Michigan according to the commercials). With every trip we ponder the question, —~~C~~ould we live here again?”

We have discovered several differences between the two states:

1) Weather.

That white stuff called snow is in abundance up to 6 months out of a year. The first snowfall is pretty and brings excitement to children looking forward to sledding and building snowmen. Anyone who is no longer a child only sees hours of shoveling and time spent on their backsides from slipping on icy streets and sidewalks. Michigan also holds claim to plenty of thunderstorms with monstrous claps of thunder (occupants of Heaven are bowling again) and eye-popping streaks of lightning. Hail falls with some of these storms ranging in size on the —~~h~~ail chart” from peas to baseballs. Humidity arrives in the summer months only to make those who are air conditioner-less miserable. Of course, here in California, an earthquake or two can rock your world.

2) Food.

A visit in Michigan always, and I repeat, always makes us thankful to be residing in an area with expansive food choices. The availability of fresh fruit and vegetables mostly year round is something we take for granted. Plenty of residents in Michigan plant large gardens and preserve their harvest through canning or freezing to enjoy during the winter months. Still, it doesn't compare to fresh.

3) Space.

Most homes in Michigan are surrounded by an actual lawn with green (not brown) grass. It takes more than 2 steps to reach your neighbor's home and no one is peeking into your house from their upstairs window next door. Traveling is measured in miles, not in hours or minutes (depending on the traffic). I don't know how many times I've driven I-75 with no cars either ahead of me or behind me within sight (did the end of the world happen and I missed it?).

4) Water.

Lakes and ponds are in abundance in Michigan, even though some are still wearing a thin coat of ice. Showers flow strong; lawn and gardens can be watered daily, if desired and people wash their cars on any given day. Every time we witnessed one of these beautiful bodies of liquid we pondered how to bottle it up and bring it with us in our suitcases.

Every state has its faults and its assets - choosing what's right for you and your family is an important personal decision (or relocate to one of the other 49).

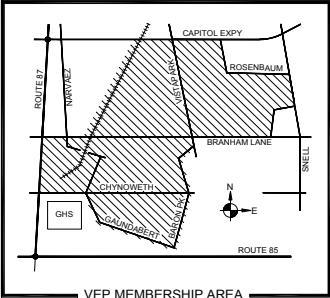
