May/June Meeting Synopsis

President Rodgers welcomed everyone to the meeting. She stated that she was pleased to see so many new faces at the meeting. She also acknowledged that she knew several people were in attendance to learn more about Video Camera Monitored Response, as a result of several home burglaries occurring in the VEP neighborhoods. As this would be a very busy meeting, she asked that one important business item on the agenda be taken first. That item had to do with the Election for the Slate of Members for Election to the Board of Directors. She asked for and received a motion and second to the motion to approve the election of the slate. It was unanimously approved. President Rodgers thanked the audience and introduced the Board Members: Ginger Cardona, Adina Pierce, Katherine Decker, Rachel Witmeyer, Rich Giammona, and herself. As per the VEP bylaws, the Board of Directors, once elected, will determine and vote for the officers of the organization.

President Rodgers introduced Francisco De La Torre of TAPS Residential Security Patrols. Francisco brought a couple of staff members with him to help with the demonstration and answer questions regarding the Video Camera Monitored Response system. They had a table top demonstration. One of the main attributes to a video camera monitored response system is that it videos intruders/potential burglars and this information is immediately available to the SJPD as a "verified response." How it works: A live person is constantly monitoring the system at a central location. In the event of an alarm, this agent will contact the homeowner to verify there is no mistake/false alarm, and then the information goes immediately to SJPD (in the case of our city/neighborhood). Note: SJPD only responds to "verified" burglary alarms currently. Verification can be made by video and/or by a TAPS Residential Security Patrol Guard in person (if there is no video). So having video camera monitored response system decreases the amount of time for a response and increases the probability of actually catching the perpetrator.

Following the presentation, the audience had several questions, such as how many cameras are needed, where are they placed, what is the cost, what about privacy issues for the homeowner (how long are the tapes kept, who has access to the tapes, and so forth). Francisco stated that because there is an additional cost to the company to pay staff to constantly be watching the monitoring system at the central location, the cost of this type of security system to the homeowner is more expensive than traditional alarm monitoring services. He encouraged the audience to sign up for an appointment where TAPS staff can fully explain the system and costs, based on the individual homeowners needs and wants. Ms. Rodgers thanked Francisco and his staff for their time and the demonstration. She indicated that in addition to this service, several residents in our neighborhood already are subscribers to the Residential Patrols provided on an individual voluntary contract basis to homeowners. Those subscribers are very pleased with the service and they find the price very reasonable.

Ms. Rodgers then introduced Rayshelle Edmunds, Council Assistant to Councilmember Johnny Khamis. Rayshelle apologized saying that the Councilmember had hoped to be here, but this time of year is particularly hectic, as the Budget is about to be finalized for the coming year. She stated the Councilmember and Captain Schroder meet weekly to discuss public safety issues of concern to District 10 residents, and that neighborhood security, particularly home burglaries, is a high priority. The Councilmember has asked for additional assistance for the SJPD including increasing the numbers of Community Service Officers, so that immediate response including follow-up reports can be taken when a home burglary takes place. She mentioned that the numbers for our area recently was 4. This initiated response and discussion from audience members – as the VEP data for the same time period was larger and seems to consistently run between 4 and 10. There was agreement that there seems to be a discrepancy between neighborhood information and that of SJPD. Neighbors were strongly encouraged to be sure to report all incidents – and ask that a report be initiated at the time of the call.

Rayshelle also announced that planning for the upcoming 4th of July Fireworks and Festival was well underway, and that volunteers and donations were still needed and appreciated. This event is sponsored by the District 10 office and Councilmember Khamis to encourage residents to attend one of the professionally sponsored events, rather than being involved with illegal fireworks. She reminded everyone that all fireworks in the City of San Jose are banned and illegal. This year there is increased safety concerns, as this is the 4th year of the drought; everything is extremely dry and increases the potential for fires. Ms. Rodgers seconded that advice. VEP is a Community sponsor of the fireworks festival at Lake Almaden – including having a booth at the festival. She encouraged everyone to volunteer, donate, and/or attend (or all three) this very enjoyable event. She stated that seeing the fireworks over Lake Almaden is really special!

Since having such a large event for the public's enjoyment, free of charge, is an expensive endeavor, a fundraiser to assist in deferring the cost of the fireworks is being planned by neighborhood association Playa del Rey. It is scheduled for June 20th at Buffalo Wild Wings (corner of Blossom Hill and Santa Teresa). She reminded attendees to see flyer included in the current issue of the VEP News. (Note: the cost of this fireworks event is primarily paid for by individual donations and business sponsorships.)

Ms. Rodgers then introduced Sheila Barry, the Santa Clara County Director for the University of California Cooperative Extension (UCCE) and a Park Partner for Martial Cottle Park. She is also the Livestock Advisor. Ms. Rodgers thanked Ms. Barry for her patience in waiting. She also brought her school-aged daughter with her to the meeting.

Ms. Barry provided a brief history and overview of what the University of California Cooperative Extension is. All public universities were established through "land grants" from the U.S. government. As a result there is direct oversight by the government through the U.S. Department of Agriculture which continues to this day. California, as most of us know, is a very large agricultural state producing much of the nation's food: produce, beef, dairy, etc. So the connection and partnership with Martial Cottle Park is an exciting one. As of yet, the contract has not been signed with the County. However, everyone is anxiously awaiting for that to be finalized. It does, unfortunately take a considerable amount of time to go through the contractual process as each aspect – University, State, etc - is involved.

4-h Clubs are also under the auspice of the UCCE. Their offices are on Berger Road in San Jose. Ms. Barry also included an overview of her interest and expertise which includes livestock, or larger farm animals. Ms. Rodgers thanked her for her presentation and stated it was exciting to have an opportunity to learn more about the UC Cooperative Extension and how it will interface with Martial Cottle Park. She said she hoped Ms. Barry would come to VEP meetings in the future, to provide additional information.

Ms. Rodgers then introduced Eric Goodrich, Park Manager for Martial Cottle Park, who gave the attendees an update on the Park. There continues to be issues with Caltrans regarding the freeway overpass and the surrounding area. Unfortunately the date for finalization and opening of the remainder of the Perimeter Trail remains unknown. Ms. Rodgers thanked Eric for how attractive the planting along the Trail was looking – and particularly so for the area surrounding the pedestrian entrance at the western side of Chynoweth.

The Master Farmer – Jacobs Farm del Cabo - has begun planting. Tomatoes and flowers will be harvested this year. Unfortunately, again due to delay in the contracting process, the planting started later than they had hoped. Initial plans for a food stand and a harvest festival has begun, with both to take place in the Fall – hopefully in September.

The Park did officially open on May 15th, and the current plan is to have all that the Park has to offer fully available for the Fall Harvest Festival. While the park is now open, not all the areas and activities are as yet available for use. As a result, most of the fees will not be initiated until later this year. There eventually will be a charge to drive in and park on the property, but for now, the Park is open with free access and parking. Currently the Park staff is being cautious and protective of recently re-established grassy areas. After the damage caused by rains and some flooding in December, the grassy areas have been roped off to allow the grass to be well established prior to having heavy foot traffic on it. Watch for more information becoming available during late Summer, prior to the Fall Harvest Festival.

Prior to closing the meeting, a raffle drawing was held - always a popular part of the meeting! Ms. Rodgers thanked everyone for attending. She reminded them that VEP takes a "summer break" with the next meeting not until September. She also encouraged everyone to provide VEP with their e-mail address, as this is the primary communication tool with members during the summer months. Ms. Rodgers also reminded attendees that VEP member e-mail addresses are kept confidential, are not shared with anyone, and VEP does not overload your e-mail box with lots of e-mails – usually a maximum of 2 or 3 per month. She wished everyone a happy and safe summer. Finally, she thanked everyone in advance for helping to stack chairs and assisting in cleaning up the Community Room.

2. Mayor's Summer Safety Briefing – July 1st at Vista Park

VEP was honored to play host to Mayor Sam Liccardo's Summer Safety Briefing. This event took place outside, in Vista Park. The event was attended by VEP residents and representatives from several other District 10 neighborhoods, as well as City officials. Additionally the press attended with print, radio, and TV represented. The focus of the briefing was to highlight the new Video Camera Registry and to provide information and encouragement to residents to not purchase or use illegal fireworks (note: all fireworks within the City of San Jose are illegal), but rather attend one of the three public fireworks displays for 4th of July available within the City of San Jose.

The Video Camera Registry will assist SJPD in identifying and capturing suspected criminals. Residents who have video cameras are encouraged to consider participating in this program. SJPD would only contact you if there had been an incident in your neighborhood that the police thought might have been caught by your cameras. This is for outdoor cameras only.

The Mayor spoke first, highlighting how the Video Camera Registry would be helpful to both SJPD as well as to residents. Councilmember Khamis was next to speak. He encouraged residents to attend the Fireworks Festival at Lake Almaden. SJPD Southern Division Commander Captain, Ed Schroder, also spoke, as did SJPD Crime Prevention Specialists - highlighting the Neighborhood Watch Program, and the upcoming National Night Out event scheduled for August.

As the intention for this program was to encourage more individual residents to register their outside residential video cameras, we were pleased to have two VEP members speak briefly. Both Don Ferguson and Kathy Welch have video cameras and provided good examples of how they have helped SJPD identify and apprehend suspects. They both also stated they would certainly be interested in participating in the new Video Camera Registry. Additional information about this program is online at sjpd.org.

However, we will consider your request, if you would be willing to be a “pilot” for us. That is, help us go through what works well and what doesn’t work as well! Beginning in the middle of September, a new "HAWK" crosswalk will become available and begin working to protect pedestrians as they cross Snell at the vehicle entrance to Martial Cottle Park. Below, please find excerpts from a visual safety brochure, which provides information on this unique crosswalk. Mr. Cordell Bailey, the Traffic Safety Education Officer for the Department of Transportation for the City of San Jose, will provide a brief overview on this crosswalk at the September 29th VEP Community Meeting.

HAWK SIGNAL IN SAN JOSE

HAWK stands for **H**igh-Intensity **A**ctivated **C**ross**W**alk. It is a type of pedestrian crossing signal intended to increase safety for pedestrians at crosswalks. The HAWK signal was first developed and installed by the Tucson, Arizona Department of Transportation in 2000. The HAWK was officially added to the Manual on Uniform Traffic Control Devices as an approved signal device by the United States Department of Transportation in 2009. The HAWK has been shown to decrease vehicular crashes with pedestrians by 69% at crosswalks after installation. Studies have also shown that 97% of drivers comply and yield to pedestrians at HAWKs. The City of San Jose is installing new HAWKs in appropriate locations to enhance pedestrian safety while minimizing delays to motorists.

PROPER HAWK USAGE

To the pedestrian, the HAWK signal is very much like a standard signalized crosswalk. The pedestrian activates the HAWK by pushing the button on the pole and waits for the walk signal to appear before crossing. Pedestrians should look to ensure all traffic has stopped. During the countdown sequence, the HAWK will begin flashing red; motorists must stop at the stop bar, then proceed if the pedestrian has cleared their lane of traffic. This gives the pedestrian a protected phase to start crossing the roadway, but also helps keep traffic moving when the pedestrian has crossed. The HAWK will go dark when the walk cycle is finished.

For drivers, the HAWK cycles through: flashing yellow, solid yellow, solid red, and flashing red, before returning to dark. When the HAWK is activated by a pedestrian, the signal starts flashing yellow to alert drivers. After a few seconds, it turns to solid yellow followed by solid red. Drivers must come to a complete stop at the stop bar during solid red. After several seconds, the HAWK signal will begin flashing red. During this time, each driver must stop and then proceed through the intersection only if the pedestrian has cleared their lane. When the walk cycle finishes, the HAWK returns to dark. When the HAWK signal is inactive, drivers may proceed through the intersection. Drivers must always obey the posted speed limit and yield to pedestrians.

WHAT IS A "HAWK" SIGNAL?

"HAWK" stands for High-Intensity Activated Cross Walk, a new pedestrian crossing signal proven to increase safety for pedestrians.

1. When not in use, the traffic signal is dark, and a solid raised hand indicates **DON'T WALK** (raised hand).



Proceed with caution.



Push the button to cross.

2. When a pedestrian pushes the button, the traffic signal flashes yellow for several seconds.



Slow down, prepare to stop. Pedestrian has activated the push button.



Wait.

3. After the flashing yellow interval, the traffic signal displays a solid yellow to give motorists enough time to stop.

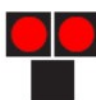


Stop if safe to do so.



Continue Waiting.

4. After the solid yellow interval, the traffic signal is solid red, and the pedestrian signal displays a **WALK** (walking person symbol), indicating that pedestrians are allowed to cross the street.



Stop.



Start Crossing.

5. The traffic signal then flashes alternate red, and the pedestrian signal flashes **DON'T WALK**. Drivers may proceed after stopping if there are no pedestrians in the crosswalk.



Stop. Then proceed with caution if clear.



Continue crossing. If walking, continue. Those who have yet to step off the curb, do not start.

6. After the flashing **DON'T WALK**, the traffic signal is dark again and the pedestrian signal indication is a raised hand (DON'T WALK) until the next pedestrian pushes the button.



Proceed with caution.



Push the button to cross.

Almaden Ranch LED Freeway Sign

At ENA's request, the Planning Director's hearing for the proposed 84 foot tall sign was deferred from Aug 12th to Sep 2nd, and a community meeting was held on Aug 19th.

About 50 people attended the Aug 19th community meeting at the Pearl Ave library. The developer noted that proposed sign height, programmable LED square footage and brightness are less than maximum allowable by the city. Community members expressed many concerns including aesthetics, brightness, traffic safety on northbound Hwy 85 (where traffic is often stopped in between Hwy 87 and Almaden Expressway), and the perceived lack of a need for a sign. A big concern regarded illumination overnight, due to our experience with the LED sign at Almaden Plaza. The Almaden Plaza sign had been on after 10 pm against its permit, and that plus a brightness issue were subsequently corrected after the meeting. The general audience consensus was that they would strongly prefer no sign at all, or to have the sign moved closer to Almaden Expressway.

About 10 residents and ENA board members attended and spoke about the same concerns at the Sep 2nd Planning Director's hearing. The developer committed to further reduce the brightness by 20%, provide ENA results of quarterly brightness monitoring, and ensure the LED portion of the sign is off between 10pm and 6am. In the end, the sign was approved, and that decision can be appealed to the Planning Commission with a deadline of Sep 14th. At this writing, an appeal is being considered. Caltrans approval is also required in order to build the sign, and that is still pending.

The sign will be 8.5 ft. higher than the tower on Bass Pro, and have an 488 square foot sign area, of which 237 square feet is a programmable electronic sign. It will be located adjacent to Hwy 85 just west of where Cherry Ave. will go under the freeway to connect with Sanchez Dr.

Life With My Animals

"He's looking at me!" "She touched me!" "He's eating my food!" "How dare he jump up on that fence without me!" These are phrases that could be visualized if comic balloons hovered over my cat and dogs' heads all day long. A few others may be: "Gotta go, gotta go, open the door..now!" "I'm starving here; feed me. C'mon, put some of that delicious wet stuff in my bowl!"

Dogs and cats are different in many ways, from how they eat and drink to how they greet you upon returning home. Cats have an attitude of arrogance (think they are better than everyone else, especially those darn dogs). The greeting from my cat depends on his hunger level: bright eyes, a spring in his step and a loud meow means "I'm hungry, where have you been?" Fall Plantings

September is a good month for planting cool season veggies, including beets, carrots, lettuce, parsnips, certain types of peas, and Swiss chard. Broccoli, cauliflower, kohlrabi, rutabaga and turnips also do well. Leaves, stems, flower heads and roots are the edible portions of these versatile vegetables, depending on the species.

Anything grown from seed (most of the above) can usually be started in August or September. Those bought as nursery-grown seedlings are usually better transplanted in September, since the same warm weather that stimulates fast seen germination can cause tender, thirsty seedlings to wilt or burn.

Root crops, such as carrots and parsnips require full sun, sandy or loamy soil, and regular irrigation. When sowing carrot seeds keep the soil moist and never let a crust form on top, or the seeds have difficulty sprouting (start indoors?). Unfortunately, parsnips never get as much good P.R. as their orange cousins. Parsnips' creamy white to yellow roots have a unique, mild flavor and can be baked, fried, mashed, or cooked in soups or stews. Cold weather makes them sweeter.

Another favorite is the humble beet. For absolute cut beauty and flavor, go for the Chioggia, also called Bull's Eye, an unusual Italian heirloom beet with concentric white and red rings inside. Albina Verduna is a sweet white beet that grows well here, and Sangria is a classic deep red, like the wine. Because it develops its shape early, Sangria also makes a good "baby beet" when pulled early.

Swiss chard, a leafy vegetable, is actually a type of beet without the tasty bulbous root, and is beautiful on the dinner table served raw, steamed, or stir-fried. It's also an attention getting ornamental in the garden, when you're touring with friends. The Bright Lights variety is especially attractive, showing up with crimson, yellow and white stems.

The obvious leafy vegetable choice is lettuce, which comes in four varieties: crisphead, like iceberg and butterhead, Bibb loose leaf, Oak Leaf, and Romaine, which grows in vertical stocks.

Finally, I trust you've been pulling the heads off those dandelions all summer. If not, you should have. Every time you walk to the car to go somewhere and you see a yellow dandelion blossom, don't think, "I'll have to dig that up when I get home." It'll never happen. Prevent that plant from multiplying by going over and plucking the blossom; if it's already progressed to the fuzzy ball, all the more important to trot over and close it into your hand and throw away, before the wind spreads the spores.

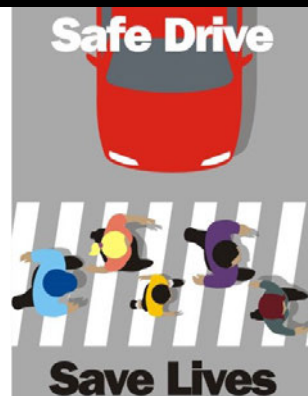

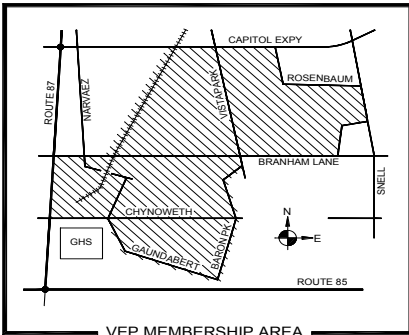
