

April Meeting Synopsis

President Rodgers welcomed a small but very enthusiastic group to the meeting. She guickly introduced Board Members and Past Presidents that were present. She announced that there would be some changes to the agenda. First Tammy Green, the Community Outreach Coordinator with the County of Santa Clara Household Hazardous Waste Program had a conflict and would not be able to attend tonight's meeting. She hopes to be able to come at a later date. She did provide interested members with some handouts regarding the program, which are available on the back table. We do have another speaker, who was available and more than willing to come tonight to provide us with information on an issue of concern to all of us who pay property taxes. This is an issue concerning the possible sale/or long-term lease of 27 acres of property currently owned by the Evergreen and San Jose City College Community College District. This property is located at Evergreen. Sandra Randles is a Community Leader and Activist who will be speaking to us about this issue later in the program. The first speaker, Nancy Creveling, who is here to present information to us on the Master Gardener Program at Martial Cottle Park, volunteered to step in, as her partner in the program, Pam Roper, (who is listed in the Newsletter as the speaker) was not able to be here tonight.

With Nancy's permission, we will however, invite our **Councilmember Johnny Khamis**, who just arrived to speak first. Johnny is always well represented at our meetings by Council Assistant Dora Gonzalez, but of course we appreciate it when the Councilmember is able to attend himself. As the Council often meets late into Tuesday evening it is sometimes difficult for him to attend our meetings. Councilmember Khamis thanked President Rodgers and said this was an "early evening", as the Council had met the previous night until almost 2am in the morning – discussing and hearing from residents regarding the issue of raising the rents 8% on older multiple units. He said he understood everyone's' concerns about how rents are going up at an alarming rate in San Jose. However these folks that own older properties are already under "rent control", while the new developments that are currently under construction are not under rent control. The older properties owners are struggling to pay taxes and then make needed improvements in their properties with this limitation. As a result, many of them can't make it financially, and feel they have no option other than to sell the property to the developers. The developers then tear down the old properties, build new ones without rent controls, and the rents go up significantly. He said that is why he is supporting the "mom & pop" owners, as he calls them, and why he voted to help the current owners with an increase to 8%. This way they can continue to offer tenants a place to live. He also talked about the proposed San Jose City Budget and encouraged everyone to attend the Community Budget meetings scheduled in each city council district. The Mayor, as well as himself, and City Staff will be there for a presentation to residents on the proposed Budget. He thanked everyone. Dora Gonzalez spoke next. She reminded attendees of the Councilmember's Community Office Hours - flyers on the back table listed the upcoming dates and times.

Ms. Rodgers also stated that a big event that was coming up was the 4th of July Fireworks Festival that is sponsored by Councilmember Khamis' office, and VEP is a Community Sponsor. Needed are sponsors, vendors for both food trucks and food booths, and volunteers to help the evening before, the day of, and the day after the event. If you are involved in a non-profit organization, and would like to have a booth at the event, there is a special rate for non-profit organizations. This is a "family-friendly event" – no alcohol sold or allowed at the Park, and it is a very exciting event. Plan now to attend with your family.

Ms. Rodgers also thanked those volunteers who came out to help with the annual Great American Litter Pickup which was held on Saturday, April 23rd. We had more families come this year. The neighborhood looks no much better as a result.

By way of announcements – plan now for the VEP Neighborhood-wide Garage Sale on Saturday, May 7th.

Ms. Rodgers introduced **Nancy Creveling with Master Gardeners**. She reminded everyone that Master Gardeners is one of the five partners with Martial Cottle Park that is listed in the original documents signed by Mr. Lester as part of the agreement he signed when he made the donation of his land. Master Gardeners is an all-volunteer organization. Nancy's role is that of Co-Liaison and Steering Committee Co-Lead for Master Gardeners at Martial Cottle Park. She is also the Advisory Board Events Chair for the University of California (UCCE) Master Gardeners Program for Santa Clara County. She spearheads the training coordination at the Park as well. The training for volunteers goes over a 4 month period.

Currently going on is the Raised Garden Beds – garden plot program. There are a significant number of programs through Master Gardeners. For instance, through UC Davis – Pests and Pest Control – they have a significant amount of gofers. There is a school garden program, including free seeds and plants, a Speakers Bureau, and a "Hot Line" – live people answer the phone during the morning hours – it is an "advice line" for any growing/ planting problem you may have. This advice line is linked to UC Davis for assistance/answers.

The partnership and property at Martial Cottle Park is a huge project for them. They have 4-1/4 acres with a budget of \$100,000. They currently have tomatoes and are available Saturday 9am to noon. They are located on the Chynoweth side (the east side of

Chynoweth down from Snell). They provide "advice to grow by" workshops - usually held on workdays: Wednesday through Saturday, 9am - noon. You can sign up on the clipboard, and/or just drop by.

They are planning to have a barn – currently putting in pathways. One issue that took them somewhat by surprise, was the lack of immediate and easy access to water for growing. This has caused some delay, and the need for additional funds. Most of their budget is raised through sales of plants etc, and/or donations. The irrigation will eventually be provided by "drip irrigation" for raised beds. Currently they have a large/involved project to <u>provide water</u> – they have to pay for a 3inch line from Chynoweth going under the path (Trail) for water. It will cost \$11,000 to get to the curb, and \$12,000 to go under the path/Trail to the fence.

For the raised beds, flowers are grown as well as food. Cut flowers will be available – and sold as part of their volunteer efforts to raise money to further their projects. They have a native plants class, a class on growing tomatoes from seeds, and one on growing succulents. At Christmas time, there will be a "wreath workshop" in early December.

There are plans for a modular building – this is where they will have <u>demonstration lawns and gardens</u>. Two of the acres will include a 70 foot greenhouse that has the expertise of a land-scape architect involved. They hope to have that up and running by Fall.

Also scheduled for Fall – October 1st, Saturday, will be the Fall Festival – plan now to attend. Ms. Rodgers thanked Nancy for her very informative and exciting presentation. Should make everyone want to become a Master Gardeners Volunteer!

The next presenter was **Sandra Randles**. As previously mentioned Sandra is an active community member and volunteer. She handed out an 'information sheet' for the audience. Anyone can request this information at All4Education@yahoo.com

Sandra informed the audience that in <u>April of 2015</u> the residents of Evergreen learned that <u>27 acres of land</u> – <u>land that is</u> <u>part of the Evergreen Valley College property, was approved</u> <u>for lease by the District's Board of Trustees to Republic Urban Properties</u>. This was a surprise and very disturbing. This land was initially obtained in 1967 for Evergreen Valley College's expansion. <u>Now it would be turned over for commercial development for up to 95 years (which essentially would mean the land would no longer ever be available for the original intention of use by the College for educational purposes for the community. In doing this, the Board of Trustees were hoping for an increase in district revenue – however this amount will be quite small – 1.5% of the \$100 million annual budget. This group of community residents believes there are much better ways for the District to fund, and/or cut costs, instead of leasing the land for 95 years.</u>

By way of a reminder, property owners (which includes this area of San Jose) pays tax into the San Jose City College/ Evergreen Valley Community College district. These 27 acres for college expansion was purchased with our tax dollars. 7% of our property tax goes to the District – that is approximately \$700/year for every \$10,000 of property value. Should the long term lease be approved for commercial (rather than for educational) purposes, residents' tax liability/bills would remain the same – the \$700/year for every \$10,000 of property value would continue to be assessed to property owners and paid to the Evergreen/San Jose Community College District.

The information sheet included several issues of concern as to how money is currently being spent, as well as how many of this District's students are going across town to DeAnza/Foothill and/or West Valley Community Colleges for classes. Many of these classes are not currently available at Evergreen (and should be). A couple of examples included the fact that Evergreen/San Jose District pays for 5 Vice Chancellors vs 3 at DeAnza - at a salary of approximately \$250,000 each. Number of students at Evergreen/San Jose is 13,000 plus students, and at DeAnza - approximately 27,400. Degrees offered at SJ/Evergreen 172 – at DeAnza 263, and so forth. The community group believes <u>much more could and should be done to increase and improve on the programs offered at Evergreen/San Jose</u>. Note: Some programs at Evergreen are highly touted with excellent reputations – the Nursing program and the Automotive programs to name two.

Additional concerns around appropriate and best use of funds spent by the district include the decision to move the District's administrative offices from Evergreen campus, to a much more expensive (and less accessible) office building in downtown San Jose.

The future of the 27 acres will eventually be determined probably in the Fall of 2016 – first by the San Jose City Planning Commission, and finally by the San Jose City Council. (Note: Usually educational issues are not determined/managed by local elected officials – those issues pertaining to education go up through a separate chain of decision makers – the Board of Education up to the State level. As this issue has to do with property-land ownership/management, it will be determined by the City Council).

Memorials to Honor SJPD Officer M. Johnson By Marilyn Rodgers

In late March, fallen SJPD Officer Michael Johnson was honored with the dedication and renaming of state Hwy 87 in San Jose (see article in April edition of VEP Newsletter). Michael was the son of long time members and Vice President of VEP, Katherine Decker, and husband Dann. Michael was killed a year ago, March 24th, while actively serving the city and residents of San Jose.

During the month of May, 2016, several memorials were held both locally in San Jose, as well as in California at the State Capitol, and in Washington, D.C. All of the memorials were to honor fallen officers, who had been killed during the previous year.

Starting the very beginning of May, the State of California had very impressive ceremonies at the Capitol, in Sacramento. This was a multi-day event to honor 4 officers killed in the line of duty last year, in the state of California. Michael was the first of four officers that were honored, which included having their names engraved on the monument at the Capitol. An additional officer was also honored. He had been critically injured several years ago, and succumbed to those injuries last year.

The ceremonies in Sacramento, were followed with ceremonies held locally – first at the San Jose Police Department in San Jose, and two days later, at the Santa Clara County Sheriff's Department. Both the City and County honored local fallen officers, including Michael.

During the middle of May, Katherine and her family, as well as many of Michael's police academy classmates, travelled back to Washington, D.C. for the national memorial. These ceremonies and activities are for all fallen law enforcement officers across the country, who had died the previous year. The ceremonies and activities at the nation's capitol are scheduled over a week's time. Included are memorials, as well as classes and other informational sessions of support for families of fallen law enforcement officers. It also included an introduction and visit with the President of the United States.

Katherine has been deeply moved and honored by all of ceremonies to honor her son Michael, as well as all of the other officers who lost their lives in service to their communities. She also wanted to thank everyone for their kind words of support to her and her family over the past year.

Mt. Umunhum Radar Tower Declared Historic By Marilyn Rodgers

As there are many members of the VEP Community that have a personal connection to, or special interest in, the Mt. Umunhum Radar Tower, the following information is being reprinted in the VEP Newsletter for everyone's information.

At the Santa Clara County Board of Supervisors meeting held on May 10, 2016, the Supervisors unanimously voted to list the Radar Tower atop Mt. Umunhum on the County's Heritage Resource Inventory. The following information was sent by Sam Drake, President, Umunhum Conservancy.

"On May 10th 2016 the Santa Clara County Board of Supervisors voted unanimously to list the radar tower atop Mt. Umunhum on the County's Heritage Resource Inventory. For the first time, the tower has official "historic" status! While listing on the Inventory does not make it impossible to demolish or decapitate the tower, it makes any such attempt much more difficult. This is a major milestone in our community's long effort to preserve the Tower and the history it represents. On behalf of the Umunhum Conservancy, I'd like to thank everyone for their support!

While preliminary, the tower's owner, the Midpeninsula Regional Open Space District (MidPen), has indicated that they will honor the supervisors' decision. Their General Manager was quoted in the Mercury News as saying "I think the tower is probably going to be there long after you and I are gone." The Conservancy is happy that MidPen seems willing to drop their proposals to demolish the tower or to reduce it to a one story shade structure.

With this objective achieved, what's next? While the tower now is recognized as historic at the county level, it does not yet have such status at the state or federal level. The Conservancy will immediately begin working on those projects.

The tower still needs over a million dollars in repairs, according to MidPen's 2012 estimate. If the tower is safe from demolition, we still need to move forward with those repair efforts. The tower must be preserved, not simply abandoned. The Conservancy has been working since 2013 to raise funds to preserve the tower. To date we have raised approximately 25% of MidPen's 2012 estimate. Many thanks are due to the wonderful individuals and businesses that have contributed to this effort to date!

At this point the Conservancy believes that the following steps are needed:

1. An assessment of the tower's current condition should be performed by an independent qualified contractor. That assessment should result in a prioritized list of specific repair projects that are needed, with an estimated cost for each. The Conservancy should pay for such an assessment and should select the contractor to perform it.

2. Repair projects identified by the assessment should be performed as funds are available. The most urgent repairs should be performed first. The Conservancy should continue to raise funds for those projects, one at a time, until the repairs required to preserve the tower are complete.

3. Follow up assessments by an independent qualified contractor should be performed every 2 years thereafter, paid for by the Conservancy.

We believe this course of action will insure that the tower is preserved for future generations while minimizing public expense and maximizing transparency.

I and the Conservancy welcome the opportunity to discuss the next steps with MidPen and hope to quickly reach a mutually agreeable plan going forward.

Chynoweth - New, Red Reflective Signs at Dead-end of West Chynoweth

For those VEP residents that live close to the dead-end of the west side of Chynoweth (south of Gunderson High School) you will be pleased to know that there are now three red reflector signs just above the street curbs and on the City side of the pedestrian entrance to the Martial Cottle Trail.

Unfortunately, over the last several months, this location has had three serious car accidents with the vehicles driving into and damaging both the street curbs, and the decorative fence at the pedestrian entrance.

While these accidents had various causes, VEP asked to have additional street lighting and additional signage to help drivers realize that this is a dead-end, with no street access through to Oakridge Mall.

Lighting and street signage has been replaced and improved. Having the red reflective signage has made a very real difference in notifying drivers of the dead-end.

VEP would like to thank Councilmember Khamis and Council Assistant Dora Gonzalez, as well as the San Jose Department of Transportation for their assistance in providing three bright red reflector signs - placed at the dead-end of west Chynoweth.

VEP Plans for a Memorial Bench / Plaque at Vista Park in Honor of Dave Fadness By Marilyn Rodgers and Rachel Witmeyer

In November, VEP sponsored the 1st Annual Dave Fadness Memorial Beautification Event. Prior to that, several people had made recommendations as to ways that Dave Fadness might be honored for his volunteerism and dedication to the Community. Several of these ideas however, cannot be implemented for another 5 to 7 years, due to restrictions and/or requirements by a variety of governmental agencies.

Along with the annual Beautification event, an additional option which can be initiated immediately is a Memorial Bench and Plaque in Dave's honor. This idea, as was the annual Beautification event, has been discussed with, and approved by, the Fadness family. With research and assistance from San Jose Parks and Recreation staff, VEP is initiating this project. The cost for a memorial bench and plaque to be placed in Vista Park will be approximately between \$2,400 and \$3,000. We know that several friends of Dave's have already made donations in his honor: to VEP, to Our City Forest, and to other worthy organizations of their choice. We all appreciate that very much. However, we felt this would be one more option for people to consider and participate in, if they wish. For Memorial Day: "The Story of Taps"

There is a myth about the origin of Taps that is circulating about the Internet. The true story is that in July 1862, after the Seven Days battles at Harrison's Landing (near Richmond), Virginia, the wounded Commander of the 3rd Brigade, 1st Division, V Army Corps, Army of the Potomac, Gen. Daniel Butterfield reworked, with his bugler Oliver Wilcox Norton, another bugle call, "Scott Tattoo," to create Taps. He thought that the regular call for Lights Out was too formal. Taps was adopted throughout the Army of the Potomac and finally confirmed by orders. Soon other Union units began using Taps, and even a few Confederate units began using it as well. After the war, Taps became an official bugle call. Col. James A. Moss, in his Officer's Manual first published in 1911, gives an account of the initial use of Taps at a military funeral:

"During the Peninsular Campaign in 1862, a soldier of Tidball's Battery A of the 2nd Artillery was buried at a time when the battery occupied an advanced position concealed in the woods. It was unsafe to fire the customary three volleys over the grave, on account of the proximity of the enemy, and it occurred to Capt. Tidball that the sounding of Taps would be the most appropriate ceremony that could be substituted."

There are no official words to the music but here are some of the more popular verses:

Day is done, Gone the sun, From the hills, From the lake, From the sky. All is well, Safely rest, God is nigh.

Go to sleep, Peaceful sleep, May the soldier or sailor, God keep. On the land or the deep, Safe in sleep.

Love good night, must thou go, when the day, and the night, need thee so? All is well. Speedeth all, To their rest.

Fades the light; And afar, Goeth day, And the stars, Shineth bright Fare thee well; Day has gone, Night is on.

Thanks and praise, For our days, 'Neath the sun, Neath the stars, 'Neath the sky, As we go, This we know, God is nigh.

Get out the vote: June 7th Primary Election

For the upcoming June 7 Primary Election, there are **City Council** elections in **Districts 2, 4, 6, 8, and 10.** You will be able to vote in these Council District races if you live in one of the City's evennumbered districts. The top two candidates with the highest number of votes will move on to the General Election on November 8.

Also on the June 7 ballot are two measures that specifically affect San Jose residents and neighborhoods:

Measure B is a proposal to increase the current sales tax by ¹/₄ cent. The City Council placed the measure on the June ballot to enact a ¹/₄ percent sales tax for 15 years. If approved by San José voters, it would provide about \$40 million annually to support basic City services such as police and fire response, repair potholes and streets, and maintain the City's long-term financial stability. The measure would require Independent Citizens Oversight with public review of spending, and all revenues controlled locally. This measure would require a simple majority vote to pass.

Measure C is an initiative to amend the San José Municipal Code regarding the local regulation of medical marijuana dispensaries. This measure was placed on the ballot through a citizens' initiative. It would amend Title 6 and Title 20 of the Municipal Code to include medical marijuana collectives as an allowed land use in more areas of the city such as agricultural, commercial pedestrian, commercial neighborhood, industrial park, light industrial and heavy industrial zoning districts. The initiative also would revise the City's current medical marijuana registration process and zoning code verification certificate process. If passed by a majority

vote, Measure C would replace the City of San Jose's current medical marijuana program with a different program as outlined in the initiative.

Protecting our animals is important, I'm happy to report that my fellow Supervisors have agreed with my recommendation to look into funding for a new animal shelter in South County. The current shelter was built over 40 years ago in a converted residential property. The facilities are insufficient, outdated, and in constant need of repair. The size of the current shelter also results in animals living in cramped conditions, which can cause stress, disease, and leaves little space to properly quarantine and treat sick animals. I have asked staff to identify the funding options needed for a new shelter.

It was my honor to serve as the auctioneer alongside Sam VanZandt of 94.5 KBAY who served as emcee for **HomeFirst's** "**Home SWEET Home" event last month**. All proceeds of the event benefited HomeFirst's work to end homelessness. HomeFirst is focused on eliminating barriers to housing and stability for the more than 4,000 adults, veterans, families with children, and youth that they serve each year.

Go Green.

You can sign up to receive the Sample Ballot and Voter Information Pamphlet electronically instead of by regular mail, saving paper.

Vote-By-Mail for Free.

Put away the stamps; the 72% of voters who vote by mail can now do so for free. The Board of Supervisors recently approved paying the postage for all vote-by-mail voters, making it easier than ever to participate in elections.

Volunteer at the Polls. Be a part of democracy in action! Thousands of volunteers are needed to help on Election Day, especially those who are bi-lingual. Volunteers receive stipends of \$115 -\$200 and must be registered voters or legal permanent residents of the United States. Students 16 years and older may apply for the Student Election Officer Program. www.sccvote.org

STOP Graffiti & Illegal Dumping I am sure all of you are as frustrated as I am when you drive around our scenic district and take in the natural beauty of it, only to be disturbed by unsightly graffiti or a sofa lying on the side of the road. We need to put an end to this blight!

To that end, on May 3rd, my colleagues unanimously approved my recommendation that we begin the Report and Reward

program to deter graffiti and illegal dumping. Mayor Liccardo, Vice Mayor Herrera, and Councilmembers Carrasco and Peralez joined me in authoring a memo that focused on ways to prevent the scourge of illegal dumping and graffiti vandalism in our neighborhoods, such as offering rewards of up to \$1,000.00 for each tip that leads to arrests or fines against graffiti vandals and those dumping illegally within San Jose. We also want to expand the use of technology to make it as easy to report illegal dumping as it is to report graffiti and help catch people who spoil our community.

Aside from offering rewards for those who turn in graffiti vandals and dumpers, the action we took this week authorize the City Manager to negotiate and execute a shared data agreement with Graffiti Protective Coatings (GPC) to make it easier for businesses and private property to easily report vandals to GPC for clean-up and to SJPD for investigative follow-up. When it comes to illegal dumping there will also be a shared data agreement that will ultimately convey reports to Code Enforcement. City staff will report back on progress toward the objectives spelled out in our memo in winter 2016. In the meantime, I want to insure that all District 10 residents are aware of the tools available to us to fight this blight. The City relies on each of us to report graffiti that we see and it is easy to do so if you have a smart phone! Just search the Android or Apple app store for the San Jose Clean app. Once you've downloaded the free app, it is extremely easy to photograph and report the graffiti, which generates a work order to get the graffiti cleaned up within 48 hours. You will even receive a message after the clean-up is completed with a photo of the clean surface (fence, wall, tree, etc.). If you don't have a smart phone, you can instead call in the location and details about the graffiti to 1-866-249-0543 or send email the information (with photos, if you have them) toantigraffiti@sanjoseca.gov .







When it comes to illegal dumping, calls are made to the City's Environmental Services Department. We are trying to bring the same efficiencies that exist in reporting graffiti to the reporting of illegal dumping, but, in the meantime, please visit this link to report any illegal dumping found in your own neighborhood, or anywhere else your travels may take you:

It's Time For A Neighborhood Watch

During the last two months, I have noticed a drop in requests for Neighborhood Watch meetings. This concerns me, because whenever I see us become complacent burglaries start to rise. Burglary is a crime of opportunity. Most burglars drive the neighborhoods before they decide to strike; this is called "casing the neighborhood." If the burglar finds himself or herself on a Neighborhood Watch block, he or she is going to think twice before deciding to break into your house. The reason Neighborhood Watch groups are so effective in deterring crime is because the neighbors in those groups are watching out for one another.



As all of you know, our police department's staffing is stretched thin and they are trying everything they can to keep us safe. In the last 60 days they have arrested 10 suspects for burglary, but they can't do it alone. We must provide them the information they need to make their job easier. Neighborhood Watch meetings are the best way to prepare our residents to do that. They teach our residents how to be good witnesses and how to identify suspicious activity that warrants a call to the police. 
