

## April Meeting Synopsis

President Rodgers welcomed everyone to the meeting and introduced current VEP Board members in attendance, Katherine Decker and Adina Pierce, as well as past Presidents. She then introduced Councilmember Johnny Khamis who had just arrived from a Council meeting.

The Councilmember discussed the issue of the VTA proposal for development at the VTA station parking lot at the corner of Branham & Narvaez. He wanted to reassure everyone that he had taken a strong position against any proposal for development at this site until the "already agreed to" needed improvements to Narvaez, Capitol Expressway, and the northbound ramp to Hwy 87 were completed. He stated that usually if the Councilmember

where the development of a project is planned has concerns and/or is against the project, **the development will NOT go forward.** This would mean that the project probably would not go forward for the next two to three years, or more, until there is a change in the Councilperson. However, there is always the possibility that the other Councilmembers may be concerned enough to vote to approve the project over the objections of the directly involved Councilmember.

President Rodgers briefly described some of the previous concerns of VEP and residents directly involved in a similar project which was proposed 10 years ago by VTA. She stated that she was pleased with the Councilmember's support on this issue particularly given the issue of needed onsite parking for any project located at this site, as well as a number of other major projects currently in development in the area: Communications Hill, and at Pearl and Capitol Expressway with the CarMax and Toyota. The Councilmember also reminded everyone about the upcoming "Great American Litter Pickup" and that Vista Park would be one of the sign-in sites for District 10.

Ms. Rodgers then introduced the primary guest speaker for the evening, Eric Goodrich, Manager for Martial Cottle Park. Eric had a very informative slide presentation for which he gave an excellent narrative. This provided the audience with information on the history of the Martial Cottle and Lester families, with particular focus on Mr. Walter Cottle Lester's mother and grandfather. It also included some visuals of the property over the years. Everyone was very enthusiastic and pleased with the presentation. Eric also provided an overview of, and information about the activities planned for the upcoming "First Annual Spring Festival" at Martial Cottle Park. He encouraged everyone to attend if possible.

The next presenter was Vice President Katherine Decker. As the previous presentations had run long, she was very concerned about the amount of time remaining for the meeting, and cut her presentation short. She had flyers and briefly described what VEP residents should be thinking about being prepared for, including doing practice exercises with our pets (the 4-legged members of our families) in the event of an emergency. She provided suggestions, including always having enough food and water for pets available in the house; it's particularly important should you need to leave them at home on a moments notice. She provided specifics about pet carriers, and already prepared kits including toys and medicine, should you need to quickly evacuate with your pets.

Ms. Rodgers reminded everyone of the upcoming VEP Annual Neighborhood-wide Garage Sale, as well as the date for the next VEP meeting: May 30th. She concluded the meeting by thanking everyone for coming, and requested that if they could assist in cleaning up the room, by stacking their chairs.

At the April 26<sup>th</sup> Erikson Neighborhood Association meeting, the Citizens for Fiscal Responsibility (CFR) provided a presentation on their goals and accomplishments. Their primary goal is to provide “citizen oversight” for responsible use of San Jose City taxpayer funds; second, to help educate both the elected officials and primary city staff, of citizen issues and concerns regarding how tax money is utilized; and third, to educate fellow citizens and encourage engagement regarding how our taxes are spent.

Dave Fadness was a co-founder of CFR, and after his death the organization that he co-founded thought it appropriate to award a commemorative honor to another citizen who works towards the goals and exemplifies the attributes Dave helped establish.



## VEP Acknowledges 75<sup>th</sup> Anniversary of WW II

As part of the last years' Memorial Day Holiday celebration, VEP started the process of first identifying, and then honoring, VEP residents that were Veterans in the VEP News. Veterans were identified as those that had served this country in any war or military action starting with World War II going forward up until the present. A second, more comprehensive list was identified and published in the November 2016 edition of the VEP Newsletter, as part of the Veterans Day Celebration.

This year, with the 75<sup>th</sup> Anniversary of the attack on Pearl Harbor in December 2016, VEP would like to also highlight one significant event/battle which occurred just four months after Pearl Harbor, known as the Doolittle Raid. Additionally, and most importantly, we would like to publicly acknowledge the World War II veterans who are still residents of the VEP community.

### Doolittle's Raid, April 18, 1942

Following the attack on Pearl Harbor in December 1941, Americans were frightened and demoralized. Approximately four months later, a daring attack made by sixteen B-25 bombers of the U.S. Army Air Corps in a joint Navy/Army initiative known as "Doolittle's Raid" provided hope and improved the morale of many Americans.

The man whose name is attached to this event, then Lt. Colonel James "Jimmy" Doolittle was born in Alameda, California and raised in the Los Angeles area. He was not only daring, but brilliant, being the first American to receive a doctorate (PhD) in Aeronautical Engineering. Of the group that became known as Doolittle's Raiders – approximately 80 strong – only four were from California. However, California had significant influence/involvement in the development of this infamous raid.

Doolittle recommended the B-25 bombers because they were "stubby" and he believed they could be used to fly off of the deck of a large naval ship. The B-25 bombers were manufactured by North American Aviation in Inglewood (LA), California in 1941. (While planes flying off of naval ships are common practice now –

in 1942 this had never been done before.) The plan went forward, and sixteen bombers were loaded onto the deck of the USS Hornet docked off of Alameda, California. (Note: This is the same location as the second USS Hornet which now houses the Doolittle Raid Museum.)

Intensive training for each bomber's five-man crew progressed quickly. The USS Hornet sailed out of San Francisco Bay toward Japan. The hope was to get fairly close to Japan before taking off. However, 150 miles further out than originally planned, the decision was made for the planes to embark. The worry was that they might be spotted before they could become airborne. All of the crews were volunteers and knew the risk they were taking. The plan was to fly over Japan, drop their bombs on industrial and military targets, and then fly toward Japanese occupied China, land, and try to avoid capture with the help of nationalist Chinese peasants. All of the bombers were eventually lost, as only one made it to China, the other bomber made it to Russia. (Bombers crash landed as they ran out of fuel.)

Of the 80 raiders, the majority survived. Eight men were captured, four of whom were later executed. Most of the men went on to continue active duty and fighting in other engagements. Fifteen of those were subsequently killed in action.

Lt. Colonel Doolittle was said to have been worried that he might face court-martial, as several of the planned targets had not been hit, followed by the loss of all of his planes. However, he need not have worried, as he and the other Doolittle Raiders became national heroes. In fact, President Roosevelt awarded him the Congressional Medal of Honor, and he was promoted swiftly, becoming a Brigadier General.

Only one Doolittle Raider survives: that is now Lt. Colonel Richard "Dick" Cole, age 101. He was Lt. Colonel Doolittle's co-pilot. As the last surviving "Raider" he has been honored during the last few months at several special celebrations.

*Note: While it is important for those of us who are the children, grandchildren, and relatives of World War II veterans to help tell the stories of the sacrifices our loved ones and others made during such an important time in our country's history, it is also important to remember that the two countries who were once our arch enemies, Japan and Germany, are now two of our strongest allies!*

## SAN JOSE HIRES NEW O.E.S. DIRECTOR!!!

The District 10 team is pleased to welcome the City's new Office of Emergency Services (OES) Director, **Ray Riordan**. Ray has a great deal of experience, having served as the Emergency Manager for the City of San Ramon for nearly eight years; Emergency Preparedness Manager for the East Bay Municipal Utility District for more than ten years; and as Senior Emergency Planning Coordinator for the Contra Costa County Office of Emergency Services for seven years.

Ray has served as the Acting Executive Director for the California Utilities Emergency Association and has functioned for ten years as Chair of the California Water/Wastewater Agency Response Network, a mutual aid and assistance network of over 350 water and wastewater utilities in California. He also assisted in forming a national mutual assistance program for water-sector utilities.

Over the course of his career, he has worked closely with public and private entities on hazard mitigation programs and on the planning, implementation, and execution of emergency response plans for a wide array of local incidents and major emergency events throughout the nation. The results of his work have been recognized nationally by the Community Preparedness Awards of the Federal Emergency Management Agency (FEMA) and by the Partners in Preparedness Awards from the International Association of Emergency Managers (IAEM) who represent over 5,000 emergency managers nationally. Additionally, he received awards for outstanding excellence in emergency management from the California Emergency Services Association, representing over 600 professional public and private sector emergency managers across the state.

Ray is a Certified Emergency Manager through IAEM, in recognition of meeting high professional standards in the fields of emergency management and disaster recovery, and he is a FEMA-certified trainer for emergency preparedness and response.

He has a Bachelor's Degree in Psychology from Santa Clara University and a Master's in Psychology/Industrial Organization from San José State University. We look forward to working with Ray to bring District 10 to a level of readiness that is worthy of all the interest and volunteerism we see here every day.


