School district representation divides our membership area along Vistapark Drive. To the East we have the Oak Grove Elementary School District and East Side Union High School District. These represent Parkview Elementary, Herman Jr. High, and Andrew Hill High School. West of Vistapark Drive, there is one school district, the San Jose Unified School District, represented by Belden and Carson Elementary, Steinbeck Jr. High, and Gunderson High School.

In order to accommodate the different issues and candidates from these districts, there will be <u>TWO</u> meetings the night of February 9, both at 7:30 PM. The Candidates Night for those in the San Jose Unified School District will be held in the Forum at Gunderson High. For those living east of Vistapark Drive, please come to Parkview Elementary School, 330 Bluefield Drive. Both meetings will feature school board candidates and both will have interesting keynote speakers to help in this effort to improve community understanding and involvement in education.

Randy Saugstad, Principal of Parkview Elementary, will lead off the meeting at Parkview. His topic will be the special revenue limit increase at stake in the Oak Grove District. John W. Anderson, President of the Santa Clara County School Boards Association and a member of the Santa Clara Unified School Board, will introduce the evening agenda at Gunderson with a discussion of the authority and limitation of school boards.

The March 8 election pits eleven candidates for two vacancies on the SJUSD board and twelve candidates for three openings in the East Side Union District. A special revenue limit increase is at stake in the Oak Grove District where nine candidates vie for three board positions.

Cooperating with VEP in urging voter turn-out are Belden, Carson, Parkview, Steinbeck, and Gunderson parent-teacher organizations. Avail yourselves of this opportunity to meet the candidates and discuss the issues before going to the polls. Let's have a 100% voter turn-out from VEP Country on March 81

Block Parent Coordinators met with VEP at the home of Rosemary Capitalo on January 18 to discuss recruitment progress for this school year. We are proud to announce that significant progress is being made toward our goal of having every street covered by at least one Block Parent. Each school now has more than fifty Block Parents; last year we only had about 50 total.

The January 9th Mercury-News stated in a feature article on Child Molesting that "In a (recent) three month period in San Jose, 36 cases of child molesting were reported." That averages 12 per month! It can happen in our neighborhood to our children. Attempts here have already been reported and, according to that article, many cases are not reported to avoid implication of family, friends, and neighbors.

It takes only a few minutes to fill out an application and chances are, you will never be called upon. Did you know that streets with many Block Parent signs will deter not only child molesters, but other criminals as well because they do not want to be identified and know that Block Parents are alert and aware.



#### STREETS UPDATE

- SNELL/ROSENBAUM Continuing improvements at this dangerous intersection are expected through the month of February. A work order has been submitted by the Department of Public Works to paint a right turn lane on Snell for south-bound traffic and a center line on Rosenbaum up to this intersection. No word yet on progress by the City Council toward an established and posted speed limit on Snell.
- PEARL/OGAN Despite the addition of signalization and overhead lighting there, this intersection continues to be the scene of serious accidents. Discussion between the City and new retail tenants at Cakridge Mall, once showing promise for a complete realignment of Pearl to eliminate those dangerous sharp bends, now centers on a plan to merely widen the existing roadbed to 4-lanes. VEP feels that this would be ridiculous, but the City sees it as a no-cost alternative since the widening would be paid for in its entirety by the new Cakridge tenants, while a complete realignment and widening would require additional City funds and condemning some additional land. The City is hesitant to condemn and claims not to have the required money. The resulting plan merely defers the ultimate need for realignment to a day when no outside money will be available.

Write or call your Councilmen--let them know what you think. In the meantime, please be careful!

- •BRANHAM/LICK BRANCH The City, PUC, and SPRR are expected to reach a formal agreement which may result in the opening of Branham Lane as early as the third week this month.
- •SCHOOL CROSSINGS All new crossings are now complete in the Carson area. Please make special note of all such crossings, urge your children to use these exclusively, and be sure to heed their warnings when behind the wheel.

REMEMBER - The speed limit in VEP neighborhoods is 25 MPH.

Please observe this limit.

Editor:

Sooner or later, someone from your area is going to visit a place where Light Rail service is provided. Maybe it'll be the Philadelphia suburbs, Sha'ver Heights (an exclusive Cleveland suburb), Burope, or even San Francisco. When they do, they'll note that the electric cars ma've very little noise. They may see how inconspicuous the track and its single contact wire are (especially when compared to the usual busy highway). They'll note that the electric cars are providing a highly-appreciated travel mode, and one which fits quite well into residential areas.

When that happens, V.E.P. people will realize that they've been fooled -- and that they've been deprived of a useful and attractive transit facility. They will then, of course, be quite unhappy with those who misled them. And "misleading", unfortunately, has been noted in the V.E.P. Light Rail arena. As an example, note the letter in the January issue of the V.E.P. News -- in particular, its claim that "present plans call for an increase in property taxes for homes close to the line". This is not true. There has been a federal guideline set up that suggests that new transit be financed in part by "recapturing" the increased tax yield resulting from increased property values on land surrounding stations -- but that's ALL. If, as V.E.P. leadership has claimed, land values will be reduced as a result of the new transit line, then there is no increased value to be recaptured. They simply can't be right both ways, can they?

I hope that all folks who are truly interested in better transportation, better communities, and better life quality in our valley will investigate the Light Rail matter for themselves. That's the only way that well-founded decisions can be made. One simple way would be to go to San Francisco, to see and hear the old Light Rail cars in action -- and realize that the modern ones propsed for Santa Clara County will be even better.

Thank you to everyone who joined the VEP Homeowners Association in response to our December Newsletter item and the furnace suit mailing.


Several membership facts may need refreshing - membership is on a yearly basis January through December.
