GUADALUPE CORRIDOR MEETING SCHEDULE

You should have found a light green flyer in this newsletter—a copy of the schedule of meetings through February 25th on the Guadalupe Corridor Alternatives Analysis. Although this flyer will arrive too late for several meetings listed, there are a host of others for which you will have adequate time to flan attendance. You should.

By January 21st the Interim Findings Report (IFR) will have been presented for public review. This report narrows the field of alternatives for construction in the corridor to those few most likely for ultimate selection late next summer. You should be interested in what those alternatives are; one of them could be Southern Pacific commuter trains on the Lick Branch behind Vistapare homes. The IFR will be approved in the meeting on February 25th pursuant to "fast track" pre-preliminary engineering work on those modes chosen.

Despite repeated efforts in these columns to 'get the word out' to this community regarding these meetings, the response has been absolutely underwhelming! Evidently only two families from this 2000-home tract have a commute problem or are concerned about traffic conditions. Perhaps it's because no one else cares that \$813,000 is being spent on a study on how to spend another 200-million tax dollars building a facility to "serve our needs". Will your needs be reserved? Do you think that government officials are busy trying to second-guess the needs of the silent majority just because that's what they're paid to do? Humbug. Our elected representatives hear only the bureaucrats and the extremists who show up at these expensive meetings.

Moreover, if you think government is busily working on extensive plans to relieve traffic congestion in our part of town you're crazy! The Guadalupe Corridor is likely to be all we'll get through the end of this century— and it won't be under construction for at least another five years. It may only be a dream too unless a clear voice is heard in affected communities like ours. Face the facts: Through local inaction we've virtually lost the West Valley Freeway (Rt. 85), and the plans for an eight-lane freeway in the Guadalupe right-of-way that our community was planned around have been abandoned also. There are no plans to widen Rt. 101 south of Tully, etc., etc., etc. There's only planning for growth.

So, next time you're in your car in a traffic jam, think of that misery as a life sentence, friend; no matter how young you are, you'll be in an even worse traffic snarl the day you retire unless you get involved in a solution immediately. Many south San Joseans are approaching two hours per day in commute time to their north/west valley jobs. If only you would spend 5% of that time seeing to it that something be done to afford ultimate relief, years could be pared from that life sentence and our beautiful valley could be spared the obvious destructive side effects. You can start by lobbying at meetings announced in the flyer. Set government's priorities straight. It's your money— and your life.

It's up to you.

The Board meets at 70 West Hedding Street (San Jose Civic Center) every Monday and Tuesday at 9:30 a.m. School policy is set by boards of trustees for each school district. V.E.P. is covered by three districts: all schools west of Vistapark Drive are in the San Jose Unified School District; schools east of Vistapark Drive are in the Oak Grove Elementary and East Side Union High School District—call for schedules of twice monthly evening meetings. Public participation is encouraged.

HOW TO USE SMALL CLAIMS COURT

Judge Mark Thomas of the Municipal Court System visited us at our November meeting and pointed out the basic considerations to employ when appearing before a Small Claims Court. First of all, admissable evidence includes just about anything, including hearsay, opinion, etc. Secondly, one's own sincere story of what happened my be the best "case" one could put together. In short, be natu 1.

sue someone in Small Claims Court? What does it cost \$\$3.00 to process and mail the notice-tofiling fee of \$2. appear to the dependent (there's a \$15.00 charge if you want the defendent series in person). There are 10 locations in Santa Clara County more court is held. No lawyer can represent you in court, to one can be present to advise you. This generally works to your disadvantage, however, as any judge will conduct the court in such a way that both parties have equal rights.

Once you're in court, the proceedings will usually take no more than 10-15 minutes. A judgement will be rendered then and there, unless the parties seem to be aggravated, in which case the decision will be mailed. If the plaintiff (accuser) loses, he has no right of appeal; the defendent however, may appeal a decision that goes against him.

If you win a case, there's no oblinion on the part of the court to collect. That's your property, and decision, you may place a continuous on the defendent's property; if he has no apparent property; if he has no apparent

Generally, the Small Claims Court it seen as a convenient way settling neighborhood disputes or to rediess an injury. The limit for claims is now \$700, but it's expected to go to \$1500 shortag.

CRIME IN THE STREETS (and Circles and Drives and Courts)

Last December, the VEP received a letter from a member who is concerned about vandalism in our neighborhood. He has had eggs thrown at his house (he's ready to paint it egg-yolk yellow), his car battery has been stolen, the car egged, 30 Italian Cypress trees have been uprooted and tossed in the street, and his home has been burglarized twice. The police don't even bother to come out anymore; they just take a report over the phone.

He also talked to one of the construction workers putting in Parkview III Park. The worker said he's never seen vandalism anywhere as bad as it is here, and he's been building parks in the Bay Area for years. "For example," he said, "one night I stayed here 'til 10 pm to guard a section of freshly poured cement. I returned at 5 am to find the whole project destroyed by bicycle tracks."

The VEP would like to start putting together a list of incidents like this, and when the list gets long enough, we can present it to the city council the way other homeowner groups in this area have been doing. If you are having problems, report it to the police (even if they won't actually come out here), and write a note to the VEP about it. (The VEP's P.O. address is on the back of the newsletter each month.) We will protect confidentiality of your letters, but anonymous letters won't be any help.

We need to convince the city council that the crime problem down here is real, even if we don't have the glamorous, flashy kind they have downtown.

Meanwhile, do you know where your kids are?
