### Volunteers needed for beautification projects

VEP has two projects scheduled for April. We'll need your help to get these tasks done—the more help we have, the less time and effort each of us will need to expend. Please call me at 578-6428 or email me at <a href="mailto:drfadness@earthlink.net">drfadness@earthlink.net</a> to be added to our volunteer list for one or both of these projects. I need to hear from you.

1. <u>Saturday, April 1 at 9 am</u> = Prune palm trees on Chynoweth Avenue.

We've always pruned the Chynoweth palms in January, but are doing it later this spring because in past years church groups expressed interest in getting fronds from us for their Palm Sunday (April 9) programs. In case we don't get the pruning done in one day, starting on April 1 will give us time during the week to finish.

Meet at the corner of Chynoweth/New World. Bring an aggressive pruning saw (saber-type works best) and a step ladder, if you have one. If you need a saw or ladder, let me know a few days in advance. Wear old clothes, with long sleeves, and sturdy gloves and shoes. The best approach is to work as two-person teams, one cutting, the other stacking fronds. Stackers won't need saws or ladders.

2. <u>Saturday, April 22 at 9 am</u> = Plant oleanders at Vistapark/Branham.

We'll plant miniature oleanders along the front of the new wooden sound wall at Vistapark Drive and Branham Lane. The city is supplying us with 70 new 15-gallon plants.

Meet at the corner of Vistapark/Royale Park Drive. Bring a spade, a bow rake, a broom, and sturdy gloves and shoes. Wear old clothes and sturdy gloves and shoes.

VEP volunteers will have to remove the existing shrubs, first. If you'd be willing to help with that work, we'll set a time that's convenient some time before April 22. Our plan is to pull the old shrubs using a truck and chain.

With sufficient volunteers, these landscaping tasks should each only take a couple of hours—we'll be happy to have your help for whatever time you can give us, though.

VEP is planning an election forum for the June 6<sup>th</sup> primary election. We anticipate the event will be held in late April or May in the Gunderson Theater. Watch for the final date, time, and location in your April VEP NEWS and by email.

There are many offices being contested on this ballot: Mayor; District Attorney; Sheriff; Board of Supervisors, Districts 1 and 4; County Assessor; 23 superior court judges; Santa Clara Valley Water District Districts 1 and 4; Santa Clara County Open Space Districts 2, 5, 6, and 7; and several statewide races, including governor. We now also have the Santa Clara County ½-cent sales tax measure.

We intend to cover the mayor's race and the  $\frac{1}{2}$ -cent sales tax in our forum.

#### Work to start on Martial-Cottle Park

The Santa Clara County Parks and Recreation Commission reviewed the Department's FY2007 (beginning July 1, 2006) Capital Improvement Plan at its March 1<sup>st</sup> meeting. \$700,000 is allocated in the plan for Martial-Cottle Park. Of that amount, \$400,000 is for preparing a comprehensive master plan, including CEQA environmental documents, and \$300,000 is to develop access and community gardens as a first-phase development of the park.

The \$700,000 funding for activities in FY2007 are coming from two sources. \$250,000 for master plan development will come from the Parks and Recreation Department budget, supported primarily through the County Park Charter Fund, coming up for renewal on the June, 2006 ballot. In addition, the Santa Clara County Open Space Authority approved a grant of \$150,000 for the master planning process at its February 9<sup>th</sup> meeting. The Open Space Authority also granted an additional \$300,000 for the Phase 1 improvements at the same meeting.

The Parks and Recreation Commission will consider recommending the Capital Improvement Plan to the County Board of Supervisors at the Commission's April  $5^{\rm th}$  meeting.

### Lester Property (Martial-Cottle Park) patrolling

Starting in February, the Lester Property (Martial Cottle Park) was included in the regular rounds made by County Park Rangers assigned to the Hellyer, Coyote Creek Parkway, and Santa Teresa Parks Unit of the County of Santa Clara Parks and Recreation Department.

Park Rangers assigned to this responsibility are pleased to know that VEP members have a special interest in this property, and they are eager to enlist our assistance. If you observe any inappropriate activity in or around the property, they would appreciate a call. Their contact number is (408) 225-0225.

- San Jose's Department of Transportation expects to have signs posted by the end of this month prohibiting commercial vehicles in excess of five tons on Vistapark Drive, south of Capitol Expressway. This restriction will apply 24/7.
- Santa Clara County Roads and Pinn Brothers Housing have signed a landscaping maintenance agreement. This clears the way for Pinn to complete landscaping work in the median of Capitol Expressway, Snell to Bluefield. They will plant remaining trees and apply ground-covering mulch that will make our reach of Capitol one of the most attractive in the entire County Expressway system.

Pinn built the high-density residential units on the northeast corner of Capitol and Vistapark. Before their project was approved by the city council in December 2001, VEP asked for and Pinn promised to donate a range of amenities; landscaping the Capitol median was one of them.

- VEP's proposal to landscape the median triangle on Rosenbaum Avenue (at Capitol Expressway) is still on hold. We're asking County Supervisor **Don Gage**'s help in winning approval to beautify this site as a volunteer project.
- VEP has offered to landscape the barren parcel at the northeast corner of Branham/Narvaez. San Jose's Department of Transportation has given us the go-ahead to proceed. Working with our city arborist, we now have a landscape design.

To avoid difficulties we've encountered in other beautification projects like this, we're wisely pursuing the installation of water service there before getting underway. VEP volunteers will plant 33 trees and apply ground-covering mulch like what we used on the Narvaez median island across Branham Lane. Watch this newsletter for updates.

• VEP is working with San Jose's Department of Transportation to find ways to discourage speeding on Chynoweth Avenue, Gaundabert/New World to Pearl Avenue. Speeding there has been chronic and city engineers are proposing "traffic calming" techniques. Expect to see the discussion of a proposal on an upcoming VEP meeting agenda, perhaps by May of this year.

A new website has been created to help you find out what sex offenders may live near you. To do so, go to the website www12.familywatchdog.us and enter your address. You'll get a map very much like a Mapquest or Yahoo map, but with colored boxes indicating locations of registered sex offenders. Click on the boxes to get the name, picture, and offenses of the person at that location.

Note that Nevada, Pennsylvania, Oregon, Rhode Island, South Dakota, and Vermont do not currently provide addresses for registered sex offenders.

VEP *never* makes major decisions without notice that they'll be discussed and debated at a scheduled general membership meeting (open to the public). After discussing them, we ask for a vote by members present. If even *one* member raises a reasonable concern during this process, we always do our best to accommodate them.

When you call us, PLEASE let us know who you are and how we can get back to you. Help us do our job by working with you.

### South substation for San Jose police

In March 2002, the voters in San Jose approved a general obligation bond measure to construct and renovate police and fire facilities. The largest project in that bond measure is the construction of San Jose's first police substation.

This substation is needed for San Jose because our police department is currently centralized and it can take 30-minutes for our officers to travel to their patrol beats in the Almaden and Blossom Valley neighborhoods of south San Jose. Staging and deploying our officers from the new substation will mean more productive patrol time for our residents and businesses.

The substation will be a full-service facility where any resident, visitor, business, or employee can conduct any police related transaction they need to. The substation will house patrol officers, investigators, police records and information, Megan's Law computer access, a community meeting room, and a processing area for those in police custody.

The city has purchased a 10.5-acre parcel for the substation on Great Oaks Boulevard, just north of the Highway 85 and Great Oaks interchange.

The total project budget, including the land acquisition, is \$65 million. The project design will be completed in September of 2007 and the construction will be complete in July 2009.

### Oak Grove School District news

Now is the time of year when many parents begin to register children for kindergarten. This is a momentous occasion for any family. I want to take a moment to share with you what the Oak Grove School District has to offer.

~ Our students are succeeding ~

Our student state testing results continue to increase in all tested subgroups. We met all 2005 State and Federal performance targets in all areas.

Fifteen of our schools have been recognized as Distinguished Schools, including all three of our intermediate schools. Two more schools are currently being considered for Distinguished School status and are likely to receive the award.

For our accelerated high-achieving students, we offer geometry at the intermediate school. Our success rate is among the highest in the county. (If you are a kindergarten parent, this may seem like a long time away, but I thought you may like to know that students receive accelerated instruction where appropriate.)

Eighteen school and District programs have received the Santa Clara County School Board Association's *Glenn W. Hoffmann Awards*, the highest total in the county. We also have received two prestigious *Golden Bell Awards* from the state California School Boards Association, most recently in 2005.

We were recognized in 2005 by Springboards Schools and Applied Materials by receiving their overall District Achievement Award.

~ Quality educational programs ~

We continue to have small class sizes of 20-to-1 in all kindergarten though third grade classes. Furthermore, we are one of just a couple of districts that have all-day kindergarten at all schools.

All schools have a Visual Performing Arts instruction at grades 4-6.

We target instruction for high achievers with pre-algebra at all K-6 elementary schools, including after school academies.

For students needing additional help, summer school and extended day and week academies are provided.

 $^{\sim}$  Parent and community involvement and support  $^{\sim}$  Thanks to community support through passing a school bond, our school facilities have been modernized and upgraded significantly. Because of an existing Parcel Tax first passed in 1991, we have been able to maintain critical programs.

We listen to parents and attempt to meet specialized needs. Our most recent new alternative parent participation program is the INDIGO program, which is housed at Frost Elementary School and emerged as the result of parent request. The Independent Study and Bilingual Waivers Programs emerged in the same manner.

~ Our schools are clean and safe ~

All schools have Emergency and Safe School Plans, reviewed and modified annually as necessary. Our school facilities have been upgraded to the highest state standards.

~ Our employees care ~

Our dedicated teachers participate in a strong professional development program. We strive to have all students succeed. When parents bring issues before us, we will do all we can to meet your needs.

Finally, we are a very open school district with a stable Board and administration that provides strong fiscal oversight in providing a safe and academically challenging school environment. We encourage and have a lot of parental involvement and opportunities to participate in the decision-making process at both the school and district level.

### VEP highlights 2005

As we enter our 37th year, our all-volunteer organization celebrated a record year of achievement in 2005, setting records in paid membership, monthly attendance, beautification projects, and bonds with our members, schools, local businesses, and government. Here are some of the keys to our success.

Monthly meetings. VEP executives meet monthly to conduct business and prepare for eight general meetings each year. In 2005, our topics ranged from neighborhood issues to West-Nile virus to government policy discussions. We always feature appropriate experts, elected representatives and decision-makers as guest speakers. We publish and mail a 16-page newsletter to all members every month that school is in session.

**Goal setting.** Each summer our Executive Board compiles a detailed set of Goals & Objectives. Debated and approved at our September general meeting, our G&O serve as our marching orders for the coming year, and the basis for a "wish list" we distribute annually to our city and county representatives. Our success springs from being organized, focused, and willing to work smart and hard to reach our goals.

**Community Beautification.** Each year VEP completes at least two beautification projects and maintains those done in past years. We've participated in San Jose Beautiful's Daffodil Days event for the last five years, and we've planted over 200 trees since 1995. ### The view from city hall

-Nancy Pyle, District 10 City Councilwoman On countless occasions my office receives e-mails and phone calls from residents concerned about community safety. As these individuals work with my staff, we are better equipped to report safety concerns and find solutions to these problems. I believe this interaction is critical to the health, safety and success of our District. Additionally, it also reflects the importance of being an active resident when it comes to local community safety.

Just a few weeks ago, a distressed resident e-mailed my office with concerns over his family's shopping experience at a local shopping center. After writing a response to the e-mail, I was able to coordinate a meeting between Captain Farmer of the SJPD, myself and the shopping center's General Manager.

Outcomes of this new working partnership have included plans to increase the presence of security and an ongoing collaboration between the shopping center, the SJPD, and VTA to deter unwelcome and problematic guests.

In addition, I plan to increase my office's outreach to local schools, working with the administrations to support and ensure the safety of our community's greatest asset, that being our children.

Through the vigilance of proactive residents, my office is able to remain informed of your concerns and act quickly to ensure the comfort and safety of all District 10 residents. Each of you can be just as active in our community when it comes to safety.

As a District 10 resident, your safety is one of my top concerns.

<u>Volunteer needed</u>: A bicycle "Roadeo" is a simple bike course designed to teach children basic skills needed to be a safe bicyclist. ### Granny units

On November 29<sup>th</sup> last year, the San Jose city council approved a pilot program to allow up to 100 new secondary "granny" units to be built in San Jose during 2006. According to the March 2<sup>nd</sup> Almaden Resident, only one permit has been issued to date, citywide, and only seven more applications are in process.

On March 14<sup>th</sup>, the city council voted not to levy parkland dedication/parkland impact fees to people building granny units. These fees could have cost from \$5,000 to \$15,000.

In my opinion, it still seems to me the city could have generated more affordable housing units by simply buying them outright than by spending all the money it did on nearly two years of studies, meetings, and hearings on granny units.

#### March madness

-John Marks, VEP's Green Gardener It's truly maddening when you can't get out there and dig around because of the rain. The ground is muddy, the lawn is soggy, and there's so little warmth that seeds barely have the urge to sprout. Although, I must admit, I've got snow peas about a foot high now; but it took a month.

Have you noticed? Weeds come slithering out of the soil with the slightest tug. Now's the time to scout around, pulling up those milk weeds and others you can spot.

What about those little six-packs of tomatoes and peppers that are beckoning from the nursery shelves? Go ahead and buy them, but keep them indoors in a sunny window to help them grow bigger and stronger (you'll save a bundle from what you'd have to pay later for the same size plants). Move them to four-inch containers, then to one-gallon buckets outside as we get closer to May. What exactly are we waiting for before planting them? Consistent daytime temperatures of 70°F.

Right now, you can plant winter vegetables such as broccoli, cabbage, peas and beets for a spring harvest. Put in pansies, snapdragons and calendulas.

You can prune now, too, especially roses and fruit trees.

Now is also the time to start summer vegetable and flower seeds indoors to transplant outside when the soil warms. Get peas, lettuce, spinach and carrots going from seed. You can also put in broccoli and cauliflower transplants. Don't forget summerblooming bulbs, corms, and tubers, including begonias, calla lilies, canna lilies, dahlias, and gladioluses.

Cold, damp weather will bring out snails and slugs in droves. They will feast on the tender new growth of bulbs and winter

plants. Hand pick, or use a bait, but don't let them go unchecked because they will mow down your garden.

When will the soil be ready for general planting? Squeeze a handful of soil; if it sticks together like putty, it's too wet. If it crumbles and falls from your hand, it's OK to dig and plant. It takes at least five rainless days for soil to dry out.

To help the soil dry out, rake up leaves you might have missed earlier and get them off the lawn. Leaves provide hiding spots for over-wintering insects.

What about feeding birds? They're building nests and starting families. You can attract hummingbirds to feed in your garden by planting fuchsias. Planted now in partial shade and away from drying wind, fuchsias will bloom from early summer until frost. Fuchsias can be planted in the ground or in containers, and trailing types do well in hanging baskets.

The trick to fuchsias: lots of moisture and using a potting mix that retains moisture. They also benefit from mist spray. In containers, use wood or light colored plastic; dark plastic pots retain too much heat, and feeder roots can be burned. Encourage bushy, flowery growth by pinching dead blossoms, and use liquid fertilizer. The more small pinches you make now on growing tips, the more flowering branchlets you'll have this summer.

Use herbs as landscaping plants. Chives and parsley add attractive foliage among blooming flowers. Rosemary and woolly thyme will take off and make attractive, drought-tolerant ground covers.

Wildflower seeds can still be sown and are suitable in many areas where other plantings don't seem to thrive.

# Emergency preparedness resources

If you have decided that you want to become better prepared in case of an emergency or disaster, but are wondering where get supplies and equipment, the following information may help you get started.

First, plan to attend VEP's *Home Faire* on Tuesday, March 28<sup>th</sup>. A few disaster/emergency preparedness vendors have been invited to participate.

Home Improvement stores such as OSH, Home Depot, and so forth are places to start. They carry items such as flashlights, storage containers, straps and other materials to hold furniture and large appliances in place, and emergency generators.

Grocery stores have bottled water and packaged food items.

Military surplus and sporting goods stores have a variety of survival and/or camping gear with such items as sleeping bags, tents, canned foods, lanterns, and clothing and boots.

There are also specialty stores for disaster/emergency preparedness which have stores and/or websites. Many of these stores/websites develop made-to-order kits which include food, water, first aid kits, etc., for families of two or four, or kits for your office or car. Additionally, they offer everything from water to individual items of interest for preparing for emergencies.

When SummerHill Homes approached us about the 78 new homes they planned to build at Branham and Vista Park, VEP leaders saw an opportunity of a lifetime. We pitched our idea to SummerHill and then-city councilmember Pat Dando. Together, we brokered a deal to allocate the parkland dedication funds from those new homes to building the community room and restroom facility that officially opened on March 18<sup>th</sup>.

Unfortunately, as with all parks, libraries, and community centers in San Jose these days, there is very little operating money available. Thus, while VEP will now have a new home for our meetings, there won't be city funds to run recreation programs at building for the foreseeable future. The room is available for rent by groups like VEP, boy scouts, private birthday parties, and so on, but the rental fees and deposits are fairly steep (VEP got a break in recognition for all we've done to make the building possible).

So what's next? Glad you asked...

We need to know what types of programs and activities YOU want to see at the community room: Daycare, after school care, senior programs, enrichment classes, what's your vision??

Would you like to volunteer to make that possible?

Do you know of a service provider who could provide these programs at a reasonable cost? They may be able to get a credit towards their rent of the building in recognition of services provided to the community, but they would need to pay their own staff and janitorial costs.

### Animal shelter life

I am a new volunteer at an animal shelter. Although I have yet to put in my first hour as a volunteer, I've been through an orientation and a couple of classes on how to handle dogs and cats. I already have to face some hard realities about life in an animal shelter.

The dog the shelter's animal behaviorist used as an example on dog handling is due to be put to sleep tomorrow. Ah, you think, dog handling, demonstration dog; the dog must be a problem, right? No. I am a new volunteer, remember? The shelter doesn't let volunteers handle problem animals, and if they were going to, it wouldn't be new volunteers handling them. I'll tell you more about her later.

Let me tell you about some of the hard realities in an animal shelter and, before you run to get a sign and start picketing outside a shelter upsetting the animals inside with your noise, I hope you will hear me out to the end.

A shelter's staff does everything it can do to make life easier for the animals in its care. The animals it euthanizes are old, physically or mentally sick, or injured. They can also be young and healthy but, unfortunately, no one wants them and they are taking up space another, possibly more adoptable animal might occupy. The staff works with the animals daily and gets to know them very well, so it hurts them horribly every time an animal has to be euthanized to make room for another one.

Shelter life is hard on a dog. They are stuck in a cage for days on end, watching people go by. Neighboring dogs are barking. Soon stress and the over-stimulus takes its toll and the dog starts going a little crazy, developing behavior problems. Volunteers at the shelter try to make life a bit easier by taking the dog on walks now and then, but some of the dogs are not mentally able to live life in a cage. Their behavior and mental condition deteriorate and the dog is "put to sleep".

Shelter life for a cat is even more difficult. In addition to the stresses that dogs have, cats are highly susceptible to diseases which may get them killed.

Why does a shelter have to kill at all? There are "No Kill" shelters, but they carefully pick and choose the animals they accept, giving preference to those they think they can quickly find homes for. They leave the old, the sick, the injured, and the difficult ones to city-run shelters, who have to take every animal. Like city shelters, "No Kill" shelters have problems with space and they want to get their animals in and out quickly to make room for more.

The dog I mentioned earlier, Renee, is a perfectly happy, sweet, playful 8-month old dog. She is learning to walk nicely (without pulling) on a leash and will sit on command. She likes playing catch and fetching. Yet the shelter is about to "put her to sleep". Why? She is a pit bull terrier—a "pit bull". The staff at the shelter says that 30% of the animals they take in are pit bulls. Most of them never get adopted.

Few of the adoptable pit bulls ever make it up to the public viewing area where they can be adopted. Of the ones that do get adopted, many are returned to the shelter.

Pit bulls have a bad reputation. However, a dog behaviorist evaluates each dog in the shelter. Those put up for adoption have passed his tests. They are good dogs.

Before I met Renee, I don't think I ever would have considered a pit bull. Now I'm very sorry I can't take her. I wish someone would save her life. Unfortunately, she's been up for adoption for over two months. That's much longer than the average dog gets and she's taking up space that another dog might have, a dog that could get adopted.

Now, in memory of Renee, who will be dead by the time you read this, I would like to ask three things of you. Number one, before you buy an animal, be it a puppy or dog, kitten or cat, rabbit, etc., please visit a shelter to see the animals they have up for adoption first.

My second request is that you consider having your animal spayed or neutered. Reducing the stray population may give shelter animals a better chance when waiting for adoption.

Finally, since many the dogs are surrendered to shelters because of behavior problems, please consider taking your new pet in for a basic training class before problems develop.

Here's a new twist scammers are using to commit identity theft: the jury duty scam. Here's how it works:

The scammer calls, claiming to work for the local court and claims you've failed to report for jury duty and a warrant has been issued for your arrest. Catching you off guard, the scammer then asks you for confidential information for "verification" purposes.

Specifically, the scammer asks for your Social Security number, birth date, and sometimes even credit card numbers and other private information--exactly what a scammer needs to commit identity theft.

So far, this jury duty scam has been reported in Michigan, Ohio, Texas, Arizona, Illinois, Pennsylvania, Minnesota, Oregon, and Washington.

In reality, court workers will <u>never</u> call you to ask for social security numbers and other private information. In fact, most courts follow up via snail mail and rarely, if ever, call prospective jurors.

<u>Never</u> give out your Social Security number, credit card numbers, or other personal confidential information to anyone who calls you.
