## 2009-2010 Goals and Objectives

1. Continue to improve our community and our association.

A. Values: Place first priority on volunteer efforts that reflect member-endorsed improvements in our community.

**D. Continue to work with the City to implement the master plan for the immediate area surrounding the Vista Park Community Room and secure funding for the plan's implementation.**

D. Monitor opportunities to build a city park at Capitol/ Narvaez.

E. Work for real improvements in traffic level of service at Capitol/Narvaez/northbound 87 onramp.

F. Work with the City to ensure that impacts of any proposed development along the Guadalupe Corridor are fully mitigated.

Captain Mike Woodworth and his team talked to the members about fire safety, what to do in an emergency, and spoke about the various procedures for his department.

After the meeting inside, meeting attendees went outside to the parking lot to see the various types of fire trucks that are used at Station 13. The firefighters did a demonstration on how they check vitals on a patient (blood pressure, EKG), and also showed us the various technologies available to them on the trucks.

Meeting attendees all received the "Vial of L.I.F.E." which is Lifesaving Information For Emergencies. It's a place for you to store important medical information that emergency medical personnel need in a time of crisis. You can pick up the Vial of L.I.F.E. kit at any San Jose Fire Station. No prior experience is necessary! Tree Amigos are expected to attend monthly meetings and volunteer one weekend a month planting trees, coaching volunteers, conducting community presentations and more.

## Meet the VEP Board of Directors for 2009-2010

**Marilyn Rodgers, President.** Marilyn has previously served as Vice President and President. A registered nurse, she works part time as a healthcare career consultant for a firm that assists adults seeking employment and/or transitioning into second careers. As Marilyn has had a long and varied healthcare career, she utilizes that experience in her own business focusing on risk management, patient care and safety issues. This expertise also includes developing effective employee incentive and rewards programs as targeted goals are achieved. She and her husband, Don, have been VEP residents for 30 years, moving to South San Jose after both graduated from San Jose State University. She is concerned about maintaining the attractiveness and safety of the neighborhood, particularly in the areas of traffic/speeding vehicles, and disaster preparedness. As a homeowner, whose property is adjacent to the Lester property, she actively participates as the VEP Alternate on the Regional Advisory Task Force for the Martial Cottle Park master planning process. ## Martial Cottle Park Update

On September 2, 2009 at the 2009 California State Fair in Sacramento, Martial Cottle Park received recognition for preserving agriculture in the Santa Clara Valley from the California Agricultural Heritage Club. This club recognizes agricultural family enterprises and agri-businesses that have been in operation for 100, 125, and 150 years or more.. On behalf of the ranch, the Santa Clara County Parks Department accepted an award for both the 100 year and 125 year recognition.

For the Martial Cottle Park Master Plan, things are moving along with a lot of work behind the scenes to prepare for the draft Master Plan/State General Plan report and a draft Environmental Impact Report (EIR). Currently staff and consultants are working on preparation of these reports.

The next task force meeting will be held sometime in the Fall, although no date has been set yet.

## Chynoweth-Thornwood Connection Preferred

A dozen years ago, Arcadia Development proposed building a large commercial/high-density residential project on their vacant parcel of land across from the car wash on Almaden Expressway, at Cherry/Chynoweth Avenues. The city required building a \$6-million bridge across the Guadalupe River as a condition for development. Arcadia balked. The project went back into hibernation, where it remains today.

The plan then was to extend Chynoweth easterly across the river to connect at Winfield Boulevard, bridging between the two existing ends of Chynoweth Avenue. An engineering study showed very serious traffic impacts at Chynoweth/Winfield. VEP's concerns for neighbors in that vicinity extended to well-founded fear about potential cut-through traffic pouring through our community past Gunderson High School and along Hyde Park Drive.

VEP opposed the Chynoweth/Chynoweth connection, a plan that no longer made sense after the city decided (on our request) to eliminate its crossing the Lester Property, making Chynoweth a permanent dead-end street.

We proposed to instead have a bridge connect Chynoweth easterly from Almaden Expressway across the Guadalupe River to connect at Thornwood Drive, the street that runs behind Oakridge Mall. There's a traffic signal there now on Winfield Boulevard, just south of the Route 85 overcrossing..

Since then, the city has adopted a preferred alignment that will extend Chynoweth easterly to a new intersection with Sanchez Drive. If and when it's built, a bridge would extend Thornwood Drive westerly from Winfield across the Guadalupe River to connect at Sanchez.

This design was adopted by the City of San Jose Department of Transportation in deference to VEP's concern over neighborhood impacts. Job well done!

## **Dear VEP Community Association,**

On July 28, 2009, Governor Schwarzenegger signed a package of bills to close the State's \$23 billion budget shortfall.

**This Fiscal Year 2009-10 State Budget includes actions that will cost the City of San Jose nearly \$100 million in lost funding.** The budget also cuts funding to state programs including education, transportation, public safety, recreation and support for people with disabilities and others receiving special assistance.

### **The State budget borrows \$20 million from the City general fund:**

The State's suspension of Proposition 1A will divert \$1.935 billion of local government property tax (8% of total local property tax revenues) in Fiscal Year 2009-10. This diversion will remove \$20 million in funding from the City's general fund which supports local police and fire, parks and transportation. The State must repay the amount shifted, with interest, no later than June 30, 2013.

### **The State budget borrows \$62 million from the San Jose Redevelopment Agency:**

Redevelopment funds have financed the San Jose Convention Center, HP Pavilion and neighborhood improvement projects. These funds can be used in the future to bring the A's Baseball Team to San Jose and support new companies growing in our City. A similar attempt to "take" redevelopment funds in 2008-09 was found to be unconstitutional, and the California Redevelopment Association is preparing to file another lawsuit to challenge the State's 2009-10 budget action.

### **Deferred payments will cost the City \$130,000 in lost interest:**

The State is deferring payments for the July-December 2009 monthly Highway Users Tax and Proposition 42 funds until January 2010.

### **Impact to the City of San Jose:**

The San Jose City Council unanimously balanced an \$84 million deficit in June of this year. Unfortunately, the additional \$20 million impact to the general fund may put in jeopardy some of the same programs that we were able to save in this year's city budget cycle. We will critically examine all of our planned capital projects using redevelopment funding and determine which projects can be postponed. The City is considering borrowing money to cover the lost revenue until the State pays us back in 2013.

I started in Oak Grove in 1975 as a physical education teacher. Over the years I was honored to be selected as the Principal at Hayes School, the Principal at Bernal Intermediate, and then selected Director of Human Resources. Prior to our Board of Trustees promoting me to the Superintendent position, I served Oak Grove as the Assistant Superintendent for Human Resources. I have served for over 15 years as an administrator in Oak Grove. I am honored and pleased to follow in the footsteps of Manny Barbara and continue to elevate the work he has done in Oak Grove.

Our school year is off to a very positive start. Oak Grove offers parents a variety of choices in their child's education environment. 

## Volunteers Clean Up Our Streets

In late June, a small group of VEP volunteers spent many hours cleaning up some of the more unsightly public places in our community. You may have noticed the work they did at these sites:



Removed weeds and trash along the sound wall and in the median island on Chynoweth Avenue, between Pearl and Winfield.

We also appreciate the work of **Phil Bejar**, **Dave Pfaff**, and **Clay Sperry** (who help maintain Vista Park).

We are grateful for the city's prompt response to our requests for removal of debris. However, unless we (volunteers) agree to do the work, the city's new policy is to tear out (yes, *remove*) any landscaping that requires ongoing maintenance. VEP has requested that they contact us first before removing plantings in and around our neighborhoods. We will attempt to line-up volunteers to do the maintenance work.

To keep this from becoming a full time job for a small handful of VEPers, we ask that you offer to help. Although the work will be ongoing, you can target your involvement to specific sites, limit it to a certain number of hours per month, work individually or with a group of other volunteers, do it on regular scheduled intervals or on an as-needed basis, etc.

Without more volunteers, we will not be able to take on more than we already do. The quality and appearance of our neighborhoods will decline accordingly. This will impact your property value—a fact the city apparently fails to understand.

## Landscaping at Narvaez Onramp to Route 87

Route 87 was opened to traffic in 1993. Its original plan included landscaping which is now being installed at the northbound, Narvaez Avenue (Capitol Expressway) approach. Sweet Gum and Cherry Plum trees will be planted there as well as erosion control grass covers. The schedule for completion is November 30, 2009.

This landscaping work is being done by the Valley Transportation Authority (VTA). VTA will be responsible for its maintenance for three years, at which time it will be turned over to Caltrans.

VTA officials say that this landscaping will have no impact on VEP's hopes for overdue improvements at this heavily congested onramp. Last year, VEP successfully lobbied to get an onramp improvement project listed on VTA's long-range transportation plan (VTP2035); unfortunately, that project is not funded so may not be built for decades to come.

Meanwhile, motorists stalled in backups there each morning will at last have a more attractive view while waiting to get through the ramp meter onto northbound Route 87.

## Fall Plantings

September is a good month for planting cool season veggies. including beets, carrots, lettuce, parsnips, certain types of peas, and Swiss chard. Broccoli, cauliflower, kohlrabi, rutabaga and turnips also do well. Leaves, stems, flower heads and roots are the edible portions of these versatile vegetables, depending on the species.

Anything grown from seed (most of the above) can usually be started in August or September. Those bought as nursery-grown seedlings are usually better transplanted in September, since the same warm weather that stimulates fast seen germination can cause tender, thirsty seedlings to wilt or burn.

Root crops, such as carrots and parsnips require full sun, sandy or loamy soil, and regular irrigation. When sowing carrot seeds keep the soil moist and never let a crust form on top, or the seeds have difficulty sprouting (start indoors?). Unfortunately, parsnips never get as much good P.R. as their orange cousins. Parsnips' creamy white to yellow roots have a unique, mild flavor and can be baked, fried, mashed, or cooked in soups or stews. Cold weather makes them sweeter.

Another favorite is the humble beet. For absolute cut beauty and flavor, go for the Chioggia, also called Bull's Eye, an unusual Italian heirloom beet with concentric white and red rings inside. Albina Verduna is a sweet white beet that grows well here, and Sangria is a classic deep red, like the wine. Because it develops its shape early, Sangrea also makes a good "baby beet" when pulled early.

Swiss chard, a leafy vegetable, is actually a type of beet without the tasty bulbous root, and is beautiful on the dinner table served raw, steamed, or stir-fried. It's also an attention getting ornamental in the garden, when you're touring with friends. The Bright Lights variety is especially attractive, showing up with crimson, yellow and white stems.

The obvious leafy vegetable choice is lettuce, which comes in four varieties: crisphead, like iceberg and butterhead, Bibb loose leaf, Oak Leaf, and Romaine, which grows in vertical stocks.

I trust you've been pulling the heads off those dandelions all summer. If not, you should have. Every time you walk to the car to go somewhere and you see a yellow dandelion blossom, don't think, "I'll have to dig that up when I get home." It'll never happen. Prevent that plant from multiplying by going over and plucking the blossom; if it's already progressed to the fuzzy ball, all the more important to trot over and close it into your hand and throw away, before the wind spreads the spores.




