

September General Meeting Synopsis

VEP's first meeting after the summer break was held on September 28, 2010 in the Vista Park Community Room.

To a standing room only crowd, **Marilyn Rodgers** introduced **Laura Cowan**, Assistant to Councilwoman Nancy Pyle, new



Gunderson High School Principal **Dominic Bejarano,** and **Mike Wasserman,** candidate for Supervisor, Santa Clara County District 1.

Layla Suarez, new owner of Giacobbe's Restaurant on Pearl Avenue provided free appetizers. She announced that Tuesday nights is all-you-can-eat Spaghetti night at the restaurant, for just \$6.95 a person. They offer catering, and soon will be offering a delivery service.

2010 is VEP's 41st year!



Next, Candidates **Linda LeZotte** and **Dan Furtado** who are running for the District 4 Seat on the Santa Clara Valley Water District Board, each gave a five minute statement for their campaign.

The next presentation was given by **Alex Mordwinow**, Operations Manager for the San Jose City Department of Transportation, and **Tom Borden** from the Department of Public Works. They discussed the proposal for the special assessment district for street landscape maintenance.

The options we have now are to 1. Remove high maintenance landscaping and convert to low maintenance 2. Take part in the Adopt-a-Street program 3. Expand the Assessment District network.

If approved by a 2/3s vote, the approximate annual cost per year (added to the homeowners property tax bill) will be between \$30 and \$55, depending on the level of service.

The VEP members in attendance voted in favor of continuing to get more information for the new Assessment District.

Next, **Marilyn Rodgers** discussed the new Goals and Objectives for the 2010/2011 year, and this was approved by the membership.

Adina Pierce and Marilyn Rodgers gave a brief update for the Martial Cottle Park project. They attended a meeting on September 22, 2010 where the Draft Environmental Impact Report was presented. The public has until October 22, 2010 to review the EIR document and submit any feedback to the County Parks Department. The final EIR will be published in November, then it will be presented to the County Board of Supervisors and State Park and Recreation Commission in December/January for approval. The design of the park will be developed in 2011.

Street Landscaping Maintenance – Special Assessment District Proposal

At the September VEP meeting, City of San Jose staff presented an overview on landscape conditions and the options the VEP neighborhood has in maintaining landscape parcels within the VEP boundaries. Staff members shared general information about citywide landscape conditions and possibility of the formation of a special landscape district within the VEP boundaries.



Through tough financial times, the City has been forced to make difficult decisions. These decisions have meant placing landscape maintenance low on the priority list in order to sustain other city services, particularly police and fire protection. This has resulted in significant reductions to the maintenance budget and the numbers of staff. During the past few years, the City developed an option for increased service in areas which have voiced a desire for something more. While nobody likes the idea of paying additional taxes, or assessments, the creation of a landscape special district is that solution. The creation of a landscape district establishes a consistent revenue source that legally can only be used for the specific use of landscape maintenance within the boundaries identified during the establishment of that district. The district then becomes immune to the peaks and valleys of the City's general budget deficits, and landscaping can be consistently maintained in a condition that is planned and expected.

If a landscape district is formed, property owners will pay the established assessment when they pay their annual property taxes. Along with the City's contribution (which would be what

the City would have paid for maintenance of the parcels within the district boundaries), the assessments paid by the property owners will be transferred to a special fund. This fund is managed by the City's Maintenance District Staff. A small percentage of the fund will go toward staff and city overhead, and the remaining balance is used only for landscape maintenance, repairs and renovations.

To maintain the landscape areas initially identified with the VEP area, the City created and presented two estimates, describing two different levels of service. The first estimate represents an optimal maintenance option at an annual cost of \$160,000. This estimate would include all weed abatement, plant pruning, plant replacements, water, tree care, management and inspection. The second estimate represents a minimal maintenance level to sustain and clean up what exists now at an annual cost of \$90,000. The estimate includes approximately 2,950 properties within the proposed district boundaries. The approximate average cost per property would be \$55.00 for the optimum service, and \$30.00 for the reduced level of service.

During the September meeting, a number of residents asked about the possibility of adding additional maintenance sites to the potential district.

Next steps include having the City staff prepare and present to VEP representatives, additional maintenance options and asso-

ciated additional costs. City staff will then take direction from the representatives on whether to proceed in the process to create a special district. A special district can only be created by a majority vote of property owners within the district boundaries, and can also be disbanded in the future by the same method.

Staff members of the Department of Transportation will be attending another VEP meeting in the future (date to be determined), to discuss in greater detail the special district options, and any other landscaping concerns you may have.

Wondering about the Green Vision? Announced by Mayor Chuck Reed in 2007, this fifteen-year plan is meant to transform our city into a greener, more environmentally friendly and sustainable city. The Green Vision sets 10 goals for San José including the planting of 100,000 new trees in the city, diverting 100% of waste from landfills, and reducing per capita energy use by 50%. Why plant trees in the city? Shade trees vastly improve the quality of life in urban areas. One large shade tree can reduce the need for air conditioning and lower energy use by 10 - 50 percent. Trees also improve air quality by removing particulate pollution and absorbing excess carbon dioxide. But that's not all — city trees also help to reduce noise pollution, screen urban views and protect our watershed by minimizing erosion. One tree can even increase a property's value by 5 to 15 percent!

With help from city and state grants and local contributions, Our City Forest has distributed \$5 million worth of free trees and services to neighborhoods, schools and agencies, including nearly 50,000 15-gallon shade trees.

November 2nd Ballot Issues



San Jose Measure U

Measure U, if approved by a majority of voters, will enact an ordinance taxing marijuana businesses at a rate of up to 10% of their gross receipts for the privilege of conducting business within the City. This tax will be in addition to the current business tax imposed on businesses in San Jose. The marijuana business tax will tax gross receipts from the planting, cultivation, harvesting, transporting, manufacturing, compounding, converting, processing, preparing, storing, packaging, and wholesale and retail sales of marijuana and ancillary products in the City, whether or not carried on for profit.

This tax will not take effect until the City Council, by ordinance, sets the rate of the tax, which cannot exceed 10% of gross receipts. The City Council may, at any time, set a lower tax rate for all marijuana businesses or establish differing tax rates for different categories of marijuana businesses, subject to the maximum rate of 10% of gross receipts. The City Council may also increase the tax rate from time to time, provided the rate set does not exceed 10% of gross receipts.

This Measure does not legalize or otherwise permit marijuana businesses in San Jose.

The revenues from the tax imposed by Measure U will be subject to the annual audit performed by the City's independent auditor which is reported in the City's Comprehensive Annual Financial Report.

A "yes" vote is a vote to permit the City Council to impose, by ordinance, a new business tax on marijuana businesses at a rate of up to 10% of gross receipts in addition to the current business tax. A "no" vote is a vote not to permit the City Council to impose, by ordinance, a new business tax on marijuana businesses at a rate of up to 10% of gross receipts.

San Jose Measure V

Measure V would amend Section 1111 of our City Charter to change the mandatory arbitration process for police and fire department employee disputes.

Currently, Section 1111 requires that unresolved disputes about wages, hours, or terms and conditions of employment between the City and the applicable police or fire employee organization be submitted to a three member Arbitration Board. The City and applicable employee organization each select one arbitrator and they jointly select the third as the neutral arbitrator who serves as the Board's chair. If the parties cannot agree on the neutral arbitrator, they strike names from a list provided by the State. After the arbitration hearing, the parties submit a last offer on each issue, and the Board, by majority vote, decides each issue by selecting the last offer that most nearly conforms to factors traditionally taken into consideration in the determination of wages, hours and other terms of public and private employment. Section 1111 lists a number of these factors, including the City's financial condition and its ability to pay the award's cost, but does not specify a priority.

This measure would change the arbitration procedure as follows:

- If the parties cannot agree on the neutral arbitrator, then either party may request the Santa Clara County Superior Court to appoint a retired Superior Court judge.
- Arbitration hearings must be open to the public and documents submitted are public records, unless provided otherwise by law.
- State law governing arbitrations shall apply only to the extent that they do not conflict with Section 1111.

This measure would also change the factors considered by the Arbitration Board. The Board must determine which party's last offer satisfies certain financial factors, is in the best interest and promotes the welfare of the public, and most nearly conforms to the traditional factors. The primary factors, however, are the City's financial condition and its ability to pay for compensation (defined to include wages and benefits) from ongoing revenues without reducing services. Further, substantial weight must be given to the rate of increase or decrease in compensation for other City employees.

The Board could not issue an award that would (1) increase the projected cost of compensation at a rate that exceeds the rate of increase of certain revenue averaged over the prior five fiscal years; (2) retroactively increase or decrease compensation for service already rendered, excluding base wages; (3) create a new unfunded liability for which the City would be obligated to pay; or (4) interfere with the discretion of the Police or Fire Chiefs to make operational or staffing decisions.

This measure would also allow court action for failure to comply with Section 1111. Lastly, the measure provides that if a court determines that any portion of Section 1111 is not valid or enforceable, then Section 1111 will be inoperative and there will be no compulsory arbitration for police and fire employee disputes.

A "yes" vote is a vote to approve the changes described above. A "no" vote is a vote to maintain the existing Section 1111

San Jose Measure W

Measure W would amend our City Charter to allow the Council on or after November 3, 2010, to (1) adopt an ordinance excluding any officer or employee hired after the ordinance's effective date from any retirement plan or benefit of any retirement plan then in existence, and (2) provide a retirement plan or plans for such officers and employees that are not subject to the current minimum requirements set forth in the Charter. In addition, the proposed Charter amendment would require any new or different retirement plan established on or after November 3, 2010 to be actuarially sound.

Charter Section 1500 requires the Council to provide retirement plans for the City's officers and employees unless an exception applies. Charter Section 1501 currently allows Council to exclude certain persons from any or all retirement plans. The Charter also currently allows the Council to change any retirement plan or adopt different retirement plans for the City's officers and employees. However, the current Charter provisions require that any new retirement plan for most City employees meet certain minimum requirements set forth in Charter Sections 1504 and 1505.

The proposed Charter amendment would allow Council to adopt an ordinance to exclude City officers and employees hired on or after the ordinance's effective date from any existing retirement plans or benefits. Such an ordinance would be subject to the requirements of applicable law. The proposed Charter amendment would also allow Council to establish a retirement plan or plans for such employees that do not meet current minimum requirements set forth in the Charter for City retirement plans.

Currently, only the retirement plans for police and fire employees are required by the Charter to be actuarially sound. The proposed Charter amendment would require that any new or different retirement plan established by the Council be actuarially sound.

Voting "yes" would amend the Charter to (1) allow the City Council, by ordinance, to exclude officers and employees hired on or after the ordinance's effective date from any retirement plans or benefits then in existence and from the current minimum retirement provisions specified in the Charter, and (2) require in the Charter that any new or different retirement plan be actuarially sound.

Voting "no" means that no changes will be made to the Charter's retirement provisions.

VTA Measure B

State law authorizes the Santa Clara Valley Transportation Authority (VTA), following a noticed public hearing, to impose an additional motor vehicle registration fee of up to ten dollars (\$10) on each motor vehicle registered within the County of Santa Clara (County). The proceeds of this fee can be used for congestion and pollution mitigation programs and projects that bear a relationship to or benefit the owners of motor vehicles who pay the fee. Such a fee must be approved by a majority of the voters voting in an election. Not more than 5 percent of fees collected may be used for administrative costs associated with the programs and projects.

The VTA Board of Directors (Board) proposes to add a \$10 fee on each vehicle registered in the County. Proceeds of this fee would be used for the following purposes: repair potholes, repave and maintain local streets, improve traffic flow on local roads; improve safety; pay for other congestion and pollution mitigation projects; and provide matching funds for federal and state funding. The expenditure plan allocates the fee revenue to transportation-related programs and projects, consistent with the Metropolitan Transportation Commission's regional transportation plan and VTA's valley transportation plan. Eighty percent of the fees collected would be allocated to local road improvement and repair; 15% to the countywide program; and up to 5% for program administration, with unused program funds disbursed through the countywide program.

Any vehicle that is exempted under the Vehicle Code from payment of registration fees would be exempted from the \$10 fee. The expenditure plan would be audited annually and periodically reviewed by the Board to determine if any modifications would be necessary. If the fee is approved, it would apply to any original vehicle registration and renewal registration occurring on or after six months following the adoption of the measure by the voters. Collection of the fee does not have an expiration date.

A "yes" vote is a vote to approve an additional \$10 fee annually on each motor vehicle registration that is paid within the County of Santa Clara.

A "no" vote is a vote not to approve an additional \$10 fee annually on each motor vehicle registration that is paid within the County of Santa Clara.

Sighs and snores could be heard from my kitchen at the end of the day on January 2nd. The mixer, measuring cups, mixing bowls, and cookie sheets celebrated a full year of daily work by relaxing on their individual shelves after the last cookie recipe was accomplished.

Several pounds of flour, sugar, and butter along with dozens of eggs, bags upon bags of chocolate chips, and a full warehouse-size roll of parchment paper have passed through my kitchen in the past 365 days. New tastes were discovered, such as the spice, cardamom, and I found that dates don't taste as bad as I thought they did when I was a child. Chocolate, ever my favorite, was used in so many different ways I never thought possible, but always ended in a delicious cookie.

Through this experience I have baked some cookies that I will probably not bake again, yet others have been added to the Favorites list. I have learned some different techniques, have found unique utensils at thrift shops, bought cookie cookbooks at garage sales, and always had something to share at parties (I'll bring cookies!!!). I was amazed as I neared the end that I was still finding recipes that hadn't been tried. I now believe there's not a cookie out there I couldn't whip up.

This recipe begins with a cake mix and ends with happy taste buds. It is quite simple and is a great bar cookie to tote to your next get-together.

French Vanilla Coconut Macaroon Bars. Ingredients: 1 package French Vanilla Cake Mix, 1/3 cup margarine or butter, 2 tablespoons water, 1 teaspoon vanilla, 1 egg, 1 ½ cups coconut, ½ cup semi-sweet chocolate chips. Instructions: Preheat oven to 350 degrees. Spray a 13x9-inch baking pan with cooking spray; set aside. Place cake mix in large mixing bowl. With pastry blender or fork, cut in butter until mixture resembles coarse crumbs. Add water, vanilla, and egg; blend well. Stir in coconut; mix well. Press dough evenly into prepared pan.

Bake for 16-22 minutes or until bars are golden brown and edges begin to pull away from sides of pan. Cool 15 minutes. In small saucepan over low heat, melt chocolate chips, stirring constantly. Drizzle over bars in desired design. Cool 1 ½ hours or until completely cooled. Cut into 24 bars. Think my baking days are over? Not quite. The new year has brought 52 Cakes. Baking a different cake every day was not practical and not good for our waistlines, so once a week the baking equipment pulls together to create a

Most people associate hot air balloons with a few movies, a weekend in Napa, a festival in New Mexico, or a way to get around the world in 80 days. But it would surprise most people to learn hot air balloons fly frequently and locally on a fairly regular basis. And just about anyone can join I the fun.


Many balloons fly out of Morgan Hill airport, Tracy airport, and Santa Rosa airport on weekends when the weather is good. And good for balloonists means light or no wind, clear skies, and mild temperatures. Festivals go on through out the year, both in our own backyard and in surrounding destinations. They can be as close as Reno, or as far away as Albuquerque, NM, but also some great ones occur in Medford and Albany OR, and in Montague CA.



The most amazing part of any festival is the mass ascension. Although the balloons leave the field at various times, they are in the general area for the first 10 to 30 minutes. Colorful balloons fill the sky, seeming to hang like ornaments over the field. Balloons come in variety of shapes, sizes and colors, and many are 'special shapes', such as stage coaches, Noah's Ark, or even the Energizer Bunny.

While attending a festival can be amazing from a visual standpoint, getting involved is an amazing experience. Helping out with inflating and launching a balloon is called 'crewing' and is easy to learn and easy to do. Getting involved can be as simply as holding the throat of a balloon while a fan blows air. And finding a balloon that needs extra crew is as easy as walking out on the field and asking if they need help. Many festivals have booths were attendees can volunteer to crew. Crewing is voluntary, and there is never a guarantee that you will get a ride, but if you find a balloon crew that you like, you will enjoy some amazing experiences and likely get a ride to float above the earth.



As of February 2006, it is illegal to dispose of items classified as Universal Waste in your trash or recycling cart. Here are some items and disposal methods:





Call the County's Household Hazardous Waste Collection Program at (408) 299-7300 to find free locations to drop these items off. OSH will accept fluorescent bulbs and Radio Shack will take household rechargeable batteries.

Computer Monitors and TVs with cathode ray tubes, Flat Screen TVs (LCD and plasma)

Call Recycle Plus Customer service at (408) 535-3515 for a Large Item Collection appointment. The current cost is \$23 for a full computer system or TV. Other recyclers may take these items for free.

If your items are still useful or repairable, you can offer them to others via Craig's List or a local freecycle email group, such as groups.yahoo.com/group/sanjosefreecycle
