September Meeting Synopsis

President Rodgers welcomed everyone and made several announcements. Ms. Rodgers then welcomed Councilmember Khamis. As VEP takes a Summer break between the first of June until the end of August, this was her first opportunity to formally congratulate the Councilmember on his re-election for a second term to the San Jose City Council, representing all of us in District 10. He provided several updates and announcements including the successful 3rd Annual July 4th Fireworks Festival at Lake Almaden, and thanked the VEP volunteers who assisted with that success. He also stated that the City of San Jose would be providing an Emergency/Disaster Preparedness Fair on October 13th, to take place downtown in the Rotunda at City Hall. He encouraged everyone to attend. He also talked briefly about the new measure B - the ¼ cent tax increase that will provide specifically for funding for transportation, specifically funding to bring BART to San Jose, and improve roads. He also indicated that he fought to assure that San Jose's Department of Transportation would be provided an additional 19 million dollars of that funding to assist with road maintenance and improvement. He responded to resident's questions and concerns about increase in taxes for residents.

Ms. Rodgers thanked the Councilmember for attending the meeting and providing everyone with updates and information. She then introduced the primary speaker for the evening - Eric Goodrich, Park Manager for Martial Cottle Park. She stated he will provide an update on issues affecting the Park, as well as some exciting information on the 2nd Annual Fall/Harvest Festival for Martial Cottle Park, this coming Saturday, October 1st. Eric thanked her and said yes they were very excited about the Festival. Additionally, they are pleased to announce that the Park will also start a new Spring Festival at the Park, tentatively planned for the first Saturday in May. He thanked the VEP members in attendance who are volunteers at the Park, including Ellen Finch, and Stephen & Lynne Lindsey. He was pleased that the numbers of volunteers for the Park are increasing - and they still need additional volunteers, so....anyone interested in what types of positions/activities for volunteers are available... may contact him. Eric stated that the Festival on Saturday will start at 10am, and that this year there will be a \$6.00 fee for parking on-site. There will be additional food trucks available this year, as well as many new and returning agencies (including Park partners) that will have booths at the Festival. Of course, the main attractions will be all of the fun activities scheduled. They are anticipating a large turnout

as there has been a significant increase in the amount of advertising for this event. He was also proud to announce that Martial Cottle Park now has its own newsletter. Marilyn indicated she had received a copy of the newsletter, and thought it was quite impressive. Eric also provided an update on park partners including possible new projects to be initiated. Marilyn stated that she had (on VEP's behalf) written support letters for two of the Park partners - Master Gardner's and Our City Forest. These organizations have applied for grants from the Open Space Authority of Santa Clara Valley for the "urban space" improvement grants provided through the new Measure Q funds - an initiative passed by the voters in the last election.

Ms. Rodgers thanked Eric, and invited him to come as often as he would like to provide information and updates on the Park. She also thanked everyone for attending the meeting, and reminded them that the next VEP meeting would be October 25th.

Vista Park Area: 2 Serious Vehicle Accidents

During the month of September, two serious automobile accidents occurred in the Vista Park area of VEP. The first accident took place on the evening of Wednesday, September 7th at approximately 8:30pm. It occurred on Chynoweth, in front of Gunderson High School. One vehicle was driving from Pearl toward Gaundabert/New World when another vehicle mistakenly driving (on the wrong side of the road) on Chynoweth toward Pearl caused a "head-on" collision. Unfortunately the vehicle causing the accident turned and sped off, immediately leaving the scene of the accident. The victim's car was totaled. The victim suffered serious injuries. SJPd responded to the scene. If anyone has information regarding this accident, they are encouraged to contact the San Jose Police Department.

The second accident occurred on Sunday afternoon, September 18th, at approximately 1:45pm. This accident occurred at the intersection of Hyde Park Drive and Birmingham Drive (just a short distance west of where Vista Park Drive deade-ends). One vehicle was heading west on Hyde Park and made a left turn onto Birmingham Drive. The second vehicle was driving east on Hyde Park toward Vista Park Drive. Hyde Park Drive curves slightly in this area, and the driver of the second vehicle was distracted and hit (broad-sided) the turning vehicle. The driver of the broad-sided vehicle suffered serious injuries.

Fortunately in both of these accidents, while injuries were serious, the results were no critical injuries or fatalities (although that could certainly have happened in both cases). Additionally, both of these accidents were caused by distracted drivers (and/or worse) that were going faster than conditions would justify.

The Chynoweth to Hyde Park to Vista Park (and reverse) has increasingly become more heavily travelled by both vehicles and bicycles, with approximately 70-80% of all traffic by those who are not residents of the VEP neighborhoods (using this route as a "shortcut", as it does not have light signals). Also unfortunately, too many drivers are not adhering to speed limits on these residential roads, and way too often driving 10 to 20 miles per hour above the speed limits. This combined with increased "driver distractions", often will result in accidents. It is our hope to prevent all accidents in our neighborhoods, but particularly critical accidents, or ones causing fatalities!!

Just a reminder.....for everyone's safety, please be sure to not exceed the speed limit of 25 miles/hour on Hyde Park and the southend (south of Branham) of Vista Park Drives. Also a reminder that the majority of Chynoweth is 30 miles/hour (and 25 in front of Gunderson - in both directions).

Frank Kistler – In Memoriam

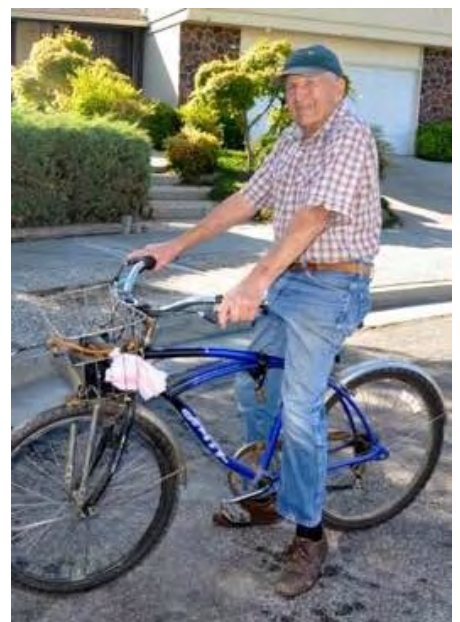

On the evening of Saturday, September 10th, VEP lost a beloved husband, father, grandfather, great-grandfather, long time community volunteer, and dear friend: Frank Kistler suddenly, but peacefully, passed away. He was 87 years old. Frank was born in Ottawa, Ohio, graduated from St. Peters and Paul Catholic High School, and immediately entered the U.S. Navy. He spent most of his enlisted time at Moffett Field as an airplane electrician. After his service in the Navy, he settled in San Jose, living there with his wife and family for 64 years. He was a journeyman electrician in the local IBEW union for over 55 years. In his retirement years he loved recycling, riding his bicycle, playing with grandkids and great-grandkids and.... watching his favorite western TV Shows: Gunsmoke, the Rifleman, and Bonanza.

He was also a very active volunteer in the VEP Community Association for many years. In his early retirement years, he helped plant trees in common areas, such as the corner of Narvaez and Branham, and along Chynoweth and Coleman Avenues. He also actively assisted in the pruning and caring for the many palm trees along Chynoweth for many years. Additionally, he assisted in the pruning and beautification of the area at the end of

Chynoweth and Barron Park Drive – cleaning up debris and planting tulip bulbs to give the site some color. This was before the Martial Cottle Park or the Park Perimeter Trail opened. This site is now the popular pedestrian entrance to the Park, at the end of (west) Chynoweth. In his later retirement, Frank was known for his tireless work with recycling – particularly collecting cans and bottles. He encouraged his neighbors to also participate in this endeavor. He utilized the funds generated toward a decade of annual sponsorships of the Christmas party for all of the residents at the Atrium Senior Community. Frank was also an avid bicyclist on the Martial Cottle Perimeter Trail and around the VEP neighborhoods – always stopping to provide a smile, a word of encouragement, or a brief conversation with his many friends and neighbors.



Frank is survived by his wife Betty, 6 children, 12 grandchildren, 6 great-grandchildren, and hundreds of friends. He will be sorely missed by all who knew him.

Celebration of Life for Frank Kistler. On Saturday, September 17th, from 1:30pm to 3:30pm the family of Frank Kistler provided a Celebration of Life for Frank's relatives and many friends. It was held at the Cup & Saucer on Blossom Hill Road. (Note: the owners of the Cup and Saucer were long-time friends of the Kistlers.) Those in attendance were provided with delicious food, and an opportunity to meet Frank's family and many friends. The rooms were nicely decorated with many pictures and important activities and memories of Frank's life. In addition to VEP friends, Councilmember Johnny Khamis attended, as well as a large contingent of friends from the Atrium.

"Adjournment" for Frank Kistler by the Santa Clara County Board of Supervisors. On Tuesday morning, October 4th, at the Board of Supervisors meeting, Santa Clara County Supervisor Mike Waserman initiated an "adjournment" in honor of Frank Kistler - his life, and his many years of service as a volunteer. In addition to several family members in attendance, VEP was represented by Marilyn Rodgers, Aiko Fadness, and Josie Supencheck.

2nd Annual Martial Cottle Park Fall Festival

On Saturday, October 1st, Martial Cottle Park hosted its 2nd Annual Fall / Harvest Festival. The weather could not have been better – sunny and very mild temperatures. The event started at 10am, with vehicles lined up on Snell (in both directions) to enter the Park. Activities included educational, informational, and interactive themes – and resulted in many smiles for both very young to the more mature! This year, the huge majority of visitors were children. Local Measures that Affect Property Taxes

After receiving many requests to explain local measures, I asked my staff to research our local Bond measures that will have an effect on your wallet if you are a homeowner or property owner in San Jose. When a bond is described in the ballot summary, it will list the total amount of the bonds. The bond repayment is funded with a tax applied to your yearly property tax bill. The tax information is not typically provided in the ballot summary, but it is included in the full ballot information that you will receive.

When bonds are issued, the cost of the bonds is spread over the taxable property within the jurisdiction of the entity issuing the bonds. This cost is then added to your property tax bill as a new assessment on the value of your property (an ad-valorem tax). We have taken a look at each local measure that may have a direct effect on your finances and illustrated what it would cost for someone who owns a \$500,000 condo and what it would cost someone with a median-priced San Jose home of \$822,700 (from Zillow.com), in the chart provided on this page.

By adding up the relevant cost estimates, you can calculate the total effect on your household budget were each of these measures to pass. For example, if you live in San Jose (which is within Santa Clara County), within the San Jose-Evergreen Community College District, the East Side Union High School District, and the Oak Grove School District, and own a property assessed at \$500,000, you could pay \$439.55 in additional tax each year (\$63.30 + \$94.75 + \$149.50 + \$132.00). If you own a home valued

at the median price of \$822,700, you could pay \$638.04 in new taxes (\$104.15 + \$155.90 + \$245.99 + \$132.00). If you are not a property owner, but you rent, the additional property-based taxes that your rental property provider is paying can have an effect on your own monthly rent when you next renew your lease, or more quickly if you are a month-to-month renter.

In addition to the new parcel and property-value-based taxes that you will vote on other local measure that may affect your household budget, so be sure to review your ballot information carefully. Measure G, for example, increases the business tax for most businesses within San Jose, but provides new exemptions for small businesses and those who earn a little extra money from self-employment. You may read more details about Measure G in the City Attorney's impartial analysis of the measure. :

However you decide to vote on the numerous ballot measures on the November ballot that you will consider – be sure to get fully informed and know how these measures will affect you, your friends, and neighbors before you make your decision!

Chynoweth Avenue Update

In November 2006, California voters passed Proposition 84, the Safe Drinking Water, Water Quality and Supply, Flood Control, River and Coastal Protection Bond Act. It provides \$1 billion for Integrated Regional Water Management (IRWM) Planning and Implementation. In September 2013, the Department of Water Resources (DWR) awarded the Association of Bay Area Governments (ABAG) full funding for 19 projects, including San José's Chynoweth Avenue Green Street Demonstration Project. ABAG serves as the lead grantee with DWR, and is establishing Local Project Sponsor Agreements (LPSAs) with each project sponsor, including the City of San José. The San José City Council adopted a resolution on June 17, 2014 to allow the negotiation and exe-

-cution of a LPSA with ABAG to effectuate a \$2 million grant with City matching funds of \$250,000 for the Chynoweth Green Street project.

The Departments of Environmental Services (ESD) and Transportation (DOT) chose Chynoweth Avenue as a potential project site due to the need to reduce the street width by installing a median, while providing a separate parking area for Martial Cottle County Park. In addition, the location of this project was ideal for the implementation of a Green Street, where low impact development (such as bio-retention or "rain garden") infrastructure can be installed to improve the quality of stormwater runoff and provide an educational experience for the surrounding community about Green Streets. The project area, along Chynoweth Avenue, is bounded by Snell Avenue and Canoas Creek. The Department of Public Works (DPW) was tasked with designing and delivering this project for ESD and the community.

City Council District 10 (D10) staff collaborated with DPW, ESD, and DOT to host a community meeting on December 1, 2015. City staff provided a visual rendering of the project to the community that showed the improvements, such as those to the median and the bio-retention areas. In addition, the rendering showed pedestrian improvements such as parking, sidewalks, crosswalks, and pedestrian ramps.

In the meeting, two major concerns were raised by the community: (1) reducing speed limits and (2) improving street lighting conditions at the east end of Chynoweth Avenue.

On August 17, 2016, City staff presented D10 staff with the completed designs that incorporated residents' concerns as expressed at the December community meeting.

Upon project completion, the residents can expect the following improvements:

- A median island that will delineate a separate access to the residential side along Chynoweth Avenue and a separate access for direct use of the Martial Cottle County Park
- Street parking adjacent to Martial Cottle Park with water quality features
- Sidewalks along Martial Cottle Park
- Crosswalks for the residents to safely cross to Martial Cottle Park.

- Re-striping of the roadway to narrow lanes and therefore, reduce speeding

- Trees and landscaping

- A new streetlight at end of Chynoweth Avenue (near Canoas Creek) to enhance the lighting conditions at the east end of the street

Expected Project Schedule Timeline:

Complete design and advertise – late October 2016

Bid and Award – mid January 2017

Start of Construction – late March 2017

Construction Completion – late July 2017

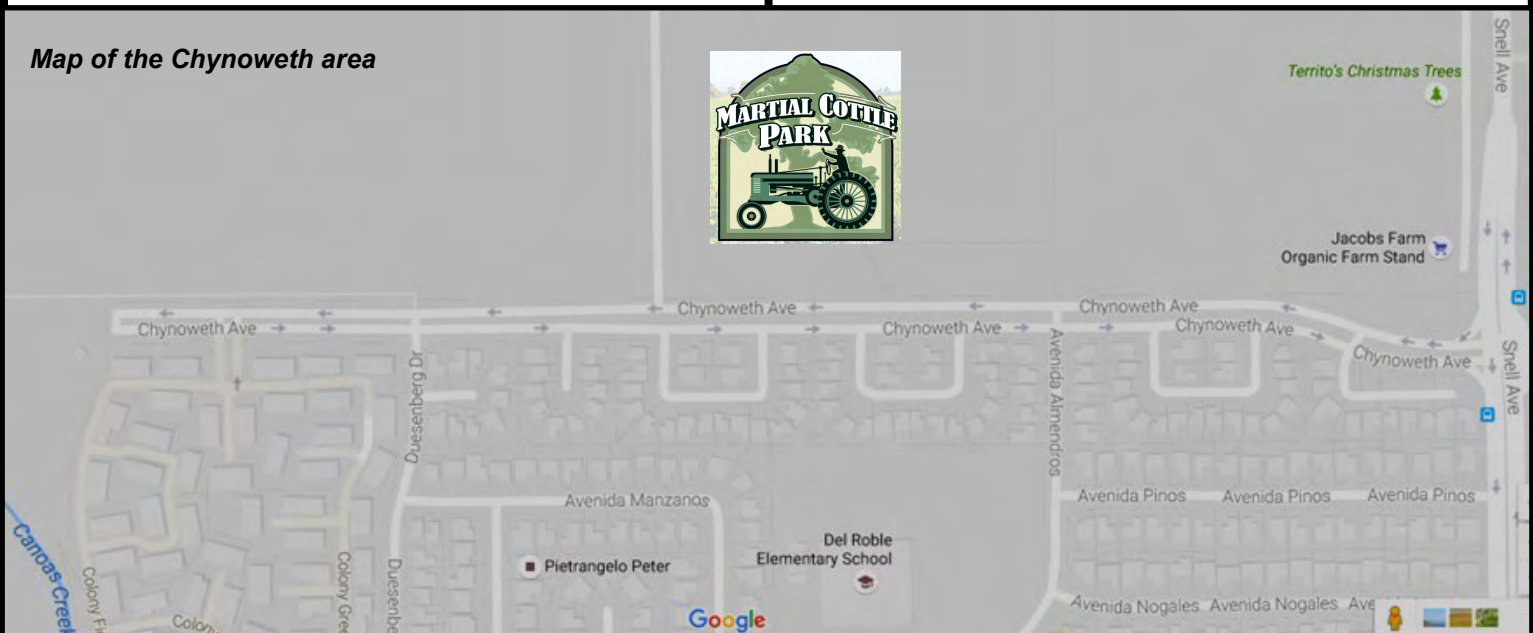


Since being elected, I have been working to help the neighbors and property owners who are dedicated to improving the neighborhood by dedicating staff resources and working with our police department on a comprehensive plan to improve the safety of the neighborhood. 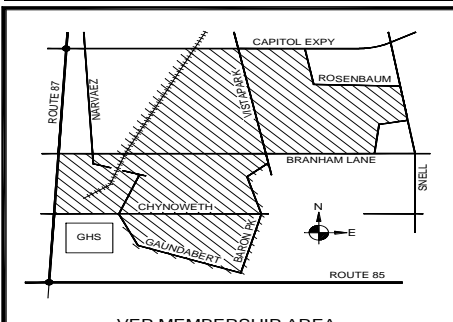
