March Meeting Synopsis

President Rodgers called the meeting to order. Everyone had been enjoying networking with friends. She introduced current VEP Board Members and Past Presidents in attendance. She then introduced Stacie Shih. representing our new State Assemblyperson Ask Kalra. Stacie previously was his Chief of Staff when he was a Councilmember for San Jose, and is now his Director for the Assemblymember's District Office. Ash was not only a Councilmember who lived just a few blocks away in the Hayes Neighborhood Association, but he has always been supportive of issues of concern regarding Branham Lane and issues involving the Martial Cottle Park. Ms. Rodgers said she had received information from several sources, including from Dave Noel, regarding an issue of importance for our area... an Assembly bill that was being heard in Committee in Sacramento. That issue was AB342 which would provide a 5-year pilot project for the cities of San Francisco and San Jose to place speed monitors on certain streets, and would give/initiate automatic tickets to speeders. This bill was to be heard in a committee that Assemblyman Kalra was now a member of - the Privacy Committee. Ms. Rodgers had called and sent an e-mail to the Assemblyman's Sacramento office to encourage his support of the bill. Ms. Shih then spoke of the several committees that Assemblymember Kalra would be a member of including one in which he has been named the Chair (an unusual honor for a "freshman" assemblyperson). She also provided information about how to contact the Assemblyperson's office, some helpful websites, and how she and the District office staff might be able to help residents in his district. Ms. Rodgers thanked her for coming to the VEP meeting, and invited her to attend any time her schedule allowed. She said she would, and mentioned that she would stay until the end of the meeting if anyone would like to talk to her. She also had several handouts for those in attendance. (Note: phone number for the District Office is 408-277-1220.) Ms. Shih also mentioned that as a pet owner, she was looking forward to the presentation on caring for pets in an emergency.

This reminded President Rodgers that she had not previously informed the attendees that there would not be a presentation on how to care for pets in an emergency. She stated that several City departments were very involved with the continuing emergency with the Flood in San Jose, and as a result, were not able to attend meetings such as ours. She hoped to reschedule the presentation for a subsequent meeting. Several attendees were disappointed as they had specifically come to the meeting for the presentation regarding caring for pets in emergencies or other unusual times in our lives.

President Rodgers then introduced Denelle Fedor, Council Assistant to Councilmember Johnny Khamis. She said that Johnnv was sorry he would not be able to attend our meeting - but the Council was in a marathon-long council meeting. Marilyn had introduced Denelle not only as the Council Assistant for Planning and Development (liaison for Johnny's office and the City), but she had also led the effort for the all volunteer project which is coming up again shortly - the 4th of July Fireworks Family Festival. Denelle took this opportunity to once again (and this time publicly at our meeting) to thank those folks in attendance at the meeting... those who had been volunteers from VEP at last year's 4th of July event. She thanked Aiko Fadness and Josie Supencheck who had worked at the booth where residents - both adults and children, could write letters to our military particularly those stationed overseas. Katherine Decker who had volunteered as the on-site "festival Nurse" and also assisted in escorting veterans, from the San Jose Veterans Center, down a "red carpet" of honor. She thanked Debra Suydam and Marilyn Rodgers (who with two other VEP volunteers who were not at the meeting) volunteered in the VEP and D10 Leadership booth - and helped raise needed funds for paying for the fireworks by selling "glow sticks." There were also VEP members and residents who helped by volunteering to set up the tables for booths the night before, and helped the day after the event with both park cleanup and litter pickup in both the park and along neighboring streets. Ms. Rodgers had been on the volunteer Leadership Team (of 4) that helped in the planning of the event, recruiting business donations (which paid for this event) and in leading and coordinating the following day with litter pickup both in the park and on surrounding streets.

Ms. Fedor then went on to provide announcements from the Councilmember's office of upcoming events – one of particular interest is the annual Great American Litter Pickup scheduled for Saturday, April 22nd. One of the 3 sites for District 10 will once again be in the VEP neighborhood – with the sign-in at Vista Park beginning at 8am.

Ms. Fedor then proceeded to provide an update and information regarding the concern VEP members and residents had over the sign which had just recently been posted by VTA at the station/parking lot - corner of Narvaez and Branham Lane. This sign was the first step in the VTA announcing their request to build both housing and commercial entities at this VTA parking lot. (Note: See more information in an article about the VTA Proposal on page 5 of this newsletter.) Additionally she indicated that the Council District Office had not been previously informed of the VTA's proposal, and had quickly initiated a meeting with VTA staff. Additional information is being requested, however, the Councilmember currently has been very public about not supporting this request until at the very least... previously promised improvements at the intersection of Narvaez and Capitol Expressway have been completed. Ms. Fedor answered several questions based on the current information, with a promise to continue to update us. Additionally she reassured the attendees that this was at the very beginning of the process, and to not hesitate to continue to ask guestions and have additional information provided to us by VTA.

Some of the questions attendees were asking had to do with the increased amount of building and development within San Jose and of particular concern – building in our area. President Rodgers interrupted the questions to say that this was probably a good lead-in for the next speaker.

She thanked Ms. Fedor and then explained that Ms. Nancy KI-Continues on Page 3

-ein, the Assistant Director for Economic Development for the City of San Jose, and the Director of Real Estate for San Jose had a conflict and would not be able to attend our meeting. However, in her place she recommended another highly qualified colleague -Nathan Donato-Weinstein. Nathan is the new Senior Executive Analyst in the same department at Ms. Klein. He previously worked for the San Jose/Silicon Valley Business Journal. As a result, he is very well versed in the business community and in business development in San Jose and in the South Bay. Nathan brought a very helpful handout/packet which was provided to all attendees. He provided information about the economics or tax revenue for the City of San Jose as well - that is the financial impacts for the City with both residential and business development. He answered several questions and/or referred them to Ms. Rodgers who was more familiar with our specific area and the large projects currently in the planning and/or development - such as the additional 2200 homes being built on Communications Hill, the building of CarMax at the corner of Pearl and Capitol Expressway, and the expansion of Toyota facility at the same intersection. Ms. Rodgers thanked Mr. Donato-Weinstein for his very informative presentation.

President Rodgers thanked everyone for coming, and asked if they would help by stacking their own chairs and organizing the community room. She also reminded everyone of next month's meeting on April 25th.

It is with both appreciation, and just a small amount of sadness, that the VEP Board of Directors, along with many VEP residents and volunteers, say "thank you" and a fond good-bye to long time VEP member and avid volunteer – Debra Suydam.

Over two decades ago Debra, then a single career woman from the Northwest, arrived in San Jose. Fortunately for all of us....Debra decided to purchase a home in the VEP area. She immediately became interested in... and... joined the all volunteer VEP Community Association.

Debra not only joined, but went on to serve as a volunteer in several capacities for the community she enjoyed and believed in. She served on the Board of Directors for several years and provided leadership for several ongoing projects. She quickly gained a reputation – "whatever activity she volunteered for – that was a definite commitment, and she would be there." For many years, Debra was involved in either leading or assisting with the annual VEP Membership Mailing Party – where both VEP newsletters and/or invitation letters to non-members were mailed out to all of the residents in the VEP neighborhoods.

Debra's volunteer interest also extended to our "4-legged residents." She was a long time volunteer for the Humane Society of Silicon Valley – leading many community projects for that organization, including serving for several years as a "kitten foster parent." She also had the informal title of "VEP resident pet expert."

Recently Debra, and husband Jeff (an active volunteer in his own right!), made a decision to move to another state, with the goal of beginning their retirement. VTA Sign Posted - Requesting Permit for Proposal to Build at the Corner of Branham Lane and Narvaez Avenue

A few days just prior to the scheduled monthly March VEP Community Association meeting, several VEP members and VEP area residents noticed a new sign posted on the edge of the parking lot of the VTA station at Branham and Narvaez. This was a notification sign in which VTA (the Valley Transportation Authority) was requesting a permit for a proposal to build - in what is now the parking lot of the VTA station. These neighbors understandably were surprised, concerned, and with resulting questions as to what exacting did this mean?

Calls for information and clarification were initiated to both VTA and to District 10 Councilmember Johnny Khamis' office. The initial resulting information was that the posting of the sign had been premature. There is a requirement that notifications be sent to neighbors in close proximity to a new development/building project. Many residents also request general information on development/building projects irregardless of their physical proximity to a project. These notifications are initially sent via an automatic electronic system.

Apparently this electronic system had failed... and was not working for a 2-week period of time. Also, the usual process of a courtesy notification to the City Councilmember whose area would be affected, had also been inadvertently delayed. Thus Councilmember Khamis had no advance information as well. These issues were identified and resolved.

At the VEP membership meeting held on March 28th, Councilmember Khamis' staff – Denelle Fedor, Council Assistant and liaison for Planning and Development provided an update on current information on the proposal. As mentioned above the posting of the sign was premature, and there are several required steps which VTA will need to go through prior to the proposed project going forward and/or being approved (or not approved).

Of important note – Councilmember Khamis has already come out in strong opposition to the proposal, stating that until "the already promised improvements at the intersection of Narvaez and Capitol Expressway – onramp to Hwy 87 north, are completed – he cannot support an additional proposed project in this area."

Initial information on the project proposal currently being requested is to build specifically in the VTA parking lot at the corner of Branham and Narvaez, including a request to a change in the City of San Jose's general plan zoning. (Note: the City's General Plan most recently went through a city-wide review and revision done approximately 8 years ago – and known to many residents as the "Envision San Jose 2040 Plan"). The request is for a mixed -use multi-family residential development of up to 450 dwelling units, and 10,000 square feet of retail/commercial.

Historical perspective – over 10 years ago, VTA had initiated a proposal for a similar project at the VTA parking lot at Capitol Expressway and Narvaez. VEP took a strong position of opposition as "no parking on site was planned" in that proposal. VEP fought to bring up specific issues of concern, as well as highlight that all initial notifications, permits, and processes had not been properly adhered to for the proposal to legally go forward. That proposal was eventually abandoned by VTA.

Currently, there are major concerns regarding both traffic congestion along Narvaez, as well as limited easement along Navarez – resulting in currently no street parking. This could very easily have a severely negative impact on the very limited street parking on the current residential homes on the small residential streets that intersect and/or interface with Narvaez.

Additionally, there are several very LARGE current development projects – both residential and commercial, in close proximity to this area. Of primary concern for the impact at Narvaez and Capitol Expressway and the northbound onramp to Hwy 87 at this intersection..... 2200 additional homes being built as part of a previously approved "several year - 3 phase project" for the top of Communications Hill!

Moreover, in close proximity – the additions being built at the Toyota facility on the north side of Pearl and Capitol Expressway; and the massive new facility being built for CarMax at the southwest corner of Pearl and Capitol Expressway with expected large numbers of client/customers increasing significantly traffic congestion in the immediate area.

VEP will be requesting ongoing information from VTA, as well as requesting the planning/provision for a minimum of three community-wide meetings be provided by them.

There will be additional information and discussion on this evolving issue at the VEP Community Meeting on Tuesday, May 30th. Plan to attend!



Exemptions for New Property Taxes Approved in November 2016

Later this year, when we receive our new property tax bills, we will all see a significant increase from several new tax and bond measures that were approved by the voters last year. If you're a senior, or meet other criteria, you may be eligible for an exemption from some of these new taxes. Two approved tax measures that were approved contained exemption language, and a third, older tax measure, also has an exemption available:

2017 Tax Measure	School District	Type of tax	Cost	Length
Y	San Jose Unified	Parcel Tax	\$72 / parcel	8 yrs
HH	Franklin McKinley School District	Parcel tax	\$72 / parcel	9 yrs

Each exemption has different qualifications and must be applied for separately. Neither the Santa Clara County Assessor nor the Santa Clara County Tax Collector administers the application process for exemptions. This is done by the respective school district.

Several people have asked us how one goes about obtaining the exemption, so we are providing the following helpful information:

Measure Y

People who are qualified to receive an exemption:

- Individuals who will be 65 years of age prior to July 1 of the tax year, owns a beneficial interest in the parcel, and occupies that parcel as his or her principal place of residence

- Individuals receiving supplemental security income for a disability, regardless of age, and occupying said parcel as a principal residence

- Receiving social security disability insurance benefits, regardless of age, whose yearly income does not exceed 250 percent of the 2012 federal poverty guidelines issued by the United State Department of Health and Human Services

Exemption Procedure:

To request an exemption form call (408) 535-6444 or email your name, mailing address, and phone number to pio@sjusd.org. They'll send you a form that you will need to return to them in order to qualify for the exemption.

Measure HH

People who are qualified to receive an exemption:

- Pursuant to CA Government Code Section 50079 (b), any owners of a Parcel used solely for owner-occupied, single family residential purposes and who are 65 years of age or older, may obtain and exemption from the education parcel tax by annually submitting an application, by June 15 of each year, to the Board of Trustees of the Franklin-McKinley School District in accordance with rules and regulations adopted by the Board

- Parcels which are (i) contiguous; (ii) used solely for owneroccupied, single family residential purposes; and (iii) held under identical ownership may upon annual application be treated as a single parcel for purposes of the levy.

Exemption Procedure:

Seniors - Exemption from the FMSD Parcel Tax is available to all senior citizens 65 years or older who live in the Franklin-McKinley School District and reside in their home. Link to the 2017-18 Senior Exemption Form: https://1.cdn.edl.io/ WFjFNbz4CH5tWp5WcwCJioGInm306F2a170FnwYh-HigDnr0W.pdf

- Senior homeowners may be exempted on an annual basis upon application to the District. To qualify, a homeowner must be 65 years of age, or older, and be the owner-occupant of the property.

- A senior applying for an exemption needs to bring proof of residence to the Business Services Department at the District Service Center and fill out the Senior Citizen Exemption Form every year (available in March each new year). The Senior Citizen Information Sheet can answer many of your questions: https://1.cdn.edl.io/

Contiguous Exemption - The contiguous parcel exemption allows a property owner to combine adjacent parcels (parcels that share a common border) into one taxable unit. These combined parcels must also have the same primary purpose (i.e., a residence, a business, vacant land, etc.). Property owners need to complete the Application for Contiguous Parcel Exemption and bring the form to the Business Services Department.

Measure CC

No exemption is listed in the documentation for the Campbell Union School District's Measure CC from 2017 (this is a correction to the information provided previously). There is, however, an exemption available for seniors and other qualified individuals from the 2015 Measure B parcel tax.

People who are qualified to receive an exemption:

- Property-owners age 65 and older, or those who receive S.S.I. benefits

Exemption Procedure:

- Mail or deliver the signed, completed form with copies of the three (3) proof of eligibility documents noted above (age, residence and ownership) to: Campbell Union School District - Parcel Tax Exemption 155 N. Third Street, Campbell, CA 95008

After the Floods, Water District Efforts Continue

Our hearts go out to all of those impacted by the recent flooding in San Jose and elsewhere in our community. The Water District is committed to reducing flood risks in those affected areas, as well as, throughout San Jose and Santa Clara County.

In the last four decades, the Santa Clara Valley Water District has invested more than a billion dollars in reducing flood risks, protecting more than 93,000 properties in previously flood-prone areas. As the flood protection agency for the county, the water district works to protect as many parcels as possible through strategically designed flood protection projects and annual stream maintenance which includes sediment removal, bank repair and vegetation management. However, flood risks still exist in our county, with more than 66,000 parcels in flood-prone areas. The water district currently has 18 projects underway to minimize this risk. Flood protection projects are a large and multi-faceted undertaking that include planning, design and construction phases, and oftentimes a permitting phase after design. In the initial stages of each project, it is essential to gather support and evaluate existing risks, potential benefits, environmental impacts and costs. Support from the community and agencies at local, state and even federal levels are crucial for a successful project.

As seen with the successful improvements to the lower and downtown portions of the Guadalupe River, flood protection projects improve a creek's capacity to withstand strong storm events and protect homes and businesses. Previously downtown San Jose and Alviso experienced historical flooding on multiple occasions in the 1980s and 90s. Both regions, addressed by flood protection projects completed by 2009, were in partnership with the U.S. Army Corps of Engineers. When the upper reaches of the Guadalupe River are completed, the entire project will protect more than 7,500 parcels from a 100-year flood event.

The devastating impacts of the recent flood event along Coyote Creek on President's Day are a reminder that flood risks persist. During the wettest winter in over 20 years, our watersheds were saturated and increased run-off filled our reservoirs and raised creek levels. For example, Anderson Reservoir, our county's largest reservoir, was less than half full on January 1, 2017. After the first series of storms in January, we began releasing water from the reservoir on January 9, as it became likely that winter storms would fill the reservoir exceeding the seismic safety restrictions. Heavy rainfall from January and February storms caused more water to flow into the reservoir than we could physically release. The reservoir reached its capacity and began to spill on Feb. 18. The subsequent storms resulted in the largest flow of water ever recorded over Anderson's spillway.

Since the President's Day storm event we have reached out to our federal and state legislators for support in seeking assistance and funding to prevent future flooding. We are also working closely with the City of San Jose to update creek capacity thresholds and develop a joint Emergency Action Plan. At the request of Mayor Liccardo our board of directors approved repurposing up to \$450,000 in an existing contract between the water district and the San Jose Conservation Corps to help the city in flood response efforts.

In early April, we will also host a series of post-flood community meetings to analyze the event and discuss how we can reduce flood risks in the future. We will need continued community and agency support in reducing future flood risks in our region.


County Parks to Call Your Own


