

III. Work with Local Government and Businesses

- A. Sponsor Election Forums to educate our members about candidates and ballot issues
- B. Work with City and County government to develop and/or maintain public landscaping in the VEP membership area.
- C. Work with City to provide traffic safety measures on VEP area streets as needed for street racing and donuts.
- D. Monitor and be reactive with the "Park and Ride" lots for development by VTA.

VEP Constitution & Bylaws: Proposed Revisions

Here, we provide a brief summary of the "Draft Revision" of the VEP Constitution and Bylaws. These changes were developed with the VEP Board of Directors and a small group of VEP Members who volunteered their time to this process. The VEP Board of Directors would like to recognize and thank the following VEP Volunteers: Aiko Fadness, Bob Aquino, Dave Noel, and Stephen Kinsey.

Proposed Revisions to the VEP Constitution:

- 1.) Preamble and Article II.b VEP Area/Boundaries: Addition of the term "Parkview" to represent "Parkview Valley" and "Carson" to align with the neighborhood designations being used by the online forum "Nextdoor."
- 2.) Article I.c VEP's association "status": Replace "nonprofit" with "not-for-profit" since VEP does not meet the legal definition of a nonprofit.
- 3.) Article VI Protecting Members' Privacy: Change in process for "Recall" of a Board Officer from the VEP Board of Directors to provide stronger protections against sharing VEP members' personal information. Adds a provision for VEP to distribute a recall petition on behalf of the initiator of the petition.

Proposed Revisions to the VEP Bylaws:

- 1.) Article III Membership Dues: Confusing & redundant Sections (B) and (C) were combined, updated and clarified.
- 2.) Articles IV.a and XX Meeting Locations: Revises these sections to reflect the Vista Park Community Room as a standard meeting location and simplifies the language about how membership is notified of changes in meeting locations.
- 3.) Article V Governance: Added language about outreach.
- 4.) Article IX VEP Board of Directors: Various roles and/or responsibilities of VEP Officers on the VEP Board of Directors was updated and revised to reflect the current needs, jobs/duties and the manner in which most VEP business is handled. Section (F) was added to allow Officers to switch roles and trade duties, as needed.
- 5.) Article XIV.c Membership Committee: Updated & clarified.
- 6.) Article XV.c Funds & Expenditures: Adds a 90-day requirement for all Reimbursement Requests.
- 7.) Article XVII.b Member Privacy: Omits a provision to disclose the entire membership database to an initiator of a recall petition.

VEP's May 2018 Meeting - Meeting Synopsis

President Rodgers welcomed everyone to the meeting and continued to encourage those in attendance to enjoy the ice cream and networking with neighbors. Then to start the meeting, Ms. Rodgers quickly introduced both the current Board Members in attendance as well as present past presidents.

The first order of business was to present VEP's 2018 Community Service Awards to two awardees present at the meeting: Juliana Pierce and Jenny Duong (Please see photos, below). She then introduced Councilmember Johnny Khamis, who had just arrived from a Council meeting. The Councilmember provided several updates, including plans and highlights for the upcoming 4th of July Fireworks and Family Festival at Lake Almaden. (Note: VEP continues to be a "Community" sponsor with a booth shared with the D10 Leadership Coalition volunteers.) He encouraged everyone to plan to attend this "family friendly" safe event. He reminded all that he had originally started the event as an alternative to "illegal fireworks" in San Jose. Ms. Rodgers also commented that this event is paid for by individual and business donations. While sanctioned by the City of San Jose, it is not paid for by the City.

Prior to introducing the guest speaker for the evening, President Rodgers stated that there was one important business item that needed to be taken care of - That item being the election of the "slate" of members to the VEP Board of Directors. She reiterated that the VEP bylaws state that each year, a slate of names for Board of Directors is brought to the membership to be elected. Prior notification of the slate is provided by publication in the VEP Newsletter. However, this year, the Board is/has recommended that rather than elect the Slate for Board of Directors at the scheduled May meeting, that this item of business be delayed until the Fall/September membership meeting. The election of a "slate" for the Board of Directors will be included then as will recommendations for bylaws changes (if any), goals and objectives for the organization for the upcoming year, and an annual budget. All of these items would be worked on by the Board over the summer months. The Board would then bring back issues/recommendations for all of these outlined business items for the membership to discuss and approve at the September membership meeting. (Reminder: all VEP meetings are open, and members are encouraged to attend and participate as their time and interest allows. So if you are someone who is particularly intrigued by Bylaws, your participation is strongly encouraged, and welcomed!)

Ms. Rodgers then introduced the primary guest speaker Valerie Merklin, Director of Development and Fair Manager for Santa Clara County Fairgrounds. Ms. Merklin provided a very interesting overview of the current status of the Fairgrounds as well as the upcoming Fair scheduled for August 2nd – 5th. The management and the Santa Clara County Board of Supervisors are continuing to discuss possible options for usage and plans for the Fairgrounds property going forward. No final decisions have been made at this point. She was excited to announce that the Fair was scheduled for this year, although starting with just a few days – August 2nd – 5th, rather than what had previously been planned in the past – up to two weeks in length. The hope is that the Fair will once again be increa-



-sed each year in terms of length of days/time, in numbers and diversity of activities, and in vendors participating in the Fair. So far the community has been very encouraging and supportive of Santa Clara County renewing its commitment to have an annual Fair. Ms. Merklin indicated this was a new role for her, but one that she is enjoying and is committed to seeing that the Fair this year, as well as future years, will be both successful and very enjoyable for the residents of our County. She ended by encouraging everyone to plan to attend the Fair on one or all 4 days the Fair will be running.

President Rodgers thanked Ms. Merklin for her very interest-ing and thought-provoking presentation. Ms. Rodgers also went on to strongly encourage, once again, members/residents to not set off fireworks, but to volunteer for, and attend the 4th of July Fireworks and Festival at Lake Almaden, sponsored by Councilmember Khamis. Contact Denelle Fedor, Council Assistant to Councilmember Johnny Khamis for additional information, and to volunteer.

President Rodgers also reminded everyone of the upcoming VEP neighborhood cleanup day. This was re-scheduled, so as to not conflict with the day it was originally to take place through-out the City in April – VEP had previously scheduled the Branham Lane Wall Painting very close to that original date.

Also, watch for additional information on the upcoming Public Safety Fair, sponsored by the District 10 Leadership Coalition. It is scheduled for late August, right after school starts. She thanked everyone for coming, wished them an enjoyable summer, and asked everyone to assist in helping organize the room, stacking chairs etc. The next membership meeting is scheduled for September 25th!

VEP Board of Directors Meets and Works on Association Business During the Summer Hiatus

During the months of June through August, VEP traditionally takes a break – no meetings during those months. However, this past summer, the Board of Directors made a conscious decision and commitment to meet and accomplish preparatory work on behalf of the organization. That work included possible Bylaws changes, supporting the work of Nominations Committee, Chaired by Past President Bob Aquino in recruiting new/additional Board Members; this recruiting effort will be consummated in the development of a "Slate" of Nominated Board Members, that will be presented to the membership at the September meeting; to develop the annual goals and objectives for the organization; and to develop/provide for an annual budget. You will see, under separate items/articles each of the above was accomplished, and is being brought forward at the September membership meeting for members to discuss and approve. (See page 2 & 3 of this newsletter.)

Each year, VEP utilizes the development of a "slate" of nominated Board Members for the election process. Many organizations have, in recent years, adopted the "slate" process. What that means is – there is one candidate identified and listed for a specific Board position. This is done rather than having 2 candidates for each position, and a traditionally "political battling it out" between the two or more candidates for each position.

The role of the Nominations Committee is to contact and/or solicit potential candidates, tell them what the role and responsibilities are for each position, and to obtain that individuals' consent to be placed on the "slate" for the ballot of the group of Board members. This 'slate' will then be elected/approved by an "up or down" vote by the membership. Traditionally, for VEP, this means a "vote by the membership" is done at the first subsequent membership meeting, i.e. this year in September. The only additional requirement is that each person who has their name submitted for the "slate" is that they "are a member in good standing." That generally means they are a member who has paid their dues, and has not done anything untoward. In addition to the work of the Nominations Committee in recruiting/obtaining individuals who would agree to have their names placed on the slate for potential election. VEP encourages "self-nomination" - that is, the organization always verbally, at meetings, and in writing, via the newsletter and/or emails, encourages any member in good standing to consider running for the Board of Directors. Any member who might be interested, is encouraged to contact the Chair of the Nominations Committee for consideration prior to the "slate" being announced and/or published in the VEP Newsletter. "Self-nomination" is also used when there is a subsequent opening on the Board anytime during the year.

This year the Nominating Committee worked very hard to recruit potential new Board members, as the majority of the current Board members had continued to serve past the allotted number of years of service for individual Board members. We want to once again, thank all of the current Board members who have continued to serve, as this shows an exceptional commitment to the VEP organization, and to the VEP communities the VEP Board serves!!

"Viva CalleSJ" Comes to the VEP Neighborhoods By Marilyn Rodgers

On Sunday, September 23rd, an exciting event will be coming south from downtown San Jose, all along Monterey Highway to Branham Lane, then turning west on Branham Lane, crossing Snell and continuing to a gate/inlet for Martial Cottle Park (across the street from Wells Fargo Bank), and entering "Viva CalleSJ." This is an exciting event that is coming to the north end of South San Jose for the first time! This is a run/race for residents who want to walk, and/or run, and/or ride their bicycles. The event will start at 10am, starting on Monterey in the South of First area of downtown San Jose, and it will last/continue until approximately 3pm, where its final staging area is at Martial Cottle Park.

The good news is it brings a lot of foot/bicycle traffic to our neighborhoods, and an opportunity for many San Jose residents to find out about/become familiar with our area, and to specifically learn more about Martial Cottle Park.

VEP Community Association will have a table/booth, along with Council Office District 10, Johnny Khamis, at the event inside of Martial Cottle Park. This is a wonderful opportunity for VEP to initiate a goal to start participating in Martial Cottle Park's Spring and Fall Festivals. It will be a "trial run" to see what people might be interested in knowing about VEP, and our very long involvement with the establishment of Martial Cottle Park. This will be an opportunity to talk to people (San Jose residents outside of our immediate area) about VEP, about our neighborhoods, and of course, about our special concern and involvement in the development and ongoing success long term of Martial Cottle Park, etc.

The "not so good news" is that several main streets will be blocked to vehicle traffic all during the time of the event – from 10am (or earlier) to approximately 3pm (or as late as 4pm). The streets that will be affected in our area will be: Branham Lane will be closed at Monterey and for all streets all along the route west to Vistapark Drive; Branham Lane will also be closed to vehicle traffic – north and south on Snell. Skyway will be blocked at Monterey.

For those wanting to participate in the walk/run/bike street race, there will be places to stop for water and/or food, places to shop, and other resources and accommodations such as public restrooms.

Merchants along the route will have a variety of merchandise for purchase.

The idea behind the walk/run/bike races like Viva CalleSJ is to get people out onto the streets to shop, eat, and socialize. This will be our first experience with this type of event – hopefully everyone will enjoy themselves!

Eagerly Awaited Project to Build "Community Gardens" at Martial Cottle Park was Approved on August 14th!

After several years of back-and-forth between the County and the City, an agreement has finally been signed by both parties for the building of the Community Gardens at Martial Cottle Park. And a special "Thank You" goes to Supervisor Mike Wasserman who worked diligently to keep things moving forward to a successful end.

The City of San Jose will be responsible for building, managing, and maintaining this facility that will be located within the County-owned park. The design process is under way and expected to be completed by the end of September, after which an RFP will be issued for contractors to bid on carrying out the plans and creating the garden. If all goes smoothly, construction is expected to start in April 2019, and the community should have access by the end of summer – just in time for fall planting!

The gardens have also been named, by action of the Santa Clara County Board of Supervisors at their August 14th meeting, the Rusty Areias Community Gardens, for the former State Parks Director instrumental in securing the State funding used to acquire the Lester property for preservation as a park for future generations.

Thank you to all the community members who wrote letters to the County Board of Supervisors and attended meetings to advocate on behalf of your fellow residents. Soon, you will have the chance to enjoy the fruits of your labors!


