### **VEP November/December Meeting Preview:** City of San Jose's Office of Emergency Management By Laura McGeever

On December 3<sup>rd</sup>, Lee Steckmest from the City of San Jose Emergency Preparedness Team will be discussing Basic Emergency Preparedness for Homes and Businesses at our community meeting.

## **VEP's October Meeting Summary**

Greg West opened the meeting by expressing his thanks to the volunteers for the VEP 5th Annual Dave Fadness Beautification Day, held on Saturday, October 26, 2019. The VEP Annual Budget was then distributed to provide more details that were requested at the September meeting.

Our auest speaker. Ms. Vanessa (vanessa.beretta@sanjoseca.gov), from the City of San Jose Homelessness Response Team (HRT) provided details regarding the homeless population from the 2019 Homeless Census and Survey. The survey is done every 2 years by going out directly to the community to do interviews. She reported that there has been a 40% increase in homelessness in the 2 years since the last survey totaling 6,097, of which 393 are in District 10; that 88% of homeless would accept permanent housing if it became available; that 68% could not afford rent; and that for every person housed there are 3 new homeless.

To help address homelessness in San Jose, the Homelessness Response Team uses that following strategies: Permanent housing for supportive housing situations; an outreach team that connects people to services and conducts assessments to determine housing need; and interim housing for rapid rehousing, including Tiny homes costing \$5200/unit placed on city lots; Conversion of old hotels and motels; and safe parking for vehicle dwellers where restrooms, dumpsters, and security are provided. Additionally, the City has passed a temporary shelter ordinances allowing private property owners, such as religious organizations, to open their facility for support. The facility must be reviewed for safely by the city. Community centers have been opening overnight for warming areas.

The HRT handles 6500 calls about homeless concerns a year. The following is their protocol for handling the calls:

- · Go out to follow-up on the location from the call
- Determine location jurisdiction. (Section behind houses near Highway 85 is owned by Cal Trans.)



- · HomeFirst is used for Outreach
- Contact the County's Hot Team for mental health concerns
- Abatement is determined based on prioritization. For instance. waterways are the top priority. School routes also high priority.
- 72 hours notice is required before abatement can occur
- On the date of abatement, 4 offices and approximately 20 individuals are involved.
- All property is reviewed to be determined what can be stored. Storage is for 90 days. The timeframe for an abatement request to abatement notice is generally 60 to 90 days.

Vanessa responded to many questions. Someone asked about the RV parking on the streets. Vanessa confirmed RV Parking is not illegal. There is no towing for occupied vehicles. There was a discussion regarding Laura's Law. Johnny Khamis interjected to explained the program. Santa Clara is yet to approve the law for use in this county but all the surrounding counties have approved it. Khamis suggested contacting the County Board of Supervisors about Laura's Law (District 1 Supervisor Mike Wasserman (408) 299-5010 mike.wasserman@bos.sccgov.org). Vanessa continued with the rest of her presentation and answered many more questions before finishing. President West thanked her for taking the extra time.

Next, Khamis spoke, continuing with his insights regarding the homeless situation. Afterwards, the following additional topics were discussed, and questions were answered:

- Prop 47 released 5234 prisoners into Santa Clara County.
- Power Outages: PG&E owns all the lines for San Jose and is in control of turning it on or off. The City of San Jose has no control. In November 2018, the state legislature approved a change of law allowing PG&E to turn off the power. The CPUC is responsible for controlling the utility company not the city.
- · Laura's Law is not currently in Santa Clara County, but should be considered.
- · Pat Dando, a former San Jose District 10 Councilmember and Vice Mayor, remembered for her advocacy and tireless work ethic, will be honored with a bronze sculpture at the Almaden Library and Community Center next year. Khamis also mentioned that VEP's own Aiko Fadness was involved with obtaining the funding.

VEP Membership Dues were discussed. There was a suggestion to increase the amount to \$25 from \$20 a year. The community discussed what would be the reason to increase the dues. The reason to increase the dues is since the current amount has been in place for an extended amount of time. The Board mentioned that there is a surplus in the budget and no reason for increasing the dues. There was a motion from Laura McGeever to keep the dues at \$20, seconded by David Noel. The motion passed.

We discussed the distribution of the VEP News newsletter in paper form. President West reported that the database indicates that 2/3 of the members request a printed newsletter, 1/3 have requested email only. Approximately 20 members have requested both forms of distribution. In addition, the Treasurer reported that having less than 200 Newsletters printed would cost the community more than more than 200 newsletters. Based on this information, the members decided to continue providing printed newsletters.

Finally, we decided to have a Council District 10 election forum for our January meeting, potentially in cooperation with Erikson Neighborhood Community Association.



### Parkview Pride: VEP's own Witmeyers Honored By The VEP News Staff

Many people in the Parkview area know the Witmeyers as the couple who bought the house next-door to Parkview School and brought it back from the squalor of an all-but-abandoned property. Robert and Rachel have been proud Parkview residents and VEP Members ever since 2009, and Rachel has served as a VEP volunteer and the Editor of the VEP News since 2013. But this autumn, the Witmeyers brought pride back home to Parkview, and the VEP, with two impressive awards.

On September 27<sup>th</sup>, Rachel was honored with the "Phenomenal Woman Award" from the Campbell, California based non-profit, "Building Peaceful Families." She was nominated by the organization's founder, Superior Court Judge Sharon Chatman, for over 14 years of service in the public schools as a 6<sup>th</sup> grade teacher. "Mrs. W" has a reputation in the Franklin-McKinley School District as a dedicated educator, whose efforts reach beyond the classroom to offer her students extra opportunities and experiences outside of school and the school-day. Rachel was completely surprised by the nomination. "I'm humbled by the award and the whole experience. I met so many wonderfully impressive and inspiring women from our area. It's really amazing to be counted among them," she says.









In October, Robert, who is a professional musician and music educator, was selected as a competitor in the First Annual "Chris Jackson's Guitar Riff-Off Contest" sponsored by 98.5 KFOX and "The Garden at the Flea" (San Jose's Berryessa Flea Market). After qualifying on October 5<sup>th</sup>, by playing Ozzy Osbourne's "Crazy Train," Robert and the other contestants had their performances posted online for public voting. The Finals were held on Saturday, October 26<sup>th</sup>, where Robert won the votes of both the judges and the audience with a unique rendition of Metallica's "Enter Sandman." He brought home the championship title, as well as an award of \$1,000, and, of course, bragging rights! KFOX and "The Garden at the Flea" have subsequently informed Robert that he will be called to defend his title as Best Guitar-Riff Player in the Bay Area, in the fall of 2020.

#### **November 2019 County Update**

Like you. I am frustrated with how PG&E has been handling power shutoffs in our County. PG&E's decision to execute power shutoffs are very costly, both to local governments and to our residents, who understandably feel ignored, scared and angry. A utility company has a responsibility to provide safe, reliable services. They can't simply turn off power to people who rely on such things as medical equipment like breathing machines, or for children who can't go to school. And businesses need to be open each day to sell products and employ people. If regular sustained power outages are the "new normal," I fear that a significant negative economic impact could ensue, resulting in employees facing layoffs from businesses that can't absorb the losses. While the County can't control what PG&E does, we are making it clear to Sacramento leaders who regulate PG&E that their actions have consequences for our residents. Entire neighborhoods have gone dark for several days (including my own), which is a huge public safety concern, particularly in rural areas. County and city resources have been stretched thin in order to help keep people safe during these

Santa Clara County declared an emergency during the outage to ensure that resources are available to continue critical operations and to minimize impact to the community. The emergency declaration allows the County to coordinate with a large network of public and private partner agencies when circumstances are beyond the capacity of local services and personnel. The County is also supporting other jurisdictions (cities and counties) that are severely impacted by the power shutoff. We know that fire danger is real and we need to hear from PG&E on what they plan to do to ensure that ongoing shutoffs aren't the new normal. As County Supervisor and Chair of the Housing, Land Use, Environment and Transportation Committee, I've requested PG&E representative appear before our Committee to answer questions. I am more than willing to detail the effects of their actions on our residents and businesses and help them plan better. We need real solutions and those usually happen by working together.

Residents understandably are asking, "What is being done to address homelessness?" The answer is that we are housing people. In fact, we've housed 12,400 people, including about 1,600 veterans and 3,800 kids, over the last 5 years! The Santa Clara County Board of Supervisors recently approved two new sites for affordable housing developments. The County's portion of the housing developments will be funded with \$15.6 million from the County's 2016 Measure A Affordable Housing bond and \$17.4 million from the state-funded No Place Like Home bond for a total of \$33 million. The Gallup and Mesa Apartments – located on a .38-acre site near Blossom Hill Road and Almaden Expressway – is comprised of 45 affordable units. The second project is the 425 Auzerais Apartments, which is a 130-unit affordable family development near downtown San Jose.

Our top priority is to use these voter-approved funds and other

public investments to create affordable housing for seniors on fixed incomes, young adults with a mental illness and other vulnerable residents. With 21 affordable housing developments in the works (four of which are expected to be completed by the end of December), the County is now almost a third of the way toward our goal of financing 4,800 new affordable units through Measure A by 2027.

# **Children's Discovery Museum:** Grab A Child & Go For A Fun Visit

When our daughter was a toddler & preschooler we joined the then new San Jose Children's Discovery Museum and went there often, sometimes just for an hour or two and sometimes for multiple hours. As she got older she knew the layout as well as we did and she led us to the things she wanted to revisit. As members we went to special music performances and events, exposing her to experiences she would not otherwise have had.

In later years, when they visited we took our grandchildren there, too, for similar experiences. At first we forgot to take an extra set of clothes, because despite plastic cover-up items in the waterplay area, some children while having a so much fun will also get their clothing thoroughly soaked. Our grandson was one of those and he wasn't ready to leave the water area when we were.

The best part of the Children's Discovery Museum for us is watching our special children discovering how things work, returning over and over again to the things they enjoy, and later telling us about them. There is a real fire engine they can climb on and heavy fire fighter's clothing they can try on. There is a face painting area with large mirrors where you can paint their face or they can paint their own face, arms, and legs. There are things to touch, push, pull, and watch. As adults we enjoyed some areas, like the making of large bubbles.

This is really a place you have to go with a child to fully appreciate it. The staff understands children and are there to help you have a meaningful experience.

They are located at 160 Woz Way in downtown San Jose. Children and adults are \$15 per person and seniors are \$14. They are open everyday, except Mondays. (Tues.-Fri. 10am- 4pm; Sat 10am-5pm; Sun 12-5 pm.) Check their website, www.cdm.org, for further information.

This is your chance to see the world through children's eyes and to share it all with them. Most large cities have their own version of a Children's Museum. Don't miss out on visiting San Jose's!

### **Persimmon Bars**

"Persimmon bars as done by my husband's grandmother for years. A family holiday favorite. Sweet frosting tops these delicious cakes."

#### Ingredients

- 1 cup persimmon pulp
- 1 teaspoon baking soda
- 1 egg, beaten
- 1 cup white sugar
- 1/2 cup vegetable oil
- 1 cup raisins
- 1 1/2 cups all-purpose flour 2 tablespoons lemon juice
- 1 teaspoon ground cinnamon
- 1 teaspoon ground nutmeg
- 1 teaspoon salt
- 1/4 teaspoon ground cloves
- 1 cup chopped walnuts
- 1 cup confectioners' sugar

#### **Directions**

- 1. Preheat oven to 350 degrees F (175 degrees C). Lightly grease a 10x15 inch jelly-roll pan.
- 2. In a small bowl, stir together persimmon pulp and baking soda; set aside. In a separate bowl, mix together egg, white sugar, vegetable oil and raisins.
- 3. In a large bowl, stir together flour cinnamon, nutmeg, salt and cloves. Stir persimmon mixture and egg mixture into the dry ingredients. Fold in walnuts. Spread batter into pan.
- 4. Bake in preheated oven for 20 minutes. Meanwhile, combine confectioners' sugar and lemon juice. Stir until sugar is dissolved. Remove bars from oven and spread with glaze.
