VEP's November/December Meeting Summary

Discussion Item: Funds for Membership Mailing

President West updated the VEP community regarding the January membership drive.

- Research: a direct mail company will deliver membership forms to everyone in the VEP neighborhood.
- The cost is \$0.20 per mailer
- Additional cost will be \$400 for the printing of the mailer
- Needed: additional information on the cost of the newsletter being mailed to the whole community.

A motion was presented, seconded and approved by the membership to move forward with the cost of mailing to the entire VEP community.

Presentation: Emergency Preparedness

Lee Steckmest, with Almaden CERT and San Jose Emergency Management Office, came to discuss and answers questions regarding individual preparedness for disasters. Lee reviewed the staffing limitations for the City of San Jose. With the number of people in San Jose and the number of response team members available, individuals will need to plan for how to handle an emergency on their own, for several days. The response team will always focus on the most populated areas first. Community Emergency Response Teams (CERT) are "neighbors-helpingneighbors" organizations. Lee mentioned that the Almaden Valley CERT group has radios to assist with other neighbors.

Lee's Simple Steps to prepare yourself for emergency situation:

- Think about the gas shut-off.
- Think about what you can do without the internet.
- What about clean water?
- Make sure there is cash on hand since the ATM's won't work.
- Make sure your cars have at least $\frac{1}{2}$ tank of gas at all times.

Lee also mentioned that there are many resources on the internet that will help you and your family get prepared. The "Ready.Gov" website is a standard staple, and PG&E has a Safety Center on-line for general prep.

Lee went on to explain that drinking water is the most essential item. Each person should have 1 gallon of water for each day. The same applies for kids. Also, all your pets will need water too.

Lee continued by going through a list of suggested items to consider preparing yourself and your home with:

For Your Consideration:

- Check your workplace / business environment for emergency preparedness.

- Make sure that your car has an emergency kit. including a fire extinguisher.

- Make a Grab and Go bag for a quick evacuation.

- Make a formal list of priority items. The list should be next to the front door.

- Have a Bug Out box. Include enough supplies for 2 weeks time.

- Life straws are available for you to be able to drink water from a swimming pool or other pools of water.

Documentation

After a disaster, everything you have may be destroyed. The following items should be copied into electronic files and kept on an encrypted drive: Marriage licenses, Birth certificates, Driver's licenses, and Passports.

Emergency contact list should be made and an outside California contact needs to be included. During an emergency, the California lines may be too busy to work.

Preparedness Homework

- Download the Ready SCC app

- Text 888777 for alerts for your zip code. Any zip code that you are interested you can send a text for.

- Know how to turn off the gas. Practice by 1/8 turn. If you cannot turn the knob, call PG&E, they will come out to turn it or they will replace it if it is stuck.

- Make certain your hot water heater is secured properly. The #1 cause of fires after earthquakes is the movement of water heaters.

More About CERT (Community Emergency Response Team)

Trained fire, safety, health, and preparedness under FEMA

- Anyone can complete the training for free
- 20 hours provided
- Communication strategy & protocol is set-up

- Training available once a month from the City of San Jose. You can go to the city's website and search under CERT to find out more information.

Lee's final words - "Can't control disasters but you can be prepared."

President's Corner: 2020 Membership Drive Kick-Off and San Jose City Council District 10 Candidates' Forum By Greg West

This month, we mark the kick-off of the VEP Community Association's annual membership drive and we ask that you renew your membership in VEP Community Association. Just drop a check for \$20 in the enclosed membership envelope, affix a stamp and drop it in the mail, or bring a check to the next meeting on Tuesday, January 28th. Since you are already a current member, there is no need to fill out the membership application on the envelope, unless, of course, something has changed, or you want to forward a comment to us.

As you know, VEP is an all-volunteer organization of friendly neighbors who are dedicated to serving the needs of our community—needs that are brought forward by our members, people like you. VEP volunteers do a variety of activities in our neighborhoods and represent our views before government at all levels. Founded in 1969 and celebrating our 51st year of community involvement, we are one of the most successful and most enduring grass roots organizations in Santa Clara County.

As one of our benefits to the neighborhood, we have organized a City Council District 10 Candidates' Forum for our meeting on Tuesday, Jan. 28. As of this writing, we have invited the three candidates in the race, and have gotten confirmations of attendance from all three. Note that we are starting this meeting a half an hour earlier than usual (at 7PM instead of 7:30PM) to accommodate member questions and discussion. Also note that we are meeting at Gunderson High School in the Forum to accommodate the expected attendance. We've asked the candidates for a 200 word introduction of themselves, which is published in this issue of the News.

We are informing the entire neighborhood about the candidates' forum using the "Every Door Direct Mail" service from the Post Office. The postage for this service is about 18 cents per piece. We are also combining this mailing with our membership drive, so a membership application will be printed on the back of the flyer. Our membership drive would normally be a 1st class mailing to neighbors that aren't currently members. So, the cost of our flyer AND postage will cost less than our normal membership drive mailing costs alone. Please note that even though you are a current member, you will get this flyer as well.

Please help keep your neighborhood strong and prepared. *Please renew your VEP membership today by returning your check for \$20, made payable to "VEPCA" in the envelope enclosed with this issue of the VEP News.* We are eager to continue to grow and strengthen our organization with your help. Thank-you for your past and continued membership!

Here are some examples of activities that your \$20 annual VEP membership has supported in the last 51 years:

- Planting and maintaining 170 palm trees in the median on Chynoweth Avenue.
- Driving community input on the design and development of Martial Cottle Park.
- Lobbying for safety improvements in and completion of neighborhood parks.
- Sponsoring spring and fall neighborhood and park clean-up days.
- Sponsoring & advertising an annual community-wide garage sale.
- Saving the Belden Elementary School site (now Vista Park) from residential developers and helping it become a park.
- Winning traffic safety improvements at multiple locations: Rosenbaum and Snell, Vistapark and Capitol, Bluefield and Capitol, Bluefield and Vistapark, Royal Park and Branham, and also at the former Branham and Lick Branch railroad crossing.
- Brokering the deal between Summer Hill Homes and the City of San Jose to build a community room & facilities in Vista Park as part of the housing project in the old walnut grove. Later, VEP won an Art Grant for the "Gates."
- Challenging the City over increases in high-density housing projects in our neighborhoods.

- Working with the City to keep homeless encampments out of VEP neighborhoods.
- Increasing pedestrian safety and calming traffic around Parkview School by working with DOT to petition the neighborhood and obtain city approval for the installation of 4 speed "humps."
- Rewarding outstanding volunteerism each year to graduating seniors at Andrew Hill and Gunderson High Schools through the VEP Community Service Awards.
- Regularly sponsoring candidates' and ballot-issue forums to inform and encourage active voters, including our D10 forum coming up on Jan. 28!

Potential Diversion of Highway / Street Funds – and How I'm Fighting It

We have an important vote coming up at City Council, at our last meeting of this month, Tuesday, January 28, 2020, at 1:30 PM, when we will vote on a memo I



authored, along with my colleagues, Vice Mayor Jones and Councilmembers Davis and Foley. We are calling on VTA to keep their commitment to the voters who approved 2016's Measure B by making it clear that they will not divert funds intended to reduce traffic congestion or repair local streets.

As you may recall, Measure B was approved in November 2016 with 71.74% of the vote. The ballot text explicitly committed a portion of the measure's revenue to "repair[ing] streets, fix[ing] potholes [and]...reliev[ing] traffic on all 9 expressways and key highway interchanges".

Unfortunately, with the New Year it appears that there is a new (and disastrous) idea gaining traction at the VTA Board of Directors that has the potential to repurpose the highway & streets funding that we were promised.

During public comment at the December 5th VTA Board of Directors meeting, activists were very vocal in seeking to divert desperately-needed highway funding in favor of the Measure's other transit priorities. In reaction to this public comment, Supervisor Cortese, a member of the VTA Board, directed VTA staff to come back to the Board on January 9th with a declaration of a Climate Emergency. It has since been determined that the resolution will instead be presented to the Board at the February 6th meeting. If the talk of creating and passing this Climate Emergency resolution becomes a reality, a total of \$2 billion in highway improvements and street repairs could be diverted. Measure B already programs over \$1 billion for Caltrain improvements, and \$500 million for expanded and improved transit operations – namely bus and paratransit service to senior, disabled, transit-dependent, and other vulnerable populations.

Let me be clear: Mass transit options and carbon emissions reductions are important regional priorities. Therefore, we must commit to delivering transportation projects as described in the clear language of Measure B. A Climate Emergency declaration must not be used to change these voter-approved priorities. After all, public transit, especially busses, rely on quality streets and efficient highways to fulfill their function in getting cars off the street and reducing carbon emissions.

VTA isn't just a transit agency – it's also the county's congestion management agency. VTA already struggles to adequately address congestion; diverting funds from our congested highways will only exacerbate the issue.

As an elected official, I have committed my tenure in office to promoting transparent and honest government. It is my hope that Supervisor Cortese and the entirety of the board share my convictions and see to it that the Measure B promises are kept. I call upon all county taxpayers to show their support for our highways and roads at VTA's upcoming Board of Directors meeting on Thursday, February 6th. Without healthy roads and highways, you and I won't be getting anywhere on time, by transit or by car.





A few highlights of the past 12 months from Santa Clara County Supervisor Mike Wasserman (representing San Jose, Los Gatos, Monte Sereno, Morgan Hill, San Martin and Gilroy):

Sheltering Animals. Animal lovers gathered in November to witness a monumental construction milestone: The "topping off" of the new Santa Clara County Animal Services Center in San Martin. After years of planning, the new LEED Silver certified Animal Services Center is on track to open in 2021! Fundraising efforts for the Center are underway to complete critical infrastructure of this state-of-the-art facility. Please consider supporting local animals with a taxdeductible financial contribution.

Housing Homeless Veterans, Kids, People in Need. Residents understandably are asking, "What is being done to address homelessness?" The answer is that we are housing people. In fact, in the last five years the County has helped to house 12,400 people - including about 1,600 veterans and 3,800 kids! We are using voter-approved funds and other public investments to create affordable housing for residents in need. The County is now almost a third of the way toward our goal of financing 4,800 new affordable units through Measure A by 2027.

Modernizing 9-1-1 Services. 9-1-1 texting services will now be available throughout Santa Clara County in 2020. This new option will help those who are deaf, hard of hearing, speech impaired and anyone who feels unsafe speaking over the phone. The County operates an emergency communications center that is staffed by 130 employees, including 80 dispatchers who answer approximately 45,562 calls per month, 62 calls per hour, 1,497 calls in a 24-hour period and 546,750 calls per year. Dialing 9-1-1 in an emergency is still the preferred way to request help, and the public is reminded to "Call if you can. Text if you can't."

Cordoba Moving Forward. The South Valley Islamic Center's Cordoba mosque and cemetery in San Martin was approved in December. Many perspectives were expressed during the multi-year process and all sides were listened to and respected. Compromises were made and it was determined that the resulting use is appropriate and lawful. The project ensures that water quality will be monitored on an ongoing basis. The project will enable its members to move their services from a converted barn to a much more suitable – and beautiful – place of worship.

Preventing Wildfires. Throughout my time in office, I have been working on improving wildfire safety and I am proud that in 2019, Santa Clara County was the first county in California to receive \$4 million from Sacramento for wildfire preparedness funding. Communications are critical for emergency notifications and coordination of resources. The money is to purchase Mobile Operations Satellite Emergency Systems (MOSES), designed to ensure that firefighters and residents can maintain communication with one another if internet service providers' systems break down.

Turning Lives Around. The County celebrated the grand opening of a 31,000-square-foot expansion of the William F. James Boys Ranch near Morgan Hill, a County youth detention facility that helps 15 to 18-year-olds turn their lives around while in custody. The expansion allows the County to provide additional services, including rehabilitation, substance abuse counseling, gang intervention, and education in trades and skills. I'm very proud of the work being done at the James Ranch by both the staff and the young people who are committed to improving their lives.

Working with PG&E. The handling of power shutoffs in our County by PG&E has frustrated many of us. PG&E's decision to execute power shutoffs are very costly, both to local governments and to our residents, who understandably feel ignored, scared and angry. While the County can't control what PG&E does, we are making it clear to

Sacramento leaders who regulate PG&E that their actions have consequences for our residents. As County Supervisor and Chair of the Housing, Land Use, Environment and Transportation Committee, I've requested PG&E representatives to appear before our Committee. We need real solutions and those usually happen by working together.

Voting Improvements. Big changes are coming to Election Day with the County's implementation of the Voter's Choice Act. Beginning with the March 3, 2020 Presidential Primary Election voters will be able to cast their ballots at Vote Centers or use Vote by Mail Ballots. The new system will make it more convenient for our 900,000 registered voters to cast a ballot and is anticipated to increase voter participation. In addition, Voters will benefit from a new, modern and secure voting system that includes new ballot scanners, tabulators and ADA-compliant ballot-marking devices at Vote Centers. The new system will enable a decentralized count which is expected to expedite election night results considerably.

Counting America - Census 2020. Since the very first Census in 1790, the Federal government has undertaken the constitutional requirement to count everyone living in the United States every 10 years. Accuracy matters: Congressional representation is based on the Census, as are significant amounts of funding; nearly \$2,000 per person per year in federal money comes into California based on census-derived data. To ensure that every household is on the Census Bureau's address list to be officially counted, the County funded an unprecedented \$1 million to launch a Local Update of Census Addresses (LUCA) effort.

Keeping Gilroy Strong. The shooting at the Gilroy Garlic Festival in July was a senseless tragedy that has rocked our community and shocked the world. Six-year-old Stephen Romero, 13-year-old Keyla Salazar and 25-year-old Trevor Irby were killed and 15 others were injured. My heart goes out to the families affected and as a community, we are deeply grateful to the thousands of local firefighters and law enforcement, EMS, physicians, nurses, medical personnel, emergency management staff, volunteers and community members who sprang into action during this crisis.

Balancing \$8.1 Billion. The needs of our County's 2 million residents far outpace revenues, which made this year's budget a herculean balancing act. The County's 2020 \$8.1 billion budget funds vital services that hold the fabric of our society together but are often invisible to residents. At the county level of government, we don't control the decisions made in Washington and Sacramento or what happens with the economy. Much of the County's budget is comprised of "pass through" State and Federal funds that pay for mandated services, which is why we are constantly adjusting to change and challenges in these uncertain times.

Improving Nail Salon Worker Health. Supervisor Cindy Chavez and I launched the Healthy Nail Salon Program, a free and voluntary program for the 850 nail salons in Santa Clara County that employ more than 5,000 nail technicians. In a joint effort with the California Healthy Nail Salon Collaborative, Santa Clara County implemented the Healthy Nail Salon Recognition Program to protect the health of nail salon workers and customers. A recognized Healthy Nail Salon offers safer products, safer practices, and proper ventilation to reduce exposure to more toxic products.

Combatting Wage Theft. The pervasive problem of wage theft disproportionately affects immigrants and low-wage workers. The County's new Office of Labor Standards Enforcement and the Department of Environmental Health launched a Food Permit Enforcement Program that will enable the County to suspend food permits from businesses who have not paid their judgments. This new effort helps protect workers and gives an advantage to the majority of businesses who do follow the rules.

I look forward to facing challenges in 2020 head on with my colleagues on the Santa Clara County Board of Supervisors and working with all of you to create a better community. I wish you all a happy and healthy New Year!
