#### **VEP's February Meeting Summary**

Here are the highlights, for those who missed the February VEP Community Meeting. We had some great speakers!

First of all, it was great to see our former VEP President, Marilyn Rodgers, in attendance. She gave a quick background on the Measure Q Expenditure Oversight Committee, which currently has an opening for any resident interested. Ms. Rodgers shared how this is an excellent way to be involved by overseeing the measures expenditures, reviewing audits and reports. The City's Measure Q oversight committee reviews city staff decisions around the Measure's finances and budgets. She also provided flyers for anyone interested. What a great way to ensure Measure Q conforms to the Expenditure Plan!

Next, our guest speaker Ky Le, Director of the Santa Clara County Office of Supportive Housing, presented a slideshow of various statistics and a very detailed account of the County's history and current relation with homelessness. Included were statistics on homelessness expansion and population growth over the years. He also gave the current status of projects completed and proposed plans for the future. This is aside from building a way to work in unison on with entities such as the State, City, VTA, Railroad and more. It was interesting to have a visual on the growth and expansion as it relates to the whole Silicon Valley. Of course, many factors contribute to homelessness, but the County's focus is in providing housing. Housing is key to personal wellness and dignity. It provides a place to sleep, have meals, receive mail, have peace and a retreat, for family and basic necessities. Several housing units have just opened in the Cupertino and North San Jose areas. Mr. Le said the County is open to all innovative ideas and looks to think out of the box.

Neighbors in attendance suggested looking at existing successful city programs, partnering with existing homeowners with extra rooms or ADU's to rent, and using open spaces or VTA parking lots for safe parking beyond the limited 10pm to 7am times.

Mr. Le acknowledged that the county needs to refine the ability to work in unison with and in a timely manner with other agencies for abatement such as the city, state, and transportation department. He also stated that affordable housing and higher paying wages are needed to support working class families in this area.

Next, we were introduced to Enrique Navarro from Councilmember Khamis' office, who announced that the Great American Litter Pick Up is April 25th (VEP is hosting a Spring neighborhood cleanup event in conjunction with GALPU). He also provided flyers for emergency preparedness (gather 15 or more nei-



Mr. Navarro suggested to email him, in order to obtain a contact for a traffic study through a "Traffic Tool Kit." He also provided a link where VEP can apply for a "Traffic Trailer," with the flashing 25MPH signage. Following the meeting, VEP immediately emailed Enrique and applied for both!

When will our streets be paved? Mr. Navarro stated it is an 8 year plan. He then followed up and provided a link that shows the first phase locations thru 2022. Good news first: Vista Park gets paved in 2020. Now the bad news: Carson & Parkview are not on this phase until 2022. The link will be posted on our VEP Facebook Group Page and it will be updated as projects are completed.

San Jose is in desperate need of more SJPD presence! Yes, 46 cadets have just graduated and will join our more seasoned officers. As their presence grows, more cadets are in training.

To end the evening, VEP President Greg West gave a status on VEPCA's membership drive, saying that membership is growing as a result of the drive. #### VEPCA's 2020 Community Service Awards



The VEP Community Association has a proud tradition of over 50 years of community service. In order to encourage the continuation of community service in the next generation, VEP annually chooses up to three graduating and deserving high school seniors to receive a monetary award to be used for post-secondary education (college, junior college, technical school, or trade school).

VEP asks the Gunderson High School and Andrew Hill High School administrations to nominate at least 2 graduating seniors per school (with no upper limit). At-large nominees are solicited through the VEP News (consider this article a solicitation). A VEP committee chooses one deserving and graduating senior each from Andrew Hill High School and Gunderson High School, regardless of where they live, and one deserving "at large" graduating senior who is a resident of the VEP neighborhood, regardless of the high school from which they graduate (other than Andrew Hill and Gunderson).

The winners will receive an award of \$1000 each, to be used for post-secondary education, based on their community service during high school regardless of their GPA. At-large award applications can be obtained by emailing the CSA committee chair at VEPCSA@gmail.com. The deadline for submission is April 17, 2020.

For this year's VEP Community Service Award, we are looking for volunteers to screen applications from eligible high school students. Again, this year, we have budgeted \$3000 for the awards, \$1000 each to a graduating, college bound senior from Andrew Hill, Gunderson, and from a VEP family for the "At Large" category. #### VEPCA Earns "Beautify San Jose" 2020 Grant: Improvement Project(s) Coming Soon!

The Department of Parks, Recreation and Neighborhood Services has continuously strived to create cleaner, safer and more vibrant neighborhoods using grants provided through the "Beautify San Jose Program." The mission of the BSJ Program is to support residents' efforts at reclaiming public space and empowering neighborhoods by aesthetically demonstrating pride.

VEP began the application process and applied in August of 2019. Attending meetings, meeting with DOT for approval while submitting and resubmitting various forms. #### Homelessness: If it's a crisis, lets act like it!

Despite my five-year effort to educate the public and lobby the County Board of Supervisors to implement Laura's law, with the support of my colleagues on the San José City Council, County leaders failed to move this law forward on January 28th. Laura's Law is a temporary, court-supervised, involuntary conservatorship law that would help some of the most vulnerable mentally ill people on our streets. While it will help a small number of the overall population of unhoused people, that handful are the most severely mentally ill, have had several interactions with law enforcement, and have the biggest effect on our community's quality of life. Laura's Law has been implemented in neighboring counties and is producing positive outcomes for both the homeless and for taxpayers, and Santa Clara County is missing an opportunity to help those who are unable to get help for themselves.

Despite this disappointment, it was satisfying to see that, after many years without significant, focused action, the County made some progress, such as approving the O'Connor and St. Louise hospitals as clinical service sites for homeless individuals that need medical treatment, and enhancement of mental health services at the Santa Clara Valley Medical Center. County-wide, voters approved Measure A, a \$950 million affordable housing tax, to fund 120 new housing developments in Santa Clara County, including 4,800 units for extremely low-income individuals and families at risk of homelessness.

Concern remains, however, that the County is not looking at quicker, more easily implemented, and less costly ways to house the unhoused. One strategy that San José has utilized is to refurbish older buildings, like the Plaza hotel, into transitional housing. Refurbishing existing spaces is quicker and cheaper than planning, designing, and building new transitional housing. The County previously passed up \$20 million in foundation funds to put with \$50 million in taxpayer funds to help convert the old City Hall Annex building into 150 units of homeless housing and they're now looking to spend twice the money for nearly half the number of beds. I encourage them not to make that mistake again, when it comes to the existing jail structure. Instead of demolishing the building, they should seriously consider remodeling it into up to 674 beds for the unhoused. Building 674 beds of new transitional housing elsewhere would cost upwards of \$404 million.

Additionally, the county ought to consider housing uses for the underutilized fairgrounds that have seen three revitalization efforts dating back to 1998 fizzle out (a fourth plan, released back in October, would see it become a "grand public space," but I'm not holding my breath). The county is encouraged to consider buying existing buildings, even new ones, to address the housing crisis more quickly.

Our residents, and our unhoused, deserve a more urgent response to the crisis of homelessness. I call on the County to revisit Laura's Law and to find ways to get people into transitional housing faster, and at a lower cost to taxpayers.

#### Recycling the Once-Unrecyclable: My push for a "Dirty Plastics" Recycling Facility

Recently, San José took a large step toward environmental sustainability when my colleagues on the City Council voted to include my proposal for attracting a Polypropylene Plastic Purification & Recycling Plant (PRP) to San José on the list of approved City priorities for the coming six months. I am especially grateful to my colleagues Dev Davis and Pam Foley for cosponsoring the memo to promote this endeavor. The only plant of its kind is presently being built in Ohio and it's our goal to replicate this facility, which would be the first of its kind on the West Coast.

This new plant, if built in San José, will be a game changer in the way we process and dispose of plastics. Its cutting-edge technology has the potential to be a positive disruption in current plastics waste stream. Currently, only 1% of Polypropylene plastic waste – such as chip bags, pump dispensers, utensils, condiment bottle caps, and the like - can be recycled, since such plastics are contaminated with oil, food residue, dyes, gel, and other currentlynon-convertible particles. What does get recycled is degraded into a dark, odorous substance suitable only for industrial uses like car parts and public benches.

Now, however, Proctor & Gamble has patented a new plastics purification technology that will enable us to recycle onceunrecyclable dirty plastics. Using a special chemical cleaning process, contaminants can now be removed from Polypropylene, converting it back into near-virgin-quality plastic suitable for reuse. The waste cycle is then transformed: dirty plastics can now be recycled into the same product over and over instead of piling up in our landfills.

The projected reduction in plastic waste is remarkable. The under-construction facility in Ohio, when in operation, will process and filter 119 million pounds of dirty plastic into 105 million pounds of near-virgin-quality plastic in its first year. That is an 88% reduction in plastic waste – enough pounds to equal the weight of a large ocean-going cargo ship! Furthermore, by reducing our dependence on virgin plastic production, we reduce our dependence on the oil and natural gas used in the creation of the plastic, making for cleaner air and oceans.

The need for this technology, on a global scale, has increased exponentially in the past two years as China, India, and Southeast Asian countries have banned importation of all but the cleanest plastic waste. We cannot and should not export an enormous volume of waste overseas, especially if we burn fossil fuels doing so and can't guarantee it will be disposed of properly. In the meantime, plastic waste that we once expected would be exported is instead accumulating in warehouses and landfills. In contrast, the Ohio facility has already pre-sold 20 years' worth of processing capacity to Nestlé, so the demand exists and we have the potential to dramatically increase the scope of Polypropylene recycling to help offset our increasingly problematic plastic waste situation.

According to the San José Department of Environmental Services, 10% of the City's waste stream is plastics and we discard an estimated 1,000 tons of it, yearly. That is equivalent to the weight of eight blue whales! San José has always been a leader in environmental sustainability and we must continue to lead. Our local waste and recycling companies agree and stand ready to support this enterprise. California Waste Solutions, Zanker Recycling, GreenWaste Recovery, and Republic Services joined me for the press conference on Tuesday and shared their commitment to the application of innovative technological solutions to our pressing environmental challenges.

The need is here, the solution is here, the time to act is now!

#### March 2020 County Update

**Census Day is April 1, 2020** and you may see volunteers in your neighborhood asking you to participate in the survey and be counted as a resident! The data – which is kept private – will then be used to calculate how much of the more than \$675 billion in annual federal funding will be earmarked for California services. There are four ways residents can respond to the survey: online, paper, telephone and in-person enumerator visit. You will receive a mail notification in mid-March from the US Census Bureau to complete the census online. I urge each of you to make every effort to be counted! Census data also assists in the drawing of voting precincts, congressional and state legislative districts, and school districts. If there is an undercount in California, the state could lose a seat in Congress and receive less federal funding for things like housing schools, and healthcare.

Anderson Reservoir update. When there is a looming hazard in our community – it must be addressed. After reading about the Federal Government's recent directive to the Santa Clara Valley Water District to drain Anderson Reservoir, I reached out directly to Water District leadership. I made sure that they understood my constituent's concerns about dam failure, water supply and environmental impacts. The Water District stated that they are working on a plan to expedite rebuilding the dam, while maintaining water supply and minimizing environmental impacts. The plan includes advocating for the passage of AB 3005, which is a bill from Assemblyman Robert Rivas to help expedite environmental review, permitting, and public contracting relating to Anderson Reservoir. I will continue to monitor the dam situation and will look for opportunities to advocate for rebuilding Anderson Dam and protecting the community.

**Coronavirus update.** We all want to protect ourselves and our loved ones against illness, including the coronavirus (COVID-19). It is disturbing to hear that discrimination is happening against people of Asian descent amid virus fears. Although the virus started in mainland China, there is no racial, ethnic or cultural basis for COVID-19. Because Santa Clara County is one of the largest Counties in the U.S., it is not surprising that several cases of COVID-19 has been reported here. Some very good news is that eight public health labs in California now have the ability to test for coronavirus - and Santa Clara County is one of them! Previously, tests could only be analyzed in a center in Atlanta, creating a time lag that had caused deep concerns. Now, doctors receive results in hours, rather than days, so any confirmed cases can be addressed much sooner which greatly reduces the chances of infecting others.

The U.S. Centers for Disease Control and Prevention (CDC) recommends everyday common-sense actions to help prevent the spread of respiratory diseases, including:


- Avoid close contact with people who are sick.
- Avoid touching your eyes, nose, and mouth.
- Stay home when you are sick.
- Cover your cough or sneeze with a tissue, then throw the tissue in the trash.
- Clean and disinfect frequently touched objects and surfaces using a regular household cleaning spray or wipe.
- CDC does not recommend that people who are well wear a facemask to protect themselves from respiratory diseases, including COVID-19.
- Face-masks should be used by people who show symptoms of COVID-19 to help prevent the spread of the disease to others. The use of facemasks is also crucial for health workers and people who are taking care of someone in close settings (at home or in a health care facility).

- Wash your hands often with soap and water for at least 20 seconds, especially after going to the bathroom; before eating; and after blowing your nose, coughing, or sneezing.
- If soap and water are not readily available, use an alcoholbased hand sanitizer with at least 60% alcohol. Always wash hands with soap and water.

Sadly, misinformation about this respiratory virus is rampant. Stay informed by getting your information from reliable sources. The County of Santa Clara Public Health Department is working closely with the U.S. Centers for Disease Control and Prevention, the State of California Department of Public Health, and other partners as the COVID-19 situation continues to change. #### ❀ Easter is Coming: Eggs Made Easy! ❀

I really, really love eggs and the Easter season has always given me the perfect excuse to make tons of those tiny, delicious, protein-packed wonders! They make such great snacks, are a great addition to salads, and who can say no to a delicious egg-salad sandwich? I sure can't!

But if, like me, you have struggled over the years to find an easier way to get the perfect hard-boiled egg that will peel easily and completely every time, let me share my favorite method!

I originally found this several years ago via Pintrest, but I have provided the direct link for you, below. Enjoy the ease!

#### How to Make "Easy Peel" Hard-Boiled Eggs From Getty Stewart: April 18, 2014

- First, choose eggs that are at least 7-10 days old – the fresher the egg, the harder to peel. Fresh eggs are perfect for poaching or frying sunny side up.

- Place eggs in a single layer in a pot.

- Cover with water so there's about 1/2 to 1 inch of water above the eggs. (While some people recommend adding salt or baking soda to the water, I've never found this to make a difference.)

- Bring to a full rolling boil. Once boiling, turn off the heat.

- Put a lid on the pot and let rest for 14 minutes (the perfect time for solid but not over cooked yolks of large eggs). Set a timer!

- Immediately after the 14 minutes are up, run cold water over eggs and let sit in an ice/snow bath for 2-3 minutes.

- After the eggs have cooled in ice water for a minute, gently crack the shell of each egg. Just enough to let a little water seep in.

- Put the eggs back in the ice water for another 1 to 3 minutes so that the water can penetrate in between the shell and egg white.

- Take out an egg and gently crack the shell all around it – you don't want to crack it so hard that the shell tears into the egg white.

- Gently but firmly roll the egg on a counter using the palm of your hand. Don't press super hard – you don't want to squish the egg, you just want to make a thousand tiny cracks all around the egg. You should begin to feel the shell separating from the egg white. I find this step really, really helps. Don't skip it!

- Peel the egg starting at the wide end where the air sac is. Use the thin membrane to peel back the tiny pieces of shell.

- If more help is needed, peel the egg under running water so that the water runs between the shell membrane and the egg white.



It is not elaborate, but it is informative, contains some beautiful flowers, and wonderful views of the intricacies of the architecture of the building. It had been a long time since we had been on a tour of the WMH and we plan to go back, because we were told that there are parts of the house not previously open to tours are now open to see. The staff members were amazingly friendly and helpful. The variety of Winchester items on display in the Product Museum was a little surprising. In addition to guns and munitions the Winchester Company made kitchen cutlery, axes and other useful items, like roller skates and ice skates.

Seasonally there will be more colorful flowers in bloom. The plants that are there are very well groomed and it was pleasurable to stroll around and look at the intricacies of the building and the garden. For a fee you can try to throw an axe aiming at a Bull's Eye. There are some very skilled axe-throwers.

Plan a short visit if you will be in the area or go for a longer time and take one of their tours.
