Candidate Forum Ground Rules

- The VEP president will moderate the forum.
- We will start the ZOOM meeting at 7:30 PM sharp.
- Each candidate will have 10 minutes at the beginning of the meeting to introduce themselves and 5 minutes at the end to wrap up. A coin was flipped to determine the speaking order.
- The forum is an opportunity for VEP neighbors to get to know the candidates. Questions will come from VEP members and neighbors, exclusively. The VEP Board will not prepare questions ahead of time for candidates. We expect that candidates are familiar with issues and will be ready to address them.
- The moderator will call upon questioners. The questioners will have a 1 minute time limit to ask one question. We will discourage multi-part questions.
 We expect that most questions will take 30 seconds or less to ask their question.
- If the question is a general question asked of both candidates, candidates will answer in a alternating order. If a question is asked of a specific candidate, that candidate will have the first opportunity to answer. The other candidate will also be able to answer the question. Each candidate will be limited to 90 seconds to answer. The moderator will give a verbal indication that 15 seconds remains for the candidate's answer and that time is up. If the question is a "yes" or "no" question, candidates are expected to answer with a "yes" or "no".



VEP solicited statements from both candidates for State Senate District 15. The following is the response that we received.

Ann Ravel for State Senate

President Obama endorsed me because I'll give government back to the people so it works for all of us.

I'm the daughter of a Latina immigrant and am a Willow Glen High School graduate. I picked apricots in Almaden Valley and worked in fruit canneries in San Jose to fund my college education.

I worked with President Obama to tackle the Great Recession and defend Americans at risk of losing their homes. I took on Big Oil after the spill in the Gulf of Mexico and stood up to drug companies breaking the law and taking advantage of vulnerable patients. When Governor Brown appointed me to make California government accountable and ethical, I challenged special interests trying to buy elections – including the Koch brothers' dark money network - and won.

As Santa Clara County's top public interest lawyer, I protected vulnerable seniors from financial abuse - recovering millions for them. I took on PG&E, Big Tobacco, and lead paint companies for poisoning children - and won.

The Mercury News called me "the best pick by far for state senate," praising me as "a smart, independent leader with an unmatched fighting spirit for what's right." Our current crisis demands independent leadership to address healthcare disparities, income inequality, joblessness, and small businesses struggling and closing.

I'm no career politician - I spent my life in public service fighting for consumers, the rights of women and minorities, environmental and civil justice.

As a champion for the rights of women in the workplace, I argued the most important Supreme Court case on the topic. In the State Senate, I'll fight for equal pay, paid family leave and childcare. I will be a tireless advocate for a woman's right to choose, and will ensure our state is standing up to violence against women and that law enforcement is prepared to address, investigate and adequately prosecute violent crimes against women.

I am the only candidate for State Senate focused on the issue of mental health and substance abuse, which has reached crisis levels during the pandemic. In the State Senate, I will fight to expand access to affordable, high-quality mental health and substance abuse services.

President Obama said I'm "thoughtful, empathetic and highly qualified."

Moms Demand Action awarded me their "Gun Sense Candidate Distinction" and Planned Parenthood gave me their highest rating.

We became members before it opened, attended one of the grand opening events, went often and even established our favorite exhibits to see first on each visit. Our daughter, Leanna, always wanted to head to the Touch Pool where she could put her hand into the cool water and touch one of the many sea creatures that would float by or the ones that adhered themselves to part of the display. As she got older she knew the names of the different varieties and enjoyed asking questions and learning more.

Stephen and I had our favorites, too. We could stand and watch the Leafy Sea Dragons for the longest time. At first they were something totally new to us. We loved watching their delicate bodies, the way they moved, and how they seemed like someone's artistic creation. Our photographs did not do them justice. Knowing that they were native to Australia and New Zealand, explained why we might not have seen them exhibited someplace else. Since then we have seen them in many other aquariums.

September 2020 County Update

As of this week, nearly 1 in 5 households have NOT participated in the 2020 Census. This means that 140,000 of the 701,000 households in the County of Santa Clara have not responded so far. Are you the 1 in 5 in your neighborhood? If so, please complete your 10-minute questionnaire today. It is as easy as going to www.my2020census.gov or calling 844-330-2020. The data collected from the Census is used to allocate over \$800 billion in annual funding for vital services including money for schools, healthcare, housing, and roads. The September 30th, 2020 deadline is fast approaching!

On September 8th, the State of California moved Santa Clara County from the Purple Tier (Tier 1) to the Red Tier (Tier 2) on the State's new COVID-19 blueprint. Counties assigned to the Red Tier are still experiencing "substantial spread" of COVID-19. The

following businesses and activities are allowed to resume under the State's framework, as well as the County's Risk Reduction Order. Businesses and activities must be in compliance with all industry-specific mandatory directives set forth by the County and State, including having a Social Distancing Protocol on file and displayed.


- -Schools: K-12 schools can open after the County has been in the Red Tier for 14 days. All schools must follow mandatory guidance set by the County of Santa Clara and the State of California
- -Personal care services (hair, nail, massage, waxing, etc): allowed indoors with modifications
- -Museums, zoos, aquariums: allowed indoors at 25% capacity
- -Gyms and fitness centers: allowed to open indoors at 10% capacity
- -Shopping malls: allowed to open indoors at 50% capacity (previously open at 25% capacity) Indoor dining, indoor movie theaters and indoor gatherings remain prohibited. Outdoor gatherings up to 60 people are still allowed. To maintain our hard-fought progress, I urge businesses and activities to follow the public health directives so that we can maintain our community's progress in bringing down COVID-19 transmission. We must all continue our vigilance with social distancing protocols and mask wearing.

Many people have been asking "Why is the COVID-19 test positivity rate for our County important?" Testing leads to quick identification of cases, quick treatment for those people and immediate isolation to prevent spread. Early testing also helps to identify anyone who came into contact with infected people so they too can be quickly treated. It is crucial of course to help treat, isolate or hospitalize people who are infected. Testing also is important in the bigger public health picture on mitigation efforts, helping investigators characterize the prevalence, spread and contagiousness of the disease. The goal is to have a low positivity rate, widespread testing and ample testing of people at greatest risk. The positivity rate is also one of two factors used to calculate our County's Risk Level under the State's new reopening framework and lowering it could help us move into a less restrictive level.

With more than 50 testing sites open across the community, the County continues to help more people get tested for COVID-19. Sites are accessible and staff are available to assist. Call ahead before visiting a hospital, clinic, doctor's office or community testing site to notify them that you might have COVID-19 or if you are experiencing symptoms such as a fever, cough, shortness of breath, chills, body aches, or loss of sense of taste/smell.


Where Does All The Money Go?

While canvassing the neighborhoods of District 10 during my campaign for City Council, I started each conversation with the same question: Which local issues are most important to you and how well is City Hall addressing them?

Across the nearly 10,000 doors I knocked on, one of the most common reactions I heard was: Where does all the money go? I don't get it. I pay thousands of dollars each year in property taxes alone, and I really don't understand where it's going. My road hasn't been paved in fifteen years, the police don't have enough capacity to follow up on property crime, I see trash and weeds along the expressways and our local bus service is getting cut. Where does it all go?

Valley Water Board of Directors Votes to Place Updated Safe, Clean Water and Flood Protection Program Renewal Measure on November Ballot

On July 21, 2020, my fellow Valley Water Board Members and I voted unanimously to place a renewal measure of the Safe. Clean Water and Natural Flood Protection Program (Safe, Clean Water Program) in front of voters this Nov. 3 for their consideration. In November 2012, 74% of voters approved the Safe. Clean Water Program as a countywide special parcel tax to provide local funding for local projects that deliver safe, clean water, natural flood protection, and environmental stewardship to the communities we serve in Santa Clara County. While evaluating ways to improve the 2012 program, Valley Water gathered feedback from more than 21,000 community members. The six priorities for the renewed Safe, Clean Water Program outlined in the community-preferred program report include:

- Ensure a Safe, Reliable Water Supply
- Reduce Toxins, Hazards and Contaminants in our Waterways
- Protect Our Water Supply from Earthquakes and Natural Disasters-Restore Wildlife Habitat and Provide Open Space
- Provide Flood Protection to Homes, Businesses, Schools, and Highways
- Support Public Health and Public Safety for Our CommunityThe renewed program would fund upgrades to pipelines, dams, and water infrastructure to improve water supplies and prepare for the risk of flooding, droughts, earthquakes, natural disasters, and climate change.

The updated program will also reduce toxins, hazards, and contaminants in our rivers, lakes, and streams through pollution prevention and creek cleanup efforts. With this renewed program, updates made for water supply reliability, environmental stewardship, flood protection, and support of public health and safety include:

- Provides \$100 million in flood protection in City of San José to plan, design and construct flood improvements on Coyote Creek, Guadalupe River, and Upper Penitencia Creek, with additional funds for shoreline protection in North San José near Alviso.
- Provides \$54 million to the Anderson Dam Seismic Retrofit project that protects Santa Clara County in the event of a dam failure, makes us more resilient in the event of a natural disaster, enhances the valley's water supplies, and provides additional habitat benefits downstream.
- Provides \$38.7 million to continue the ongoing coordination with local cities and agencies to clean up large creek side encampments that contaminate

waterways. This cooperative effort includes working with local municipalities, social services, and nonprofit advocacy groups that will help provide housing alternatives to the unhoused population.

- Restores and maintains healthy fish populations by providing \$44 million for environmental stewardship projects, including identifying and helping to remove priority barriers to fish passage, and improving habitat with instream gravel, boulders, and large wood.
- Provides \$53.1 million in grants and partnerships for cities such as San José, agencies, organizations and individuals for water conservation, pollution prevention, creek cleanups and education, wildlife habitat restoration and wildlife corridors, flood-inducing blockage removal, and access to trails and open space.
