# PRESIDENT'S CORNER






We were all rattled by the news regarding the Vista Park resident whose home was filled with explosives and a meth lab on Potomac Ct. A big thank you to the SJPD who worked with over 40+ FBI agents and other agencies to apprehend the suspects and make our neighborhood safe again.

This can happen anywhere, but when it happens in our neighborhood, we are reminded that we should all remain vigilant. Every one of us is responsible for the safety and well being of our VEP neighborhood. It was a resident that reported suspicious activity that led to the investigation and subsequent arrests. I am so glad nothing more came of this and that everyone in our community is safe again.

We are excited to announce that we will once again be sponsoring a community garage sale and cleanup day in our neighborhood, in partnership with the City of San Jose and the Salvation Army. ### VTA - Capitol & Branham Station Access Study

- VTA Team Presenters: Roberto, Jennifer, Jeanine & Aiko (not to be confused with our Aiko Fadness)
- Aiko Cuenco reviewed VTA's Study Background on Transit Oriented Program
- Gave overview of VTA Station Access Study for pedestrians, vehicles & cyclists
- Updated Timeline: Currently in Phase 1 Community Outreach & Assessment of Improvements. Phase 2 projected for spring '23.
- Reviewed current challenges with VTA pedestrian, vehicle & cyclist access
- VTA will be staging station pop ups, community meetings & online survey, regarding user challenges
- Safety is a current issue, they are concerned with encroaching encampments

### District 2 Update - Helen Chapman

- Shared some background as Jimenez enters his 7th year with lots of experience (currently involved with Public Safety Program)
- Abatement Project, corner of Branham & Monterey, began in February 2023. (Editor's Note: The homeless encampments on the property were cleared. Perimeter fencing and bike lane barriers were installed the week of March 13th.)
- No status on Kingspark & Branham crossing light, but it is an approved project in the making
- Focus on re-opening Police Academy is ongoing, funding needs to be included in budget
- · Monterey Road Maintenance Project, from SJ to Morgan Hill, will target maintaining & installing traffic lights, cameras, railroad crossing maintenance and street & tree clean up
- Open Space Authority is now chaired by Helen Chapman
- Former Aloha Rink (Charities Housing Project) targeted to be complete late summer 2023, with resident occupancy commencing the fall of 2023
- VTA Safe Parking on Santa Teresa & Ignacio delayed but should complete in 2023

# Update on VTA Projects By Helen Chapman, for D2 Councilmember Jimenez

From the housing department: Staff is estimating the site preparation work for the VTA Safe Parking project will be complete in March, so they are preparing for a mid to late March opening the program for RV participants.

The safe parking CAC has been meeting 2 x month and reviewing/discussing operating plans and participant agreements. The CAC also reviews the outreach progress updates. Right now, there are 7 RV's from Hedding and Spring area that still want to participate in the RV safe parking. LifeMoves is doing weekly outreach to the list of sites we received from D2 and D10, which does include your neighborhood.

VTA/Branham Light Rail Station: Councilmember Jimenez inquired VTA about the status of this site and was told that there is a 9 month feasibility analysis with Charities Housing for the site. They're exploring the potential in building low income for-sale units. Further info can be found on the January 12th VTA board meeting under consent item 6.3.

6.3. ACTION ITEM - Authorize the General Manager to conduct predevelopment work with Charities Housing for a term of up to nine (9) months to formulate a proposal for Board consideration for development of a feasible 100% affordable, owner-occupied "forsale" housing project at the VTA Branham Light Rail Station park-and-ride lot, pursuant to the existing Cooperative Agreement between VTA and the County of Santa Clara (County) Office of Supportive Housing (OSH). If a feasible concept cannot be accomplished with Charities Housing during the term, authorize the General Manager or designee to then pursue a feasibility collaboration for a period of up to 9 months with Jamboree Housing Corporation for the same purpose.

# Groundbreaking Timeline: Emergency Interim Housing Community Site at Monterey Hwy. and Branham Lane

The City and its partner LifeMoves are ready to break ground on the much needed and highly anticipated Emergency Interim Housing Community at Monterey Rd. and Branham Ln. This project will create 204 units of interim housing for our community's most vulnerable residents. In addition to safe and stable housing, LifeMoves will provide residents with case management, crisis intervention, employment services, community development, and community integration.

The project is funded by a \$51.55 million grant from the State of California Project Homekey as well as additional funding from the City of San José and the Sobrato Family Foundation.

After many months of planning, we will be entering into the development phase of the project. LifeMoves is scheduled to take ownership of the site this week. The site will be cleared (weather permitting) on Friday, March 17, 2023. The site clearing includes abating the unhoused encampment that has occupied the site for some time. The residents of the encampment have received outreach and have been offered services through the Temporary Housing Assistance Program (THAP) from LifeMoves and the City's Homeless Response Team.

The site has been cleared and the perimeter will be fenced by General Contractor Devcon Construction, Inc. until construction is complete. (Editor's Note: Fencing was installed the week of March 13th.) Onsite security will be provided to monitor the area and prohibit trespassing. Neighbors should expect to see tree removal and other construction equipment on the site.
